World War III May Have Already Begun

riends, if the last five years here in Western society

✓ have left you with a sense of disconnectedness and confusion as regards the society you live in, a discussion of the recent work by David Hughes could be just the panacea you need.

Hughes, a British scholar and academic, is only the latest critical thinker to argue that Covid-19 was a psychological operation and not a health emergency. It was a way to usher in technocracy, a path to totalitarianism by a transnational elite. As a quick aside, can I suggest we start replacing the word "elite" with "elitist"? Calling these people elites feeds into their own overblown narcissism while calling them elitists is a far better descriptor.

Hughes has coined the term "Omniwar" to better describe the variety of attacks being waged against the people. He describes it this way. "World War III is waged using the novel methods of Omniwar-that is, war waged across every domain of life, but clandestinely and with plausible deniability where possible, so that

the public does not recognize it as such." This war is the few (global elitists) versus the many (the rest of us).

Omniwar is nothing like past wars-the effort now is focused on gaining control of every single individual through the use (misuse) of technology.

The Weaponization of Everything

In support of his thesis, Hughes presents fifteen easily identified areas that are being used to attack and subject (mainly Western) populations. In the interests of space, I have selected a handful for review. You may not agree with every example, but pondering Hughes's position and considering his argument is still worthwhile.

1. Weaponized Health Care – the fact that odious Covid-19 measures were rolled out in lockstep fashion

5. Information Warfare -We were first introduced to the dishonest phenomenon of "factchecking" during Covid. It is by now well established that most, if not all, Covid-era fact-checking was carried out by groups both directly and indirectly funded by the pharmaceutical industry. Remember, too, "Freedom of Speech but not Freedom of Reach," that juvenile mantra rolled out on Twitter / X. This was also a disguised tool for the suppression of inconvenient truths.

6. Law and Order - Hughes points to evidence of police brutality against Covid protesters but not other kinds of protesters. This leads to the appearance of a politicized policing policy. There is also a growing use of "lawfare"using the judicial system as a means to silence and persecute dissidents. Both examples will resonate with Canadians who remember the Freedom Convoy, many of whom are, even today,

around possible links to autism in children and infants. More recent microscopic analyses of Covid-19 vaccines and the documentation of a variety of unidentified substances within them have increased our suspicions. The now-famously blank Covid-19 vaccine package inserts and recent damning Pfizer Freedom of Information Act (FOIA) disclosures in the United States (US) demonstrate that pharmaceutical companies were aware early on of the terrible side effects. The Amazon bestselling book by author and former Presidential consultant Dr. Naomi Wolf, The Pfizer Papers (2024), corroborates that fact.

3. The Great Poisoning – Hughes notes the general trend towards the poisoning of necessities like food and water, particularly in Western countries. Recent court decisions in the US prove that the ingredient glyphosate found in the herbicide Roundup is poisonous to soil and especially wheat, and a recent California Court's strongly worded decision shows that the fluoridation of drinking water can damage cognitive neurodevelopment in children.

aware that our judicial system continues to be used to target Freedom Convoy participants, and other social/ political dissenters.

7. Subversion of Christianity – Christianity has been increasingly subverted for the last 100 years, claims Hughes. But the recent uptick has been dramatic. Evidence the opening ceremony of the Paris Olympics, which included a blatant mockery of Christ's Last Supper. Clearly, it has nothing to do with sports but was seemingly designed to attack, offend, disrespect and sow disunity. Covid rules, in particular, targeted churches and other places of worship, causing many to close their doors and alienating many Christians from their houses of worship - further dividing them and subverting their unity. Because of the abject failure of many churches to oppose

Tam writing to say I'm totally against the proposed wind energy projects. To destroy thousands of hectares of pristine, beautiful environments that hold all kinds of wildlife and birds is truly insane. To destroy

barrens, bogs, and watersheds is insane. To do this for very shortterm projects is insane. To do this for the interests of foreign countries is insane. To do this to increase the load on our already limited power grid is insane. To do this and affect the mental health of thousands of Newfoundlanders is insane and criminal. To do this and destroy communities is criminal. To destroy property value is criminal.

It is the government's duty and mandate to protect the people of this province and to ensure democracy in every way. It is the government's duty to protect the physical and mental health of all the people of our province—it is their duty to protect the safety of the people they serve.

These projects were devised while under a wind energy moratorium; they were done in extreme secrecy, quickly, illegally, and with

no public or stakeholder input. They were done even when the magnitude, destruction and dangers were not fully known either by the government or the public.

The appropriation of 3.8 million hectares, rezoned and stolen from the people of this province, is criminal and will come to light in court one day. The huge amount of land taken and rezoned for wind energy is history in the making. Nowhere in Canada has ever such an enormous amount of land been taken for wind energy. It will be a precedent-setting court case. This 3.8 mil-

- The Supreme Court of New York has ordered all New York City employees who were fired for not being vaccinated to be reinstated with back pay. The court found that *"being vaccinated does not prevent an individual from contracting or transmitting COVID-19."* New York City fired roughly 1,700 employees for being unvaccinated earlier this year after it adopted a vaccine mandate under former Mayor Bill de Blasio. Many of those fired were police officers and firefighters.
- The establishment's *"Zero Meat by 2030"* agenda is flopping hard. After receiving \$8.5 million from the Liberal government, Aspire Food Group, **a cricket flour producer based in London, Ontario, has laid off 100 of its 150 employees** and temporarily reduced production at its cricket farming facility.

- New CDC report reveals COVID-19 vaccination rates among healthcare workers have plummeted to an all-time low, with staff citing safety and efficacy concerns. The report, published on October 31, 2024, captured an all-time low in COVID-19 vaccine uptake among healthcare workers across the United States during the 2023–2024 respiratory virus season. The data showed that only 15.3% of healthcare workers in acute care hospitals and 10.5% of those in nursing homes received the 2023–2024 COVID-19 vaccine.
- For the second time, **Fanshawe College has been** ordered to compensate an employee placed on unpaid leave under its COVID-19 vaccine mandate. In the latest case, Arbitrator Norman Jesin ruled in favour of Michael Kennelly, a professor at Fanshawe's London, Ontario, Campus, who challenged the college's refusal to grant him a religious exemption from its vaccine policy.
- Alberta court certifies class action lawsuit against

shape, or form. These are get-rich-quick schemes that a dictatorship government promotes. - Robert Kennedy Jr. has announced that the Trump administration will advise all US water systems to remove fluoride from tap water on day one. "On January 20, the Trump White House will advise all U.S. water systems to remove fluoride from public water," Kennedy wrote. "Fluoride is an industrial waste associated with arthritis, bone fractures, bone cancer, IQ loss, neurodevelopmental disorders, and thyroid disease... Fluoridation is a dated practice that infringes on medical ethics by ignoring informed consent and lacks the rigorous scientific backing that its promoters claim makes it 'safe and effective'".
- A new bill introduced in the US House of Representatives, states that universities and colleges that mandated the COVID-19 vaccine would be liable for medical expenses for students who experienced adverse events from the shot. *The University Forced Vaccination Student Injury Mitigation Act of 2024* would require higher education institutions to cover medical costs for students who were—or still are—required to get a COVID-19 shot for class attendance and who experienced an injury. The bill stipulates

being found at the lowest levels measured in recent history, on average, in breakfast cereal and other oat-based products, according to tests by the American nonprofit Environmental Working Group. Glyphosate exposure has been linked to a variety of adverse health effects. To date, Bayer Monsanto has paid out over 12 billion USD to plaintiffs who have developed a rare form of lymphoma as a result of glyphosate exposure.

- A \$170-million class-action lawsuit has been filed against the Province of Ontario and its Chief Medical Officer of Health, Dr. Kieran Moore, alleging negligence, misfeasance in public office, tortious inducement to breach contract, and violations of privacy rights related to the implementation of CO-VID-19 vaccine mandates for healthcare workers.
- Charges have been dropped against Clayton McAllister, an ice road trucker whose powerful image of him lying peacefully in front of a police line during the Ottawa Freedom Convoy became a worldwide symbol of non-violent protest. McAllister was facing charges of mischief, resisting arrest, and disturbing the peace.

the provincial government for COVID-19 health orders that impacted businesses during the pandemic, allowing it to proceed. The lawsuit, led by plaintiffs Rebecca Ingram and Christopher Scott, challenges the authority of Alberta's government to impose business restrictions through Chief Medical Officer of Health orders, which the plaintiffs argue were unauthorized and illegally imposed. The lawsuit seeks compensation on behalf of a broad group of Alberta business owners, claiming that the health orders, issued ostensibly under public health directives, resulted in devastating financial losses.

• Alberta's ruling United Conservative Party approved a resolution stating, in part: " CO_2 is a nutrient foundational for all life on Earth...The earth needs more CO_2 to support life and to increase plant yields, both of which contribute to the Health and Prosperity of all Albertans." The resolution recommended that the Government of Alberta should: Abandon Net Zero targets, remove the designation of CO_2 as a pollutant, and recognize that CO_2 is a foundational nutrient for all life on Earth. colleges must cover the medical costs or risk losing all federal funding from the US Department of Education.

- Alberta's United Conservative Party government has approved amendments to the province's Bill of Rights that add protections for medical choice, including the right to refuse vaccination, as well as strengthen gun ownership rights, property rights, and freedom of expression. Regarding vaccine choice, it said Albertans will not be "coerced" into receiving medical treatment without consent unless they are "likely to cause substantial harm to themselves or to others."
- Tucker Carlson apologized recently for making fun of people who believe vaccines cause autism. Carlson told Jimmy Dore that he used to make fun of people who believe vaccines cause autism. He now describes his behaviour as *"unthinking, stupid, and reactionary." "I apologize for that,"* Carlson said. Carlson also admitted *"I've never spent four minutes thinking about vaccines."*

They're Trying to Silence Us: The G20's War on Climate Skepticism

In yet another chilling example of Orwellian overreach, the G20 Summit in Brazil has unveiled a new international effort to stifle dissent under the banner of *"fighting disinformation."* This latest scheme, dubbed the *Global Initiative for Information Integrity on Climate Change*, is spearheaded by the United Nations and UNESCO. With a financial war chest provided by nations like the United Kingdom, France, and Sweden, this initiative isn't about *"truth"* or *"science"*—it's about control.

"Bringing together countries, international organizations, and stakeholders worldwide, it aims to pro-

mote and defend information integrity on climate change, address disinformation, and enhance climate change awareness and action. It includes a global fund which will finance research into disinformation on climate change and initiatives to promote information integrity."¹ - unesco.org

Let's call this what it is: a blatant attempt to silence anyone questioning the socalled climate crisis narrative. Under the guise of combating *"misinformation,"* these global bureaucracies aim to crush free thought and erase critical voices from the public square. This isn't just an attack on skeptics—it's an assault on open discourse itself.

The Initiative: A Wolf in Green Clothing

According to their public statements, the Initiative

seeks to fund nonprofits for *"research"* and *"public awareness campaigns."* They're also creating what they call an *"international research network"* to identify and suppress so-called disinformation. In other words, they're building an apparatus to label opposing viewpoints as dangerous lies and to justify censoring them into oblivion.

UN Secretary-General António Guterres, with his characteristic paternalism, declared disinformation a threat to climate action and even democracy itself. The not-so-subtle subtext? If you dare question their dogma, you're the problem. *"We must also take on climate disinformation," Guterres said. "Our climate is at a breaking point."*

The History: Silencing Skeptics Since Day One

This isn't the first time climate skeptics have been targeted. As far back as 2010, Google began manipulating search results to demote skeptical voices. A French study highlighted how skeptics dominated online search rankings at the time,² leading to a concerted effort to bury their views beneath mountains of alarmist propaganda.

Blogs like *Pensée Unique* and works by Claude Allègre drew enough attention to provoke the ire of the establishment.

Now, thanks to collusion between Big Tech, governments, and nonprofits, the *"censorship-industrial-complex"* has become a powerful and insidious force. Groups like the Cybersecurity and Infrastructure Security Agency (CISA) in the United States, along with private entities like NewsGuard,³ routinely conspire to flag, suppress, and delegitimize dissenting voices.

We've seen this play out before. *The Twitter Files*⁴ laid bare the extent of this collusion, revealing how social media platforms partnered with government agencies to

Entire Field of Alzheimer's Research Exposed as FRAUDULENT

Longstanding NIH Neurology Director Eliezer Masliah Engaged in **Data Manipulation to Benefit Drug Companies**

third-party investigation by Science has uncovered significant levels of fraud in the Alzheimer's research community. The investigation has confirmed research misconduct by Eliezer Masliah, a longstanding employee of the National Institutes of Health (NIH) and a leading figure in neurological studies. The allegations involve the falsification of scientific data, spe-

cifically the reuse and relabeling of images in his published papers to artificially boost the efficacy of Alzheimer's drugs.

Masliah, appointed as the director of the National Institute on Aging's (NIA) Division of Neuroscience in 2016, has been a pivotal player in the field, overseeing a budget of \$2.6 billion. Celebrated for his contributions to the understanding of Alzheimer's and Parkinson's diseases, Masliah has authored nearly 800 research papers, making him one of the most cited scientists in his discipline. This research has led to the speedy approval of new Alzheimer's drugs, but now these drugs are being called into question.

Academic investigation detects intentional data manipulation in Masliah's research over 25 years

The investigation into Masliah's work has called into question numerous Alzheimer's studies from his laboratory at the NIA and at the University of California San Diego (UCSD). This work contained manipulated images, including Western blots and brain tissue micrographs. An independent forensic analysis presented a 300-page dossier, revealing a pattern of questionable data across 132 published papers spanning from 1997 to 2023.

The scrutiny of Masliah's work began in 2023 when forensic image analysts began flagging discrepancies in several of Masliah's papers on PubPeer, an online platform for discussing research publications and allegations of misconduct. The initial concerns prompted a deeper examination by a team of experts, including Columbia University neurobiologist Matthew Schrag, neurobiologist Mu Yang, and independent forensic analyst Kevin Patrick. Their previous investigation into another researcher led to significant findings, including the suspension of a clinical trial due to data manipulation.

In their analysis of Masliah's work, Schrag, Yang, and Patrick uncovered numerous instances of duplicated and altered images across multiple studies. Yang noted that certain Western blots appeared to be "seamlessly blend*ed*," suggesting a deliberate effort to misrepresent data. She described her investigative process as akin to that of an art historian, identifying a "signature style" of manipulation that recurred in many of Masliah's papers. One particular study, published in 2015 in BMC Neuroscience, illustrated troubling image manipulation that exaggerated the drug's effectiveness. In this research, images of brain tissue from normal and mutant mice suggested that prasinezumab reduced tau damage, but further analysis revealed unnaturally similar images that raised doubts about their authenticity. As Yang and her team reviewed Masliah's publications, they identified hundreds of suspect images, leading them to halt their search due to the overwhelming evidence of misconduct. "I suspect similar problems would emerge from a close examination of the hundreds of other Masliah papers," Yang commented. The allegations raised serious concerns among neuroscientists. Samuel Gandy, a neurologist at the Mount Sinai Alzheimer's Disease Research Center, expressed his shock, stating, "Hundreds of images. There had to have been ongoing manipulation for years."

Drug companies and scientists who benefited from fraudulent Alzheimer's research now called into question

Following the dossier's release, the NIH stated that Masliah's misconduct was confirmed in two publications, leading to his removal from the NIA's neuroscience division director position. Details regarding his current employment status remain unclear, as NIH officials declined to elaborate on their next course of action.

founded the biopharma company Prothena. The drug's efficacy is now under scrutiny due to Masliah's questionable research.

Even with Alzheimer's research fraud uncovered, the FDA has declined to comment on the implications for the drug prasinezumab, which is currently undergoing a new phase 2 trial aimed at assessing its effectiveness in slowing the progression of Parkinson's-related movement difficulties. The phase 2 trial of prasinezumab is particularly



critical as drug makers Hoffmann-La Roche and Prothena look to announce preliminary results later this year. These companies are ignoring the latest findings of fraud and are expected to make decisions regarding a possible phase 3 trial by 2025 or 2026. The ongoing con-

cerns about Masliah's research not only challenge prasinezumab but also jeopardize the credibility of various other drug development efforts that rely on his earlier fraudulent research methods and data manipulations. One of those drugs, built on the fraud of Masliah's research, is Cerebrolysin, sold by Ever Pharma, Masliah's fraudulent research also impact will Neuropore Therapies, which cites Masliah's

The implications of these findings extend beyond Masliah's individual work. This fraud has also exposed the research of the late Edward Rockenstein, a former UC San Diego neuroscientist who co-authored 91 papers that now face scrutiny due to the dossier's findings. Similarly, Robert Rissman, who contributed to 16 papers cited in the dossier, is now at the University of South Carolina (USC), where the institution has announced a confidential review of his involvement with Masliah's work.

Masliah's research has influenced the development of experimental drugs, including prasinezumab, which was aimed at treating Parkinson's by targeting the alphasynuclein protein linked to the disease. However, recent clinical trials reported no significant benefits, raising further questions about the validity of the underlying research. Masliah played a pivotal role in the drug's conceptualization alongside the late Dale Schenk, who co-

The Blue Light Pandemic

The pandemic began on a screen and continues to play out on a screen. The only ones not playing are the children, as many children are too rapidly turning into adults.

Numerous studies conducted in the early years of the pandemic attempted to link early puberty with a virus.

What if the real reason was the bluelight virus in our software, affecting our body's hardware?¹

When I was a child, I couldn't wait to go play in the dirt, smash sticks against rocks, or just gaze end-lessly into the babbling brook.

There are three things that most of us can't stop watching: Fire, water, and people working.

Why? All living things are drawn to fields of energy.

This is why so many of us love to see a good Sunrise or Sunset—as the force of the Sun acts upon our primal craving to experience energy in its raw element.

Today, many of us are subconsciously drawn to a different type of screen, like the one you're using right now to read my words.

Now close your eyes, just for a second. What did you see? Darkness. Yet the rest of your body saw a different picture. Our skin is still perceiving and absorbing the blue light coming off the screen.

How does this happen?

It turns out our skin has eyes like a peacock, that are embedded in

our subcutaneous fat. Those "eyes" are a protein called melanopsin. Melanopsin is very sensitive to blue light and is contained in fat cells called white adipocytes. White adipose tissue (WAT) is activated by blue light and increases sympathetic nervous system (SNS) activity/ stress response.

Why is this important?

Melanopsin regulates the amount of melatonin our bodies can use, and melatonin drives hormonal production in the rest of our body. While we may think of melatonin as the sleep hormone, it is really so much more. Hormones tell our bodies when to eat, sleep, breathe, and reproduce. Melatonin alone synchronizes the biological functions of our pancreas, liver, kidney, adrenal glands, heart, digestive tract, lungs, and reproductive organs.

Believe it or not, we have at least 400 times more melatonin in the gastrointestinal (GI) tract than we do in our pineal gland! This is why all digestion begins in the skin and the eyes before it can precipitate to our GI. The female reproductive system has even more binding sites for melatonin.

How do melatonin levels affect fertility?

Mammals are geared to reproduce in the warmer months. Ever seen a deer have sex on a snowy beach? I didn't think so.

Pass that margarita, dear...and let me tell you why. Aside from the warmth that we and those horny friends of ours love, there is another reason we often miss while basking in our heat of solar passion. There is more light in our environment during spring and summer, and this light reduces the amount of melatonin we have. The melatonin that we've stored in the darker months is then absorbed and used by many of our reproductive organs. This is why melatonin levels are typically highest in the winter and lower in summer. Light gives life, and life takes time.

How does melatonin affect birth?

tonin, leading to poor sleep. However, what many don't know is that this master sleep hormone may also control the destiny of our children's reproductive future. In a 2022 study by the European Society for Pediatric Endocrinology, entitled *Excessive smartphone screen time linked to earlier puberty onset,* researchers from Gazi University and Ankara City Hospital in Turkey exposed 18 immature female rats to the same type of blue light

emitted by our screens. Researchers found that rats who were bathed in blue light for longer periods matured more quickly than the rest. Since melatonin is an anti-aging hormone, aging increases rapidly when this hormone is lowered.

Are our children rats? No. However, rats go through puberty at roughly the same rate of time as humans. The hormonal and ovulation (release of egg cells) changes that occur during pre-puberty and puberty in female rats are also comparable to humans.

How does blue light affect puberty?

Once puberty hits, melatonin levels for both boys and girls drop. While researches are still unclear as to the direct reason for this decrease, the pattern of high to low melatonin remains consistent throughout all children. Conclusive studies may never come. In the meantime, why would we want to lower a hormone that may prematurely trigger puberty in our children by exposing them to more blue light? Let's not let primetime TV steal the prime of our life.

Melatonin is also the reason why babies are typically born at night, as this hormone helps the uterus contract. Uterotonins, like oxytocin, are present in the amniotic fluid and regulate contraction.

What happens when we live indoors most of the year?

We enter a season-less world, where we pass through life living a stone-cold summer that freezes the blooms of our vitality, and steals the fruits of all humanity's labour. Our windows block most of the healing wavelengths of Sunlight, like infrared and UV, and they also keep in the artificial light from our screens, rendering us blue-light toxic.

Blue light destroys our body's ability to make critical pro-growth hormones like melatonin, testosterone, and estrogen, as hormonal production is switched to cortisol, which can potentially lead to chronic stress. The cascade of inflammation begins when blue light hits the melanopsin photoreceptors in our skin and eye, as retinol. Also known as Vitamin A, retinol has a very loose chemical bond with melanopsin. When this bond is broken, chaos ensues for our hormones.



Jury Awards \$12M to Michigan Woman Fired for Refusing Covid Shots

federal jury in Detroit awarded over USD \$12 million on November 8, 2024, to a former Blue Cross Blue Shield of Michigan (BCBSM) employee, Lisa Domski, following her claim of wrongful termination due to religious discrimination over the company's COVID-19 vaccine mandate.

Domski, who worked for the insurance provider for more than 30 years as an IT Process Specialist, argued that her dismissal in January 2022 violated her religious rights. The jury awarded her \$10 million in punitive damages, \$1.7 million for lost wages, and \$1 million in noneconomic damages. BCBSM, a leading health insurance company in Michigan, implemented a company-wide COVID-19 vaccine requirement in October 2021, mandating all employees to be fully vaccinated by January 4, 2022, unless they received an approved medical or religious exemption.

Domski, a practicing Catholic, submitted a religious exemption request, stating that her beliefs prevented her from accepting a vaccine associated with fetal cell research. Her request was denied after BCBSM concluded it did not qualify as a sincerely held religious belief, and she was subsequently terminated on January 5, 2022. During the trial in federal court, Domski's legal team argued that **her job was conducted 100% remotely** during the pandemic and approximately 75% remotely even before COVID-19, contending that her remote status minimized any risk to coworkers and made vaccination unnecessary for her position. Additionally, they argued that BCBSM's process for exemption requests involved intense scrutiny that pressured employees to comply with the mandate despite their personal beliefs.

BCBSM stood by its vaccine mandate, describing it as a lawful measure to protect public health and one that followed state and federal accommodation guidelines. Following the jury's decision, BCBSM released a statement expressing disappointment and indicating it may consider an appeal. *"Blue Cross respects the jury process; however, we are disappointed in the verdict. Blue Cross is reviewing its legal options and will determine its path forward in the coming days,"* the company stated.

Property Rights and Bylaw Enforcement

here is something horribly wrong with this country. If you want to know who is to blame, you need only look into a mirror.

Some Town Halls currently think they can pass any bylaw they want and attach a massive fine for non-compliance. Then, if you don't pay it, they put it on your property tax bill and then sell your home if you continue to

no choice but to agree to cease his illegal activity, or he refuse to pay. Buck explained to the enforcement officer that their by-laws only apply to their corporation as stated in their own bylaws. Buck also got North Huron's CAO to confirm their bylaws only apply to the lands described in the bylaws, which are the corporation's assets such as parks, roads, town hall, etc. Buck also clarified the reason he advocated for and got the Wingham police disbanded was that the council was using them to prop up their regime and that by-law enforcement was now the only remaining pillar of support they could use to illegally abuse and harass citizens/dissidents. The enforcement officers are standing down and refusing to violate Rights

at Buck & Jo's.

Requests for the job description of the bylaw enforcement officer have gone unfulfilled, most likely because one does not exist. North Huron Reeve/Mayor Paul Heffer was confronted at a meeting on October 10, 2024, about his claim that his corporation has authority over private property. Heffer refused to answer who told him he had this authority and admitted he was cowardly for failing to identify his co-conspirators.

North Huron Reeve/Mayor Paul Heffer was warned that he would be treated like any other burglar if he attempted to illegally trespass and seize private property. It should be noted at the 18 July 2022 North Huron council meeting, Jason Younan, Inspector-Detachment Commander for Huron County OPP, clearly advocated "Taking care of business" (lethal force) if you find an intruder in your home and you "believe" your life is under threat.

New Poll: 78% Of Canadians Support The Recent Immigration Cut

The Century Initiative, a lobby that wants to expand Canada's population to 100 million by 2100, condemned the cut, claiming that "Canada's reputation as a stable, welcoming environment for business and talent is now at risk".

'n a recent article in the Financial Post, I reported that support for Canadian immigration restriction had reached 72%, a statistical supermajority that includes all major political parties and every age group. In another recent column, I wondered whether this astonishingly high percentage was the ceiling of support or whether opposition to high immigration would continue to increase.

We now have the answer

In a survey commissioned by Bloomberg News and conducted by Nanos Research, 78% of respondents said they supported or somewhat supported the federal government's decision to slash permanent resident levels. You can read the full survey here. Here are some of the key results:

78% support the immigration cut

"As you may know, the federal government has recently reduced the target of new permanent residents it plans on accepting in 2025 and 2026, from 500,000 each year to 395,000 in 2025 and 380,000 in 2026, which is expected to result in a population decline of 0.2%. Do you support, somewhat support, somewhat oppose or oppose this reduction in permanent resident targets?"

Oppose: 5% Somewhat oppose: 12% Unsure: 5%

Majorities of men, women, and all age groups support the cut

Men: 79.8% Women: 77% 18-34: 75.7% 35-54:79.3% 55+: 79.4%

Majorities of all regions surveyed support the cut

Ontario: 81.8% Quebec: 78.8% Atlantic Canada: 77.1% Prairies: 74.9% BC: 73.1%

So, who exactly doesn't support the cut?

While 78% of Canadians support the immigration cut, it has come under considerable fire from the business lobby and special interest groups over the last couple of weeks. Here is a small sample of what they had to say about the decrease:

143 civil societies and charities signed a Migrant Rights Network open letter calling for the immigration cut to be reversed. The letter also called for a general amnesty to be extended to illegal immigrants on Canadian soil.

The Canadian Chamber of Commerce issued a statement saying that the immigration cut was "disappointing for businesses across the country". The statement went on to argue that reducing immigration would make life harder for employers: "Significantly decreasing our labour pool will impact thousands of these employers across Canada struggling to find the workforce they need to operate and grow".

Dan Kelly, president of the Canadian Federation of Independent Business (CFIB) told CBC News that employers are unhappy with the immigration reduction because of its impact on the labour pool: "There's a bunch of temporary foreign workers in Canada today, working for them, happy in their jobs, but whose visas are about to expire and they're going to be sent packing. This is such a waste of talent."

Australian Town Calls for Immediate Suspension of Vaccines

In a surprise move, the local government of West Australian mining town Port Hedland is calling for immediate suspension of the Moderna and Pfizer Covid vaccines pending an investigation into evidence of excessive levels of synthetic DNA in the shots.

At a special meeting on 11 October, Port Hedland councillors voted five to two in favour of notifying all of Australia's 537 local councils of the evidence of the DNA contamination in the vaccines and associated risks.

"We are gravely concerned about the potential health risks posed by synthetic DNA contamination, including the dangers of genomic integration, cancer, hereditary defects and immune system disruption," said the letter, a copy of which was sent to councillors around the country following the vote.

Letters were also sent to every health practitioner within the Port Hedland area, strongly urging them to share this information with patients contemplating receiving any Pfizer or Moderna Covid modified-RNA (mod-RNA) vaccines.

The Port Hedland Council joins federal independent MP Russell Broadbent in calling for the suspension of the vaccines until an urgent and thorough investigation has been carried out into the DNA contamination matter. Port Hedland Councillor Adrian McRae, who brought the motion, said that he hoped the vote *"will be the ripple that creates a bigger wave across the country, and perhaps the world"* on the issue of Covid vaccine safety.

The move comes after independent testing of Australian vials of Moderna and Pfizer Covid vaccines by Canadian virologist Dr David Speicher detected residual synthetic DNA at levels up to 145 above the regulatory limit. Independent studies in Canada, the US, and Germany had previously tested the mod-RNA vaccines and found excessive levels of DNA, which is a byproduct of the production process and is allowed in amounts of up to 10 nanograms per dose under international regulations.

In the Pfizer vaccine, there is a DNA sequence called the SV40 enhancer/promoter, which is known for its utility in gene therapies to drive DNA into the nucleus of cells. The SV40 enhancer/promoter (not the same as the SV40 virus) was discovered in the Pfizer vaccine in 2023 by genomics scientist Kevin McKernan and has since been acknowledged by regulators, including the Therapeutic Goods Administration (TGA) and Health Canada. Responding to these findings, Florida Surgeon General Dr Joseph A. Ladapo petitioned the Food and Drug Administration (FDA) to halt the Covid mod-RNA vaccine program in December last year.

However, both the FDA and the TGA deny that the vaccines contain high levels of DNA or that the synthetic DNA poses any safety risks, including the SV40 enhancer/promoter. In a statement released after the Port Hedland council vote, the TGA said that it was aware of *"misinformation"* in recent reporting of the contamination issue and that findings of high levels of residual DNA in the mod-RNA vaccines are *"not robust or reliable, and are creating confusion and concern regarding*"

the safety of vaccines."

But, the TGA did not provide any evidence to support its claims or refute the work of independent scientists who detected the contamination. At the same time, the TGA mischaracterized the scientists' work and omitted some key but inconvenient facts from its statement.

The TGA claimed that it has independently tested 27 batches of mod-RNA vaccines for residual DNA levels and found them to be compliant. However, no one can

verify this because the TGA **fully** redacted

Professor Dalgleish, who previously sat on the scientific board of mRNA technology company CureVac, said he had seen an upsurge in aggressive, fast-progressing cancers in his oncology practice amongst patients who had received Covid vaccine boosters, particularly colorectal and blood cancers. *"We need our health authorities to begin monitoring these trends, develop testing protocols for those exposed to synthetic DNA contamination, and prepare treatment pathways for the inevitable rise in vaccine-induced conditions,"* he said.

The motion to warn Australians of the DNA contamination in the mod-RNA shots was supported by Councillors Adrian McRae, Sven Arentz, Lorraine Butson, Camilo Blanco, and Deputy Mayor Ash Christensen. It was opposed by Mayor Peter Carter and Councillor Ambika Rebello. Blanco, who formerly served as Port Hedland Mayor, said he was inundated with calls from other local government areas after the Port Hedland Council motion was passed. *"I've been contacted by so many councils that are ready for this,"* he said. *"They can't just ignore this. We want genuine answers."*

The TGA misleadingly criticized the use of a testing method called fluorometry in some studies but ignored the evidence of excessive DNA using qPCR, which is the TGA's preferred method for testing residual DNA levels. The TGA also ignored a step taken by Dr Speicher (the use of an enzyme called Rnase A) to ensure the accuracy of the fluorometry reading. The TGA failed to address the implications of residual DNA being encapsulated in lipid nanoparticles (LNPs), which go to every major organ system in the body (according to Pfizer's biodistribution data) and enter the cells (according to the Office of the Gene Technology Regulator). And the regulator did not address the presence of the SV40 enhancer/promotor at all.

West Australian Premier Roger Cook slammed the Port Hedland council for passing the motion to alert Australians to the DNA contamination issue, telling the press that the council had gone *"off the rails"* and *"should stick to its knitting."* But Port Hedland residents who attended the special meeting implored the council to take action, as did internationally lauded Professor of Oncology Angus Dalgleish in a recorded address in sup-

Some Of The Most Absurd Things That Have Happened In Recent Weeks

- over a decade, the Canadian Union of Postal Workers (CUPW) brought attention to several key identity politics issues. Among them was a proposal to include "gender-affirming care" in their benefits plan, covering procedures like sex reassignment surgeries. The union also advocated for "precautionary cessation of work for pregnant and breastfeeding employees," favouring inclusive language over explicitly referring to women as "women."
- DoNoHarm reports that the US's top ten list of doctors providing "sex change treatments" made between \$1.7 and \$5.2 million USD last year.
- New study finds that Alzheimer's patients who took anti-Aß monoclonal antibodies not only did not experience any reduction in their symptoms, but also experienced up to a 4-fold increase in mortality. The

study (Dwivedi et al.) comes in the wake of a recently retracted landmark Alzheimer's paper published in Nature in 2006 (Lesné et al.) that suggested an amyloid beta (A β) could cause Alzheimer's Disease. An investigation by Science over the summer revealed evidence that the paper, along with 132 other papers co-authored by Lesné, appeared to use manipulated data. The study has been cited nearly 2500 times, is thought to have triggered \$287 million in US government drug funding in 2021 alone, and is the second most cited paper ever to be retracted, according to Retraction Watch data.

- Pat King, an organizer of the 2022 Freedom Convoy in Ottawa, has been found guilty of multiple charges related to his involvement in the protest. King, 47, was convicted of two counts of mischief, one count of disobeying a court order, one count of counselling others to disobey a court order, and one count of counselling others to obstruct police. King could be facing up to 10 years in prison.
- A new peer-reviewed study of over 3 million people finds "statistically significant" heart-related adverse events within 21 days of receiving the Pfizer and Moderna mRNA COVID-19 vaccines. The Cambridge University

Press study (Yun et al.) found that people vaccinated with mRNA shots from Pfizer or Moderna faced a 48% higher chance of developing acute heart issues, such as myocarditis, pericarditis, or even cardiac arrest, compared to those vaccinated with non-mRNA vaccines. They also observed that younger people, particularly males, who received mRNA vaccines were more likely to experience heart complications compared to older adults.

• Valencia, Spain, banned driving for 24 hours following heavy rainfall, amid growing concerns about the region's vulnerability to flooding. While establishment appointed scientists tried to claim that "climate change" was to blame for the floods, data showed no significant increase in rainfall. Critics point to Spain's recordbreaking removal of dams to protect wildlife, coupled with a reluctance to construct new, eco-friendly dams due to CO2 emission concerns, as contributing factors to recent floods.

- During its first full national non-rotating strike in A peer-reviewed study by *Rogers et al* published in the International Journal of Innovative Research in Medical Science found that brain clots are 112,000% more likely to occur after receiving a COVID-19 vaccine compared to those receiving an influenza vaccine. When comparing COVID-19 vaccines to all other vaccines combined, the likelihood is 20,700% higher. Their study called for an immediate global moratorium on the use of COVID-19 vaccines with an absolute contraindication in women of reproductive age.
 - During Taylor Swift's Eras Tour, a portion of Toronto's Gardiner Expressway (one of the world's busiest highways) was temporarily closed to accommodate her police-escorted motorcade. The Toronto Police further embraced the concert festivities by distributing friendship bracelets to fans.
 - According to grant documents obtained by Children's

Health Defense via a Freedom of Information Act (FOIA) request, the NIH has spent hundreds of millions of dollars in grants since 2020 to create "culturally tailored" pro-vaccine materials to promote COVID-19 and flu vaccines. The grants are part of a massive initiative by the NIH to increase vaccine uptake by "nudging" and changing how people make decisions.

- The University of Nevada women's volleyball team became the 5th university women's team to forfeit their match against San José State. San José State insists on having a biological male student play on their women's volleyball team.
- A report to the United Nations reveals that 600 female athletes have lost almost 900 medals across 29 sports to transgender rivals. The study, Violence Against Women and Girls in Sports, was presented by Reem Alsalem, the UN special rapporteur on violence against women and girls. In her report, Alsalem urged

the UN to provide "stronger protections for women and girls in sports."

- Outraged parents of children attending Oyster Pond Academy in Nova Scotia have pulled their children from class after a male drag performer gave a compulsory presentation on "gender identity" to children as young as 12. Following the uproar, instead of apologizing, the school issued a statement reinforcing their dedication to spreading LGBT ideology, claiming doing so ensures every student feels "safe, welcome, and respected."
- Despite British Columbians facing unprecedented financial challenges, the BC NDP has voted to increase their own pay, awarding themselves more money than ever before. As newly re-elected Premier David Eby unveiled his cabinet, The Canadian Taxpayers Federation highlighted that the cost of the cabinet is at

least \$490,000 higher than that of his predecessor. Ministers now receive an additional \$60,000 on top of their base salary of \$120,000, ministers of state earn an extra \$42,000, and parliamentary secretaries see an increase of \$18,000.

• The Trudeau government has introduced their plan to implement a new "ArriveCAN style" border crossing application. According to a federal report obtained by Blacklock's Reporter, by 2026, Canadians driving to the United States will be asked to pre-submit photos, provide their biographic and biometric declaration, and provide their license plate numbers to the Canada Border Services Agency through the new app.

• Trudeau, admits he overdid immigration and strained Canada's economy. Champion of immigration, Justin Trudeau, admitted that he "didn't get the balance right" at a news conference in Ottawa, as he took the unusual step of acknowledging his policies had placed a strain on housing and the economy. He said Canada needed to "pause population growth and let our economy catch up." Canada's population hit 41 million in April, with immigration accounting for almost 98% of population growth last year. Under the new plan, the target number of permanent residents arriving in Canada in 2025 will

be reduced by 21%, from 500,000 to 395,000.

- Report by DailyBread finds that 4 in 5 new food bank clients (82%) are newcomers to Canada, and more than 1 in 3 are either temporary residents, refugee claimants, or undocumented individuals.
- Two years after Ryerson University was renamed Toronto Metropolitan University, in response to concerns about Egerton Ryerson's involvement in the design of Canadian Indian residential schools, the institution is launching what may be the world's first DEI medical program, where prospective students will be chosen not on merit, but on the colour of their skin or their ancestry. Of the 94 seats in the program, 75% of students will be chosen from "Indigenous, Black, and Equity-Deserving admissions pathways." The remaining 25% of students will be chosen through the general admissions stream.
