## Trudeau Demands Life In Prison For "Speech Crimes"

To protect children from sexual exploitation, Canada must pass the Online Harms Act, says Prime Minister Justin Trudeau's government.

"I am the parent of two young boys," said Justice Minister Arif Virani. "I will do whatever I can to ensure their digital world is as safe as the neighborhood we live in. Children are vulnerable online. They need to be protected from online sexual exploitation, hate, and cyberbullying."

But Virani's bill is totally unnecessary to protect children. Its real goal is to allow judges to sentence adults to prison for life for things they've said and for up to a year for crimes they haven't committed but that the government fears they might commit in the future.

As such, Trudeau and Virani's Online Harms Act (Bill C-63) is the most shocking of all the totalitarian, illiberal, and anti-Enlightenment pieces of legislation that have been introduced in the Western world in decades.

The Liberal government's censorship legislation, when considered in the context of Trudeau's sweeping abuse of governmental powers during and after the Covid pandemic and new subsidies for government propaganda, sets a new watermark in rising totalitarianism in Western societies.

In an unusually long statement in response to a series of questions asked by Public, the Trudeau government's "Canadian Heritage" department, which regulates the media, tried to ease our concerns. "Bill C-63 is meant to bolster the rights of Canadians to express their thoughts and opinions," said the anonymous official, "by creating a safer and more inclusive online space."

But the government spokesperson went on to confirm the shocking truth about the legislation, which is that it would put people in prison for life for things they've said, specifically, "advocating genocide."

"Bill C-63 would increase the maximum penalty specifically for advocating genocide from 5 years to life imprisonment," said an unnamed spokesperson for the Canadian government, "and from 2 years to 5 years, on indictment, for the willful promotion of hatred (section 319 of the Criminal Code)." [emphasis added]

This means someone who writes something that a government official decides is "advocating genocide" will face a longer maximum sentence than someone who rapes a child.

And what might count as "advocating genocide"? Today, there are prominent politicians around the world

who say that supporters of Israel are advocating the genocide of the Palestinian people and that supporters of Hamas are advocating genocide against Jewish people. Imagine if they were in power. Under Trudeau's legislation, would they not be able to send their political enemies to prison for life?

a "peace bond" to incarcerate people before committing any crime. "Peace bonds are well-established tools in Canadian criminal law that are used to prevent an offense from being committed in the first place," the spokesperson said. "A peace bond will only be imposed where a court is satisfied that there are reasonable grounds to believe that an offense will be committed."

But it's not just advocating genocide or the willful promotion of hatred that can now carry life sentences. Under the new bill, if anyone breaks any federal law and the courts find that the law was broken for hateful reasons, that person can also be subject to life in prison.

"People can be jailed for up to 12 months just because other people fear they may commit future hate speech," noted Joanna Baron, the executive director of the Canadian Constitution Foundation. "The options are a year of imprisonment or wear an ankle bracelet, submit to DNA tests, submit to ongoing monitoring."

Let's not mince words. The Trudeau government is attempting to create "pre-crime" no different from the kind depicted in Steven Spielberg's dystopian 2002 film, *Minority Report*. The main difference is that in that movie, there appeared to be far more certainty that the police were preventing murders. In the case of the government's hate speech law, the crime is of using one's words in ways that offend the government

In reality, what's happening in Canada is a terrifying assault on two core Enlightenment principles: free speech and equal justice under the law. Those of us in Canada are as outraged as anyone else. And we are, like many others, seeking to understand what exactly is happening. Why did a longtime liberal democracy put in power a person and a

party committed to destroying it?

Strossen notes in her book *Hate: Why We Should Fight It With Free Speech, Not Censorship* that Canadian hate speech laws have in the past been used against French-Canadian nationalists, a Jewish community leader, and a pro-Israeli speaker. The government insists its definitions of hate are specific enough to avoid confusion. But Strossen documents how subjectively courts have enforced hate speech laws around the world.

And the new bill would take everything to a new extreme. Experts agree it will create a chilling effect. As such, despite the government's claims to the contrary, this chilling effect appears to be the bill's intended purpose. The Trudeau government wants to instill fear in people in order to control their speech.

As I wrote last September, Trudeau is pioneering a new way for governments to take control over the information

The fact that people disagree about what constitutes hate speech is at the heart of the problem. "Over and over," notes former ACLU President Nadine Strossen, "different decision-makers in the same country disagree about whether particular expression does or does not fall afoul of the pertinent 'hate speech' laws."

To enforce it all, the proposed law would create a new Digital Safety Commission with incredible powers to police content. "The breadth of powers is remarkable," noted legal analyst Michael Geist. The Commission's "rulings on making content inaccessible, investigation powers, hearings that under certain circumstances can be closed to the public, establishing regulations and codes of conduct, and the power to levy penalties up to 6% of global revenues of services caught by the law."

The Trudeau government spokesperson emphasized that Canadian laws allow the government to issue

# Note to Globalist Predators: Rolling Protests Until You Surrender

I have captured on my hard drive several hundred incidents of farmers, truckers, rail workers, you name it, on the march in every country and every region in Europe. They are out by the tens of thousands, and they are staying out, rolling thunder up and down the roads, clogging up traffic, walling politicians in their homes, and dumping manure at every government building. In the U.K., right now, they are marshalling for a massive truck and tractor protest on the way to London. Paris is in trauma, all of France locked up on a rolling basis, by which I mean the police never know where it's going to happen next. Every country, Poland, Greece, Italy, Corsica, Belgium, the Netherlands, and Spain, is on fire.

Here's the witless *Financial Times* on February 23rd:

*"It is a testament to how far political leaders and opinion formers have lost touch with agriculture that so few seem to have seen this coming. Governments that want to tackle climate change seem not to have thought through the effects on an industry that is facing rising production costs and falling global food prices."*

Sorry, Camilla Cavendish (a more elish name you cannot imagine), you are way, way, way out of date. Call yourself a reporter? Honey, you are a typist for the Rothschilds.

The *Financial Times* is about eighteen months behind the times. What is happening in Europe runs far deeper and presages far more systematic change than a temporary pulling back on taxes and regulation.

Nope, we are removing your lamp from your lampstand until you submit. Or, to be precise:

*"... repent and do the deeds you did at first; or else I am coming to you and will remove your lampstand out of its place—unless you repent."*

Dammit.

This is why the farmers' revolt is significant:

John Dickenson's *Letters from a Farmer in Pennsylvania* were carried from town to town, printed again and again, read out aloud at town meetings, electrifying pre-Revolutionary America. Farmers, said Dickenson, and I paraphrase, are the basis of any culture. Anger them too much, and things change. Plus, they are not beholden to anyone; they can feed and house themselves and are the base of independence; from their secure houses, new ideas are nurtured. Finally, they have mastered inputs and outputs. A farmer knows when a culture is failing. And they are respected. It was why Stalin murdered the Kulaks, too uppity, too unpredictable.

Another thinker, Henry St. John, the Viscount Bolingbroke, a Tory, founded the Country Party in opposition to the Whig ascendancy, which he called the Court Party, where advancement was doled out via preference and bribery, not the virtue of an idea or proposal. Bolingbroke (unreadable now) said that the country was from where all good things came: ingenuity, creativity, problem-solving. It must be heard. Bolingbroke and his friends are credited with the invention of a Parliamentary opposition.

He was exiled for his trouble, his properties confiscated, his wife left him, and he spent the time in Paris alternating whooping it up—famous for running naked along the Champs-Élysées—and consulting for bonny Prince Charlie's daddy, James Stuart, who claimed the British throne. And fighting for his rights, Bolingbroke was eventually allowed home, ran for Parliament, and went on to challenge the Court party, unpacking the legislation until the special deals that bled the country were consigned to history. The subsequent economic boom produced a period of growth in Britain, leading to the Industrial Revolution. And to the American Revolution, because Bolingbroke was much-read by the American founders.

Sound familiar? Because here we are again. The World Economic Forum, in partnership with the United Nations, has divided up the world and said this goes here and that goes there, and "free trade" is everywhere, but we pick the winners and losers. The losers are the people of Western democracies, slated to be overrun, their history, traditions, and practices buried. Too uppity, too inconvenient.

Europe is, finally, on fire. In every country, farmers are on the roads, joined by truckers and rail workers. Sixty-nine percent of Germany, the most obedient population in the E.U., is on their side. Even little Corsica

has its farmers out. This is just the beginning because farmers can come and go; they don't have "jobs," they have businesses, they are independent. In the last week of February, farmers started ripping up the fences outside the E.U.'s buildings with their backhoes. In France, farmers and truckers are walling government officials in their buildings. And while the specific complaint is Net-Zero and Europe's Green New Deal, everything is on the table, especially the floods of immigrants breaking small cities, towns, rural Europe's culture, traditions, and local economies.

Rishi Sunak, the globalist's globalist, has announced that he is not backing down. Macron was chased through a market last weekend, but he, too, is holding firm. Like Trudeau and the interloper Biden, they cling to power. These countries claim they have clean elections. I doubt it. The electoral reason for mass immigration is immigrant vote bundling via fast-tracking to permanent residency. It happens everywhere. People who barely speak the host country's language are told who to vote for by their community leaders, who distribute housing and benefits. Immigrants and migrants are sorted into swing districts where the cheat won't be noticed. Migrants in the U.S. are overwhelmingly sent to red (Republican) states.

The E.U. put all its faith in free trade agreements, which placed all the world's farmers in competition with each other, encouraging them to produce at the lowest possible price at the cost of their own incomes and growing debt."*

And that is why we are here. The winners in the food game are the consolidators, the bureaucrats who decide food prices and, of course, the markets, and finally, the hedge funds. It is a case of taking from the poor and giving to the rich.

• **Newfoundland fisheries have won their battle for freedom!** After protesting for weeks outside the Confederation Building in St. John's for a free and open fishery market (i.e., not to be restricted to selling only to the large corporations in the area), fishermen reached a deal with the NL government that allows catch to be sold to outside buyers.

• After a group of doctors, including Dr. Paul Marik, took the FDA to court for spreading lies about the efficacy and safety of ivermectin for the treatment of COVID-19, the **FDA settled and agreed to remove all social media posts and directives that claim we should not use ivermectin to treat or prevent COVID-19.** Dr. Marik utilized ivermectin in his COVID-19 treatment protocol as Chief of Pulmonary and Critical Care Medicine at Eastern Virginia Medical School and Director of the Intensive Care Unit at Sentara Norfolk General Hospital. Marik was made to remove the protocol from the school's servers while Sentara issued a memorandum to hospitals telling them to stop using ivermectin for COVID-19, citing the FDA.

• **More than four times more parents are against vaccinating their children compared to pre-pandemic times,** a new Canadian survey by the Angus Reid Institute shows. Canadian parents opposing the vaccination of their children rose from 4% in 2019 to 17% in 2024. The survey also found that 29% of parents expressed skepticism surrounding the science of vaccines, and 34% feared the risk of significant side effects. The survey also indicated a decline in the percentage of Canadian parents who believe vaccinations should be mandatory for school children, dropping from 70% in 2019 to 55% in 2024.

• **Bill banning chemtrails passes in Tennessee Senate.**

## FREEDOM WINS!

The Tennessee Bill, SB2691 (HB2063), would ban the government from engaging in "geoengineering experiments" and "intentionally dispersing chemicals into the atmosphere" in the state. Similar legislation has been introduced in at least six other states.

• **Bad news for COVID-19 vaccine manufacturers. A new bill would allow Americans to sue COVID vaccine manufacturers directly.** The *Let Injured Americans Be Legally Empowered (LIABLE)* Act would strip COVID-19 vaccine manufacturers in the US of liability protections, enabling Americans who took vaccines that were misleadingly promoted and federally mandated to pursue civil litigation for their injuries.

• Arbitrator James Hayes has ruled that **nine Ontario nurses, dismissed for not receiving two COVID-19 vaccinations, should be reinstated as their termination was deemed "unreasonable."** Hayes wrote, "Their employee rights may not be ignored," and stated that the policy should have allowed for the option of unpaid leave.

• **Nova Scotia Health Authority (NSHA) backs down on its COVID-19 vaccine mandate, offering those who lost their jobs the opportunity to return to work.** In their statement, NSHA said, "This change reflects our commitment to respecting the choices and autonomy of our staff members while also considering the evolving landscape of COVID-19 in its endemic phase."

• The National Health Services (NHS) of England announces that **children will no longer be prescribed puberty blockers at gender identity clinics.** After

reviewing the damaging effects of the hormones on children, the NHS said banning puberty blockers is "in the best interests of kids." Puberty blockers inhibit normal development of puberty, such as facial hair and breast development, and cause other health issues, such as weakened bones. Health officials said the government "welcomes this landmark decision by the NHS" and healthcare should be evidence-based to protect the "best interests of the child."

• The crown attorney has **withdrawn all criminal charges against William Laframboise, the alleged leader of the Windsor/Ambassador Bridge Freedom Convoy** in 2022. Laframboise was facing criminal mischief charges.

• Idaho Senate Bill 1245, nicknamed the **"Pesticide Immunity Bill" was shot down despite intense lobbying by the Bayer (Monsanto) Corporation.** The Bill would have given pesticide manufacturers immunity against liability for EPA-sanctioned pesticides. This legislation would have been similar to the 1986 Act, which gave vaccine manufacturers immunity against liability for injury and death caused by their products. We can all thank a coalition of advocacy groups, farmers, and other individuals for standing up to this sham legislation.

• **Trust in "experts" is on the decline among Americans,** according to a recent national telephone and online survey conducted by Rasmussen Reports. The findings reveal that, when it comes to making healthcare decisions, a mere 35% of American adults feel confident in relying on advice from "experts." In contrast, 58% of people emphasize the importance of conducting their own research before making such decisions.

# Confessions of a Tesla Owner: The Real Story

In February 2024, Hilary Mueller wrote a letter to the editor of the *Inverness Oran* sharing her countless negative experiences over three years of owning an electric vehicle (EV-2021 Long Range Tesla). She felt compelled to respond to Paul Strome's article that touted the benefits of EVs.

Hilary and her husband are organic farmers, who have been living in a fully off-grid, solar-powered home (in Nova Scotia, Canada) for the last eight years. They were initially enthusiastic advocates of the EV, even attending a Greta Thunberg-inspired climate change march in Halifax back in 2019. She admits: "I feel slightly embarrassed about sharing this so publicly because I truly feel that we got duped by clever and persuasive EV/doomsday marketing."

Even though the car was more expensive up front, she was optimistic because it only cost \$14 to "fill up" at home with a Level 2 charger. That would more than make up for the initial cost over time, considering the price of gas. "No pesky oil changes and Tesla's titanium shield under the car means no repairs due to rust." A trip to Halifax required an 18-minute stop at the Enfield Supercharger, but they looked at it as a break. Excitement ultimately waned and, by the end of the first year, they regretted their decision.

"The undulating, electric hum while the car charges for seven hours permeates our entire home and yard. Is that healthy?" Additionally, everyone had to "exit the vehicle ... at the Supercharger because it feels very unhealthy to be in such a high-voltage environment while it's charging. Rain, shine, snow, or sleet - everybody out!" To add insult to injury, she learned that the battery life decreases with every charge and that charging to 100% was not even advised - only to 80% as a precaution! They would later learn the toll that harsh weather would have on battery life and charging.

Fast forward to 2022, after one year they could still make it to Sydney and back if they did not make any detours. "Having to stop in Baddeck for two hours to juice up just to make the 40-minute journey home doesn't make much sense." However, they would need to stop at "the Enfield Supercharger when going to Halifax, but no

detours. Stick to the highway or else." This was all proving to be quite the challenge, but they continued to soldier on and be the true environmentalists that they wanted to be; it wasn't getting easier. By Christmas of 2023, the difficulties were becoming even more apparent. With a 2.5-year-old car, headed to "the Valley" and an outside temperature of 5°C, they worried they would not even reach the Supercharger. When they did arrive, it was almost dark and the entire family (with dogs, so unable



to go inside) had to exit the vehicle and wander around in the cold in Truro, for 1.5 hours to get enough charge to reach their destination because "staying in the car while it's charging feels like every hair on your body is getting charged up too." So, once they were on their way again, realizing that "the wall plug at Grandma's takes days to charge the car and we can't believe how poorly the car is performing," they stop to charge up ONE MORE time "just in case" at New Minas Supercharger.

Charging up in town before leaving, "everyone out into the cold" during the charge and repeating the same process again with kids and dogs, "windy and half raining, half snowing" for 35 more minutes shortly after, they barely made it home with six percent battery power. Why on earth would a vehicle that performs so unreliably be something we are encouraged to live with? This is inconvenient and frankly, quite nerve-wracking.

Hilary recounts the story of how one day in January

2024, she was driving with her husband, anxiously looking for a charging station. They finally arrived in Enfield before running out of energy, but their relief was short-lived as they quickly discovered that "Enfield supercharger is down. Neither the car nor Tesla phone app notified him; 9:00 p.m. on a Sunday. No indication of when/if the charger will turn on again. Car is at three percent. Not enough power to keep the heat on, let alone drive to a motel. Other EV drivers there are all cursing their cars and their decisions." They waited an hour for the station to restart and another hour to charge up! Two hours out in the cold!

February wasn't proving to be much better. One day, returning from the airport, her husband drove the EV, while Hilary drove their 2012 Toyota Matrix, the more reliable car, because she had to detour (to Antigonish) and pick up their dogs on the way home, which was too much to expect from the "Long Range Tesla." Despite the detour and stopping to collect the dogs, she made it home before her husband, since he had a one-hour stop to charge the EV. "It takes longer to charge an old battery... My husband finally made it home... with the heat turned off, because he was trying to conserve power. Made it home with six percent."

Hilary maintains that their EV was in standard working condition and had no issues (other than those common to every EV). All of the problems were simply a result of how a

Tesla performs (normally) along with the added stress of Canadian winter conditions and always wondering if you will make it to your next destination. "This is what range anxiety looks like! It is not, as Paul Strome so kindly put it, 'for those drivers who have trouble paying attention to their fuel gauge.' Range anxiety means constantly paying attention to your fuel gauge and crossing your fingers and toes, hoping you're going to make it!" Why switch to a mode of transportation that is so stressful and unreliable? Hilary ends, referencing Paul's letter:

"The February 14th letter features all of the dealership, government, and activist talking points. None of it is based on the real-life experience of a rural EV owner. The 'official range' of EVs is not based in reality. Only on the first day out of the factory (if it's sunny, with no wind, temps between 15-20°C, on a straight stretch road with no hills) would our car ever live up to its range expectations. Speaking as a former climate change activist and current EV driver, I can only see EVs working if you live in a big city and never plan on leaving that big city. The last thing we should be pushing for is to phase out internal combustion engine vehicles by 2035 in Canada. Yes, we absolutely have to take better care of our planet, but EVs make zero sense in the real world."

## Canada to Incorporate Social Scores in Banking

The Canadian banking system is set to be radicalized by open banking framework. Proponents are framing this as a way for banks to easily share information and access user data. The truth of the matter is that this is an opportunity to merge social standings with banking to provide government complete control over our finances.

The organization Open Banking Excellence, a World Bank partner that originated in the UK, claims that it will host all of a bank's relevant needs in one place. The organization, which has reached 40 countries, aims to "create exceptional platforms and content that promotes knowledge sharing, new thinking, and partnerships within the industry - catalysing the adoption of Open Finance and Data for better financial inclusion worldwide."

"It's about having that fairer, more inclusive, more open society," said Helen Child, founder of Open Banking Excellence. Open Society, well, that does sound familiar. Why is there a need for inclusivity and fairness in banking when it should come down to numbers? "It drives financial inclusion," she added. "It's democratizing data."

Data. That will be worth more than gold as we move forward with a cashless society. There is no easier way to control the masses than to control their access to money, their ability to buy, trade, and freely move about. The Canadian Press outlined the true motive in plain sight: "One of the biggest areas of growth is in credit assessments. Under open banking, lenders could directly access an individual's banking data, so they can look beyond credit scores. Consumers can also use it to build their credit scores, for example, by proving reliable rent payments."

Looking beyond credit scores equates to determining

if a person is fit to participate in the global economy based on their personal views. Look at what happened to Nigel Farage. He never committed a crime or did anything to warrant what many have called the "Farage fiasco." Nigel was suddenly debanked by Coutts & Co., and was unable to access any of his checking or savings accounts. His credit cards were deactivated. He was unable to participate in society without a moment's notice.

Farage did his due diligence and found that there were countless people who experienced the same financial attack carried out by the banks on behalf of the government.

This is a widespread phenomenon. We saw it happening commonly during COVID lockdowns, where users were not permitted to access places if their digital COVID passports failed. Now, us "sheeples," as we are all referred to, are dying in our millions,

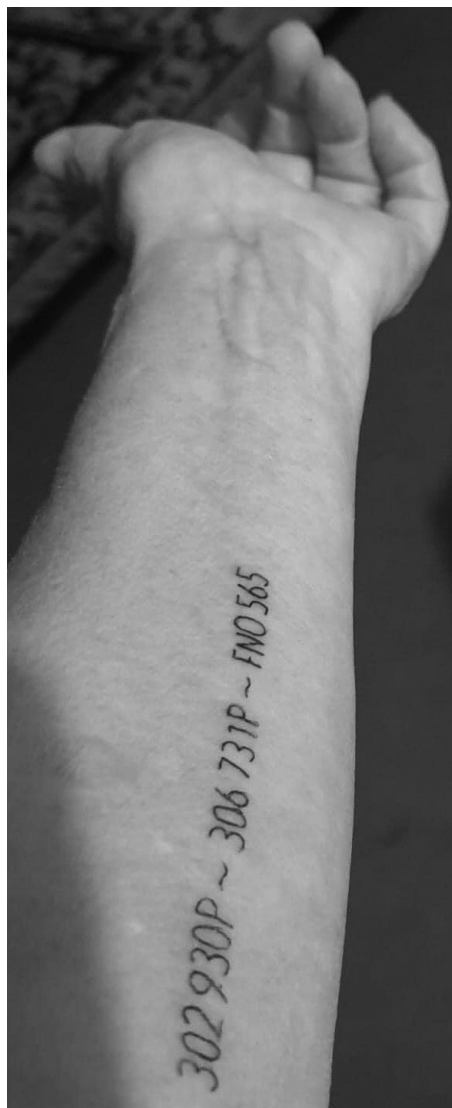
some suddenly, while some are destined to slow malingering pain-filled deaths. But we are dying, and ironically, we are the evidence—the proof you will all use later.

# Who Owns You? Health Canada?

## An Update on Your Ownership

Ownership means control. We own things so that we have control over them. Black's Law Dictionary defines ownership as "the complete dominion, title, or proprietary right in a thing or claim." The issue of who owns your body is going to be an interesting legal topic in the following years. When living organisms such as plants contain a genetic modification, the patent holder of that genetic modification has a property interest in the plant. So, if the pollen from a genetically modified crop transfers the genetic modification to an adjacent farmer's field, the patent holder of that genetic modification has a property interest in the infected crop. When a human has their DNA modified by mRNA vaccines, does the patent holder of the modification have a property interest in the human? Likely, but the ramifications of such property interests are yet to be explored by the Courts.

The legal area where ownership over another's body has been sorted out, is the area of slavery. For example, when slavery was allowed in the U.S., there were laws governing who had rights over the slave's body. In other words, there were ownership laws. Slaves have, until now, been the only class of persons who did not have control over their bodies. They did not have control because they did not own their bodies. Slaves have been the only class of

people that could not decide how they were going to treat themselves when they were sick or how they were going to prevent illness. In this way, slaves are like livestock. They have no choice when it comes to medical treatment.

Very soon, we are all going to learn what it is like to be slaves in that we will have no choice when it comes to medical treatment. The entity that will get to choose our medical treatments is Health Canada. It flows from this that Health Canada has the power of ownership over us.

There should be nothing more important to you than having control over your body. There should be nothing more important than having the right to choose your medical treatments. You are in the process of losing this right. You are in the process of losing control over your own body.

You are losing ownership over your body so that Health Canada can protect a different type of property: intellectual property. Our drug laws are designed to protect intellectual property rights (patents). They are not there to protect health. Here is how it works:

First, the government defines the term "drug" so broadly that it includes anything used for a therapeutic purpose. So, for example, even water is a "drug" if used to treat or to prevent dehydration.

Second, the government makes it illegal to sell a "drug" without government approval. With these two tricks, it becomes illegal to use any treatment the government doesn't give you permission to use.

Third, the government makes it so expensive to get

government approval that only drugs with intellectual property rights (patents) can get through the drug approval process. The process to get approval to treat a serious health condition can cost over a billion dollars. Less expensive applications still cost hundreds of millions of dollars. Companies only try to get drugs with patents through this process. If they are successful, they can charge high prices because the patent gives them a monopoly over the drug. You can only patent a chemical drug. You cannot patent a natural remedy. The effect of this distinction is that, in Canada, it is only legal to treat serious health conditions with chemical drugs.

What is changing is that Health Canada will now be making it so costly to get approval to treat moderate and minor health conditions, that only chemical drugs with patents will be able to afford to get through this process. The effect of this

Canada's goal.

One of the changes the SCF will bring about will be to require small natural remedy companies to pay the same fees that the large pharmaceutical companies pay. Many companies will go out of business and we will lose their products. The products that do remain will increase in price, taking them away from economically-disadvantaged Canadians. This change alone will likely make it impossible for homeopathic, naturopathic, and traditional Chinese doctors, whom many of us rely on, to access most of the remedies they use.

Companies with patented products (chemical drugs) will have a monopoly, enabling them to dominate the market, recover their costs, and make a profit. What are we and our natural health practitioners to do when we have no natural treatments?

We have to band together to stop Health Canada. Last year, Health Canada snuck into the Federal Budget Bill changes to the law that imposed penalties intended for large pharmaceutical companies on health care practitioners and small natural remedy companies. The fines increased from \$5,000 to \$5,000,000. No health care practitioner or natural remedy company can withstand these large penalties.

MP Blaine Calkins has introduced Bill C-368 to reverse these changes so that penalties on small companies and practitioners are reasonable. Second Reading for this Bill in Parliament is set for April 18, 2024. It is crucial that Bill C-368 passes second reading so that it can be analyzed in Parliament's Standing Committee on Health. We need you to put pressure on your MP to support this Bill. The Natural Products Protection Association (the "NHPPA") has both a petition and an email campaign to make it easy for you to give your support. Go to [nhppa.org](http://nhppa.org) to sign the petition and to send an email to your MP.

To stop Health Canada's efforts to take control of your body, you have to get involved. You cannot afford to lose your right to decide how to treat and how to prevent illness. For many of us, this is a do or die situation. We have to stand together. Please get involved with the NHPPA so that we can act together.

First, go to [nhppa.org](http://nhppa.org) and subscribe to the Newsletter. This will inform you about campaigns and initiatives you can participate in. You can learn about events and volunteering opportunities. Second, fill in the volunteer form. Third, support financially. We are fighting rich and powerful interests and to overcome their influence, we need to create the largest citizen rebellion in Canadian history. We need your support. We cannot do it without you.

This is a tremendous opportunity for Canadians to make Parliament responsive to us again. There is frustration from the Covid experience over governments being unresponsive to us. The Trucker Convoy became the largest protest in Canadian history. For 24 days, not a single member of the Trudeau Government would meet with the Truckers. Rather, the Government used the 24 days to organize a military-style police force to assault us. We have to get Parliament listening to us again. This is likely our best opportunity. Other than the Trucker Convoy, the two largest Citizen-led movements in my lifetime have been to protect access to natural remedies. Canadians are passionate about protecting their right to natural remedies, and we have an opportunity to use that passion to get Parliament responding to us again.

change is that, in Canada, it will only be legal to treat any health condition with chemical drugs.

# Are We In For a False Flag Alien Invasion?

Around the same time, late 1970s, Ben Rich, the director of US aerospace corporation Lockheed’s Skunkworks stated, “We already have the means to travel among the stars, but these technologies are locked up in black projects and it would take an act of God to ever get them out to benefit humanity.”<sup>2</sup>

Goodness knows there is enough recorded history surrounding the UFO phenomenon to choke a horse! Consider ancient cave drawings depicting what look like spacemen, Renaissance paintings with airborne objects hovering in the background, Sumerian clay tablets that tell the story of off-world visitors engineering humans to become slaves, the stories in the Book of Enoch, and the Bible’s tales of Elijah in the heavenly chariot, fallen angels, and the Nephilim.

There is no shortage of information on the UFO phenomenon. Hundreds of books, articles, movies, and television shows have been written and produced on the subject, and whether intentionally or not, all accounts have served to indoctrinate the public into the notion of the presence of extraterrestrial craft and life forms.

From the late 1800s “air ship” accounts, to the first reports in the 1940s of “flying saucers” by Kenneth Arnold, and the Roswell, New Mexico crash of the same year, to the Robertson Panel, the Condon Report, and Project Blue Book UFO investigations, to the 1952 UFO two-day fly-over at the White House, Washington, DC and the Arizona Phoenix Lights incident, to the Betty and

Barney Hill and Travis Walton abductions in the 1960s and 70s, and the hundreds of thousands of civilian sightings of UFOs on record at UFO reporting centres such as MUFON and NUFORC.

The phenomenon does not belong exclusively to the United States. Canada has her own history of UFO sightings, crashes, and abductions, as does every nation

Phenomena) travelling alongside and around ships, and that the US Department of Defence is taking these situations very seriously.

Since 2017 and *The New York Times* shocking disclosure, we have had a slow build of the UAP narrative seeping into the public domain. It’s been a roller coaster ride like nothing we’ve ever experienced. Videos of UAP flying at tremendous speeds in and out of the ocean or hovering over US Navy ships, have been released for public viewing. In July of 2023, the US Congress held a hearing on the subject and entertained “whistleblowers” such as US Intelligence officer David Grusch, along with retired US Navy pilot David Fravor and former US Navy fighter pilot Ryan Graves, all testifying under oath their experiences with UAP while employed in US intelligence and the military.

Congressmen and congresswomen, such as Tim Burchett and Anna Paulina Luna, are pushing for full disclosure of back-engineered alien technology, while some Senators continue to push back. environment—spreading disinformation and demanding censorship—that is similar but different to efforts we are seeing in places like California, Australia, and New Zealand.

People across the Western world were rightly alarmed when Trudeau, in February 2022, invoked the Emergencies Act for the first time in Canadian history and froze bank accounts of people who had donated to the “Freedom Convoy” protest led by truckers demanding an end to Covid-19 vaccine mandates. Trudeau justified such acts by demonizing ordinary Canadian truckers as “Nazis” and “racists.”

Then, Trudeau passed an Online Streaming Act and Online News Act, which gave the government expansive new powers to regulate what happens and what you see online.

In January, Alex Gutentag and John Morrison reported that the Trudeau government had used disinformation to justify its crackdown on the Freedom Convoy. The Royal Canadian Mounted Police (RCMP), Canada’s national police force, then promoted this false information to other “Five Eyes” English-speaking nations.

This discovery is significant because it contributes to a pattern of intelligence agencies from the US, UK, Australia, New Zealand, and Canada, which have collaborated on surveillance since World War II, being caught abusing their powers to investigate and persecute the political enemies of elected officials.

In addition to this inorganic governmental element,

there is also a cultural element at work. Canada has a reputation as a nation of polite and mild-mannered people. With a liberal democratic government in the tradition of Great Britain more than the United States, Canada has, in recent decades, undertaken extraordinary efforts to recognize historical injustices and create belonging among historically marginalized groups, including First Nations, racial minorities, and immigrants.

But over the last few years, Trudeau has turned this cultural goodwill against free speech, liberal democracy, and the rule of law. It is no surprise that the government is seeking sweeping powers to censor people in the name of reducing prejudice. It’s clear that, in Canada and other nations around the world, governments, including their intelligence agencies, are working with NGOs to weaponize a culture of compassion and kindness against the basic freedoms that Western nations have taken for granted for hundreds of years.

Hate speech laws fail on their own terms. During the 15 years before Hitler took control of Germany, there were over 200 prosecutions based on anti-Semitic speech, notes Strossen in her book. The laws thus actually helped the Nazis gain attention and support.

The good news is that many groups are raising serious concerns about the new bill and its impact on free speech and expression.

For example, the country’s national paper of record published a scathing op-ed. The *Globe and Mail* called the proposed bill “fatally flawed” and concluded, “There may be a balance to be struck between toughening sanc-

tions against hate speech while protecting freedom of expression and due process. The Liberals have not found that balance.”

And some NGOs, like the Canadian Constitution Foundation, are fighting back. Baron told Public that she is unaware of any other countries that impose life sentences for hate speech.

“The UK and Australia have brought in similar online harms legislation, and they’ve been focused on things like platforms having a duty of care to the user and the child protection legislation,” Baron said. “As far as I know, none of their packages had similar criminal provisions surrounding hate speech, and certainly not the public.”

But that’s where those nations may be headed. Canada appears to be playing a role similar to Ireland: to push the envelope in the war on free speech and democracy. The good news is that, as this pattern becomes visible, we become less vulnerable to it.

It’s up to lovers of free speech in Canada, the U.S., and other Western nations to expose what appears to be a coordinated effort by governments to regulate speech at a minimum and undermine free speech and democracy at a maximum.

Justice Minister Virani is right to want his children to be safe both in the real world and online. The problem is that, while we are not his children, he is attempting to treat us as ones, just as all totalitarian governments do.

# Is Measles a Real Threat or More Pharma Fear Mongering?

The mainstream media and pro-vaccine advocates in public health and government would have you believe we are at serious risk of a measles epidemic as a result of “vaccine hesitancy.” There is no doubt that there is an increase in parents questioning the vaccine narrative. Recent polls reveal that 1 in 6 parents say they are “really against” vaccinating their children, a four-fold increase from 2019. There has also been a significant increase in the proportion of Canadians who oppose mandatory childhood vaccination and say it should be the parent’s decision. The question is whether the risk to the health and safety of our children is “vaccine hesitancy” or whether the risk is blind faith in the vaccine industry.

The vaccine industry would have you believe that all vaccines are safe and effective, vaccines are responsible for the significant decline in mortality in the last century, and vaccines are necessary for our children’s health. The evidence supports none of these statements. These statements are marketing propaganda masquerading as science. The vaccine industry would also have you believe that measles is a serious illness that puts our children’s lives at risk and that if everyone simply vaccinated their children, then measles would be eradicated. These statements are also not supported by the evidence.

## A Childhood Rite of Passage

Prior to the introduction of the measles vaccine in 1963, measles was considered a childhood rite of passage. Virtually all children had measles. It was a time to stay home and to be cared for by one’s parents. They even made a Brady Bunch TV program about the benefits of having measles. Those of us old enough to have experienced measles are mystified by the drama and fear-mongering surrounding measles today.

For those who have only experienced measles through pharmaceutical marketing campaigns, measles presents as a whole-body rash, complete with fever, congestion, a cough, and pinkeye that lasts about a week. Measles is “highly contagious,” and before vaccination, almost all children contracted measles.

## The Measles Vaccine

When the measles vaccine was introduced in 1963, the promise was that one shot would confer life-long immunity and that measles would be eradicated by 1967. We now know that neither of these claims were true. The measles vaccine does not confer life-long immunity, as

evidenced by the “need” for boosters, and outbreaks regularly occur in fully vaccinated populations. Measles is still with us today after more than 60 years of vaccination.

What is not considered in the rush to inject every child is what is lost because of vaccination. Vaccine advocates



rarely admit that recovery from natural exposure to measles confers life-long immunity. More importantly, mothers who have been vaccinated for measles do not transfer long-lasting maternal antibodies to their infants that protect the infant in the first few months of life. That means that infants of vaccinated mothers are at increased risk.

Also not acknowledged is that while measles was once a serious illness in past centuries, the mortality from measles declined by 98.5% and was no longer considered a public health threat BEFORE the vaccine was introduced. To describe measles as a “killer disease” is fraudulent!

## Is the Measles Vaccine Safe?

When the mainstream media and vaccine industry claim that the vaccine is “safe,” they are misleading the public. Would the public agree the measles vaccine is “safe” when, as of May 31, 2023, there have been more than 109,499 reports of measles vaccine reactions made to the Vaccine Adverse Events Reporting System (VAERS) in the United States, including 547 deaths?

Further, a US Health and Human Services study acknowledged that less than 1% of vaccine adverse events are reported. That means the number of injuries and deaths could realistically be 100 times the reported numbers. If so, do 10,949,900 reactions and 54,700 deaths sound safe? The undisputed fact is that the safety of the measles vaccine has not been proven against a true placebo. Thus, the claims that the vaccine has been proven safe are false.

## So, What is Our Message?

You didn’t think I would leave things there, did you? Of course not. The real point of parsing the globalists’ (not-so-) secret message is that doing so helps us to clarify our own position.

When you boil it down, it’s actually pretty basic. The globalists hate life and want to end it. **To counteract them, we must cherish life and seek to preserve it.**

Allow me to quote myself at length from my 2016 editorial on “The Greatest Blessing”:

“We are programmed to look out for danger and respond to threats. It’s instinctual, and well it should be. We live in a dangerous world and our family line wouldn’t have made it this far if there weren’t an eternal vigilance against potential perils.”

“But always focusing on the threats and dangers can send us off the deep end. Especially when dealing in the doom and gloom that pervades so much of the alternative media, it can be all too easy to dwell on the negative and forget why it is we’re fighting for truth and justice in the first place. In fact, it can become difficult to remember that we’re fighting for anything at all and just focus on fighting against. Against our enemies. Against the politicians and bankers and globalists and fraudsters and psychopaths.

There is substantial evidence that the MMR (measles, mumps, rubella) vaccine is causing neurological damage in some children and that administering the MMR vaccine before three years of age can cause regressive autism. Autism has become an epidemic, with more than 1 in 36 children diagnosed. But it seems the media thinks measles is a bigger threat than autism.

Dr. Richard Moskowitz, a family physician with more than 50 years of clinical experience, deems the measles vaccine as “an unhealthy reprogramming of the immune system that trades off the acute, vigorous responses to infection in favour of “weaker, but ongoing, chronic responses that have rendered us a lot sicker than we would have been had we simply left well enough alone.”

## The Rise of Vaccine Hesitancy

The vaccine industry, which includes the media, would have us believe that “vaccine hesitancy” is a danger to society. We see it otherwise. At Vaccine Choice Canada, we view the increase in parents asking questions about vaccine safety, efficacy, and necessity as an

indication that parents are doing their due diligence. The reality is that almost all modern diseases originate from a disturbed immune system. No other drug intervenes in the immune system as intensively as a vaccine, and the effects of vaccination are irreversible.

The vaccine industry greatly exaggerates the risk of experiencing diseases targeted by vaccines. Measles is a classic example of the hype common with vaccine proponents. The reality is that permanent injury and death from measles are *exceedingly* rare in a developed country like Canada. Neil Rau, an infectious disease specialist, and Dr. Richard Schabas, MD, Ontario’s former Chief Medical Officer, stated in an October 2018 article titled “Stop the Hysteria Over Measles Outbreaks” that “*The borderline hysteria fueled by the media and public health that greets a few cases is unwarranted ... At current rates, Canada can expect to see a death from acute measles about once every hundred years or so.*”

Vaccine hesitancy is not a “threat to global health,” as the World Health Organization (WHO) claims. Instead, it is responsible parents doing their due diligence and finding that the vaccine industry’s claims that vaccines are safe, effective, and necessary are wanting. And that is what the vaccine industry is afraid of.

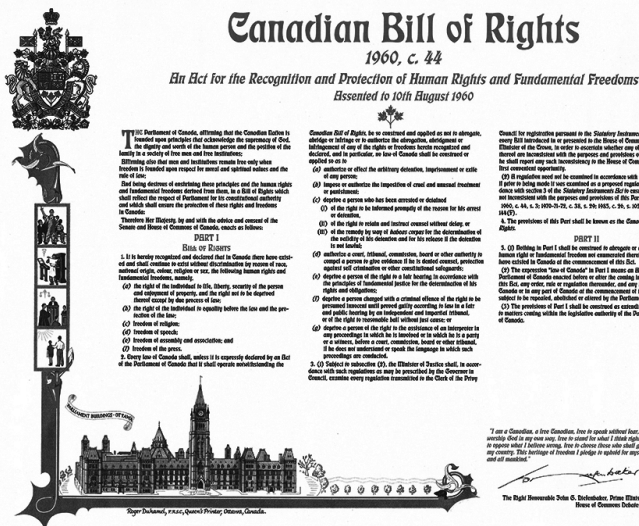
This article examines some of the history of our human rights and fundamental freedoms eventually brought under the Bill and reviews the current communist-globalist attack on Canada escalated through the pandemic. I hope to help people understand their legal rights and the importance of asserting them to maintain our democracy.

Not to worry; we are holding the line and many brave Canadians have stepped up to defend our beloved country. So far, we are in the lead.

The method being used to undermine our democracy and replace it with communism-globalism is primarily to destabilize the country and demoralize the people. It comes straight out of the communist handbook.<sup>2</sup> They are carrying out their plans subversively. In order to pull it off, they have to be able to legally get the police and military to act against the people, which is not permitted now under Canadian law. One technique they use is trauma-based mind control called psychological operations (psyops), which is done through infiltration of our government and main institutions, including schools, mainstream press, social media, and our protest movements.

There have been thousands of Bill wins regarding Covid-19-related charges. For example, Dave Freedom, who was criminally charged for protesting his charges, had them dropped in his challenge by using the freedom of speech and assembly portion of the Bill. We have more wins<sup>3</sup> for charges related to Covid, the Freedom Convoy, and Rolling Thunder on the record.

## An Act for the Recognition and Protection of Human Rights and Fundamental Freedoms



In reading the Bill,<sup>4</sup> the preamble indicates that the State is recognizing and protecting human rights and fundamental freedoms, i.e., God-given by virtue of being human. The State is committing to protect these rights. Note that this Act obligates the State, including the King, and puts no obligations on the citizens of Canada.

Part 1-1 of the Bill lays out those rights and freedoms recognized and protected by the government. It is the “Rule of Law” that individuals have a right to equal benefit and protection under the law. It protects the right to life, liberty, security of person, and enjoyment of property. It protects the freedoms of religion, speech, the press, and of assembly and association. It also guarantees legal rights, such as the rights to counsel and a fair hearing.

Part 1-2 indicates the only way the Bill can be changed. Rights in the Bill are protected in Common Law, so they cannot be removed by legislation. For example, with the

## THE CHARTER

The Charter of Rights and Freedoms opening statement:

“Section 1 The Canadian Charter of Rights and Freedoms guarantees the rights and freedoms set out in it subject only to such reasonable limits prescribed by law as can be demonstrably justified in a free and democratic society.”

Right out of the gate, unlike the Bill that recognizes your God given “human” rights, the Charter merely guarantees the “rights” laid out in the Charter. These are government-issued rights that can be and are currently being taken away easily without court or parliamentary approval under the Covid-19 bylaws.

And it eliminates the preamble of the Bill that talks about free individuals and free institutions and the importance of family. This was not an accident. This omission is to help us move towards communism where humans are not free, institutions are not free, and the family has little or no importance. And it has eliminated the right to enjoy property (this is also a communist purpose as land rights interfere with their aim to control all land use) and the right to equality before the law and protection from the law (also important to establish communism).

We will start with a description of what happens in a Charter Challenge. In the Charter, the rights (note not human rights) are said to be guaranteed. Look up the guarantee; it allows conditions. And that condition is the State can set limits on your rights without going to court or passing an Act through parliament. They merely have to claim, not prove, that they have justifiable reason such as they have done with the Covid-19 measures, which violate all your rights. These Covid-19 measures violate all your fundamental rights. And to try and get them back, you must go to Court.

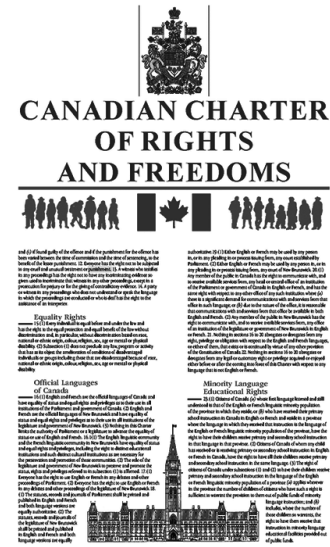
## There are many problems with the Charter Challenge approach of fighting Covid-19 measures

Your right to life, liberty, security of persons, enjoyment of property, the right not to be deprived thereof except by due process of law (Common Law), the right to be treated equally by the law and protected equally by the law, freedom of religion, speech, assembly, association, and press are all violated with the Covid-19 measures.

If you use the Charter, there will be the problems and impediments you face in trying to get your rights back.

Section 1 is sometimes called the Mack Truck clause because it is a big enough loop hole for a Mack Truck to drive through. This section limits any and all your rights and freedoms without court approval or public debate in advance. Charter Challenge is the only recourse, which is lengthy, complicated, and expensive. Section 24 even gives the judge enough authority to override your Common Law rights.

case of Alford v. Canada 2022. The bottom line is that the rights and freedoms cannot be abridged unless there is due process of law, which is a judicial decision calling for it, and an Act of Federal Parliament to pass the reduction of rights into law. This is very difficult and unlikely to happen because judges are required to respect established Common Law rights. And to date, no rights have been removed, nor has there been any attempt to do so, since the Bill was passed in 1960. Conversely, with the Charter, they can just bang out bylaws that violate all your rights under section 1 and leave it up to you to go to Court and challenge the reasonableness of the violations.

The best thing about the Bill is that you can cite it anywhere the government including police or private persons are enforcing Covid-19 measures with sanctions. The Bill applies in all cases where force is used because this is federally regulated activity (Criminal Code of Canada) when they are using force. And the Bill can be cited without notice in all proceedings related to Covid-19 measures where force is used. This includes bylaw tickets, criminal charges, and Section 22 closures of churches or businesses.

The Bill was presented to the federal parliament in Canada by John Diefenbaker and passed into law in 1960. The Bill was an attempt to codify all your Common Law rights that back the Bill up when used in formal proceedings. When you use the Bill, you do not have to argue whether there was a good enough reason your rights were violated. To seek a remedy, you only have to show your rights were violated.

Diefenbaker was concerned about keeping communism out of Canada and the Bill was the tool he believed would work to do the job. Here is a famous quote by Diefenbaker that he made when the Bill passed:

“I am a Canadian, free to speak without fear, free to worship GOD in my own way, free to stand for what I think right, free to oppose what I believe wrong, or free

# Big Pharma and the Billionaires Invested in the Gender Industry

There is no transgender community that pushes an ideology of body dissociation around the world—at lightning speed—into language, law, institutions, and the media simultaneously. We are governed by oligarchs at the highest echelons of finance, and they have a vested interest in the gender industry.

“Gender identity” ideology is not politically separate from business. Business is no longer separate from politics. We in Western cultures are governed by billionaires in finance who drive policy through our political institutions. A façade of democracy shrouds the oligarchy we live in, just like the gender performances in gender ideology shroud the capitalist profiteering from the colonization of human sex.

Many people view the gender industry as solely or predominantly a political issue, one that sets the rights of one group above or against another’s. While antagonized factions do fight with each other, business reigns.

Jon Stryker is one of the billionaires driving “gender identity” globally. He finances his LGBT non-governmental organization, Arcus Foundation, from his stock in medical multinational Stryker Corporation, to which he is the heir. Vanguard Group, one of the world’s biggest investment companies, holds the largest share of stock in Stryker Corporation. BlackRock, the most significant investment company in the world (global assets total \$20 trillion), is the third-largest holder of Stryker Corporation stock and the biggest holder of Vanguard Group stock. The fourth is Greenleaf Trust, the financial management company Jon Stryker left to create Arcus Foundation. Cumulatively, these investment houses own Stryker Medical and would hold influence over its operations.

Those at the pinnacle of the global LGBT corporate juggernaut come from banking and investment, not human rights. BlackRock employs a former Federal Reserve vice chairman and a former head of the Swiss National Bank. BlackRock recently rolled out a “queer” credit card through MetaBank, part of Meta Financial Group. Meta Financial Group’s largest shareholder is BlackRock.

BlackRock states that LGBT diversity is “in their DNA” in their LGBT outreach to Asia. MetaBank was one of the banks that sent our stimulus checks to America during the COVID crisis. A CNN report claims, “BlackRock is so powerful that the federal government has asked for its help during each of the past two recessions. In March, the Fed tapped BlackRock to manage the first-of-its-kind vehicle to buy corporate debt, including junk bonds.”

Authentic Brands Group was on the receiving end

of an \$875 million investment by BlackRock in 2019. Authentic Brands Group owns 50 brands, including Sports Illustrated, which has now featured on its covers not just one, but four men claiming womanhood for themselves. Its Aeropostale brand donates money to LGBT causes from its “gender-neutral” collection.

Black Rock owns the lion’s share of stock in 38 companies donating to Planned Parenthood, which has become the largest provider of cross-sex hormones to young people. They are also among, or the largest shareholders, along with Vanguard Group, of Johnson & Johnson



pharmaceutical giant, Pfizer, United Therapeutics, GlaxoSmithKline, AbbVie (the makers of Lupron), Merck, and Novartis. It would be easier to list the Pharma giants not owned by BlackRock. They also own most of our media conglomerates, such as Comcast and Disney, our payment platforms and banks, and our food corporations. They own banks such as Deutsche Bank, Goldman Sachs, and JP Morgan Chase, all of whom have shown a keen interest in “gender identity.” They own our textile companies, and they own Big Tech.

BlackRock, along with the Vanguard Group (which they own as well), nearly own the world, and it’s obvious they have an investment in the ideology of “gender identity.” What exactly are they investing in when they financially support this new ideology being driven across the globe?

We must look at what “gender identity” accomplishes in the world to understand this and why the largest banks and investment houses in the world have any interest in a tiny minorities’ identity issues. “Gender identity” does double duty. First, it opens markets in sexual identity. Without it, the already massively profitable corporate identities created out of same-sex attraction could not

be expanded. Without violating the boundaries of male and female, all that exists are lesbian, bisexual, gay, and straight people as a marketing constituency. Add “gender identity,” which provides an illusion of changing sex, placing it on a spectrum, and the marketing constituency expands infinitely. As “gender” ideologists are fond of reporting, there are as many genders as there are people. Any marketing graduate can tell you that honing your message to smaller and smaller, more distinct groups is a recipe for success. Not only are medical identities profitable in this equation, but profits soar for everyone.

Make-up lines, like Crayola’s new Boing Boing, for so-called “gender fluid” individuals, Jecca, a London-based unisex brand of make-up that launched in 2012, Sephora’s Phluid non-binary fragrance line, clothing lines like TomBoyX which market traditional men’s boxer shorts shaped for women’s bodies, are just a few small examples of the marketing opportunities that occur when the boundary between male and female is blurred, and sex has been pronounced as existing on a spectrum. These product lines help to make the illusion more real that we are not a sexually dimorphic species and that there is some other way to be human while supporting new markets.

The cosmetic industry is worth a staggering \$532. Billion dollars. Until recently, males wearing cosmetics were limited primarily to the music industry. “Gender identity” changes all that. It builds a bridge

for men to accept hair, fashion, and cosmetic enhancements that were traditionally the sole territory of women. The 2021 catwalks were ablaze with a so-called feminine menswear trend, which the fashion industry calls “male femininity.” The men’s personal-care market is expected to hit \$166 billion in 2022. Vogue reported two years ago that high fashion houses like Chanel, Tom Ford, and Marc Jacobs were unveiling make-up lines for men.

“Gender identity” also works as a grooming apparatus that dissociates us from our sexed reality. The language and laws being changed, even in our medical institutions, for “gender identity” ideology are based on the deconstruction of sex. The gender performances in gender ideology obscure the corporate mining of our reproductive capacities for profit. We are being reduced to parts—no longer men and women—but breasts, penises, vaginas, wombs, eggs, and sperm that can be bought by either sex, for either sex.

The gender industry has nothing to do with inclusivity. It is about corporate profiteering.

### RECOMMENDATIONS

We recommend that you get involved and engage to protect our democracy. We need to oppose the communist agenda by maintaining our rights and freedoms as sovereign people. ## Some Of The Most Absurd Things That Have Happened In Recent Weeks

- **WeightWatchers has issued an apology to its customers, admitting they "got it wrong" in the past when they said weight is a matter of diet and lifestyle.** In a strategic shift, the company now plans to incorporate weight-loss medications such as Ozempic into their plan.
- **Over 140,000 US farms were lost in just five years.** Between 2017 and 2022, the number of farms in the US declined by 141,733, or 7% —an area loss equivalent to the size of the state of Maine. Meanwhile, in that same amount of time, insect protein and lab-grown meat investor Bill Gates became the largest private owner of farmland in the US, currently owning over 270,000 acres across 18 states.
- **In the ongoing landmark fluoride trial—that seeks to prohibit the addition of fluoride to water in the US—an Environmental Protection Agency (EPA) risk assessor admitted under oath that fluoride is neurotoxic even at relatively low levels.** Furthermore, the agency's key expert witness on fluoride's neurotoxicity conceded to serious flaws in his own study.
- In possibly a new record, after a FOIA request by the *Epoch Times*, the CDC (Centers for Disease Control and Prevention) released their 148-page report on myocarditis after COVID-19 mRNA vaccination—it is completely blank due to a full redaction of absolutely everything it contains.
- Was "long COVID" just a fad? Australian Chief Health Officer Dr. John Gerrard says a scientific study proves "long COVID" doesn't exist. One of Australia's leading doctors urges everyone to refrain from using the term "long COVID" following a new study that found the long-term effects of the coronavirus are no different from those of other viruses. The study, conducted by Queensland Health, examined 5,000 Queenslanders and found that adults who tested positive for COVID did not experience an increased rate of "long-COVID"-like symptoms compared to those who had the flu or a cold.
- **Dengue fever has spiked fourfold in Brazil following the release of millions of gene-edited mosquitos by the United Nations' World Mosquito Program.** In the first five weeks of 2024, over 364,000 cases of dengue infection have been reported—four times greater than previous cases in the same period in 2023. The dramatic spike in dengue cases has prompted Brazil to purchase millions of doses of the dengue vaccine.
- **Electric vehicles (EVs) release more toxic particles into the atmosphere and are worse for the environment than their gas-powered counterparts,** according to a resurfaced study recently highlighted by the *Wall Street Journal* (bit.ly/3TpCu01). According to Emission Analytics, who conducted the study, modern cars have improved in cleanliness so much that most vehicle-related pollution while driving actually comes from tire wear. The study found that EV tires and brakes, with their significantly heavier load, release 1,850 times more particle pollution compared to modern tailpipes, which have "efficient" exhaust filters.

- A new whistleblower video shows Pfizer's principal scientist admitting that the company skipped 10 years' worth of safety testing and had significant knowledge of mRNA vaccine side effects, but released the COVID-19 jab anyway. Justin Leslie, a former Pfizer employee and whistleblower, released the video recording of a private conversation with Kanwal Gill, a principal scientist at Pfizer, online. Kanwal also talked about how they had been attempting to market vaccine mRNA technology for 50 years, but due to side effects, were not able to do so until the company used the pandemic to bring mRNA vaccines to market.

- When CTV News asked Ontario Premier Doug Ford about what he learned from the pandemic four years later, he responded with: "I think we did extremely well compared to the rest of the world." Reminder: Ford implemented a province-wide vaccine passport system that compelled businesses to restrict unvaccinated patrons in places like restaurants, sporting events, and movie theatres or face steep fines. His government also strongly advocated for a six-foot social distancing measure that, in turn, appeared to greatly financially benefit to his labelling company, *Deco Labels*.
- For years, people who believed COVID was like a bad cold or flu were called "conspiracy theorists." Now, the CDC has issued new isolation guidelines for COVID-19 that are in line with the flu and other viral respiratory illnesses.
- FDA Chief Dr. Peter Marks acknowledges that the "avalanche of reports was tremendous," referring

- to adverse event reports from the COVID-19 vaccines. As noted during the hearing by the Select Subcommittee on the Coronavirus Pandemic, as of February 2024, Vaccine Adverse Event Reporting System (VAERS) reports for COVID-19 vaccines total significantly higher than all other vaccines combined since 1990.
- **Goodfellas Wood Oven Pizza, with seven locations in Toronto, Ontario, is charging people a 2% carbon fee on all orders to fight climate change.**
- **Despite a decline in viewership, the federal government pledged to give the CBC yet another \$1.4 billion handout for the 2024-2025 fiscal year.** In the 2022-2023 fiscal year, CBC received \$1.3 billion from the federal government. The CEO also disclosed that the company paid out bonuses totalling \$14.9 million in the same fiscal year. CBC fails to see their decline in viewership as being related to the lies they tell, instead claiming it is due to "news fatigue following two years of the COVID-19 crisis."
- **COVID-19 lockdowns had high health and economic costs,** study shows. A recent Swedish study published in the *Economic Affairs Journal* (Andersson & Jonung) found that Sweden's less restrictive COVID-19 policies, in contrast to other European nations that imposed stronger lockdown rules, led to lower excess mortality. Sweden also suffered a lower negative impact on GDP growth during the COVID era.
- After millions received mandated vaccinations in the name of protecting others, **FDA Chief finally admits that the COVID-19 vaccines may not prevent transmission of disease.** During a hearing with the Select Subcommittee on the Coronavirus Pandemic. FDA Chief of the Center for Biologics Evaluation and Research, Dr. Peter Marks claimed, "it may not prevent infection" as the data on transmission is "challenging to pin down."
- Of all media outlets, CTV News reports that **Ontario Hospital staffing shortages could be due to COVID-19 vaccine mandates.** Unions representing Ontario hospital workers continue to label the province's staffing crisis as being at its "breaking point."
- **France's "Pfizer Amendment" could potentially turn mRNA critics into criminals according to a highly-controversial law that was just pushed through the National Assembly.** The draconian law aims to throw journalists who advise against the use of therapeutic or prophylactic treatment (including experimental mRNA gene therapy) into prison for up to three years and pay a hefty fine of 45,000 euros.
- **Regina, Saskatchewan's oldest Catholic church, Blessed Sacrament, becomes the 100th vandalized church in Canada since 2021.** Captured on video, the gas-carrying, mask-wearing arsonist was just one of a flurry of arsonists that have targeted churches following the residential schools' mass graves announcement in 2021. Of the hundred countrywide church attacks, fourteen served congregations on Indian reserves, and eleven churches were hit on a single day in Calgary.
