Wearing Masks Made No Difference CONFIRMED: The "Anti-Maskers" Were Right

The most rigorous and comprehensive analysis of scientific studies conducted on the efficacy of masks for reducing the spread of respiratory illnesses — including Covid-19 — was just published. The study, titled, *"Physical interventions to interrupt or reduce the spread of respiratory viruses"* (Jefferson et al.) was conducted by The Cochrane Collaboration, a British non-profit that is widely considered the gold standard for its reviews of healthcare data. The group's analyses are often used to inform policymakers — and this study's outcome is clearly the opposite of what our policies have been. The article concluded: *"Wearing masks in the community probably makes little or no difference to the outcome of influenza-like illness (ILI)/ COVID-19-like illness compared to not wearing masks"*

In an interview, Tom Jefferson, the Oxford epidemiologist and lead author told journalist Maryanne Demasi on Substack:

"There is just no evidence that they" — masks — "make any difference," "Full stop."

But, wait, hold on. What about N-95 masks, as opposed to lower-quality surgical or cloth masks?

"Makes no difference — none of it," said Jefferson.

What about the studies that initially persuaded policymakers to impose mask mandates?

"They were convinced by nonrandomized studies, flawed observational studies."

What about the utility of masks in conjunction with other preventive measures, such as hand hygiene, physical distancing or air filtration?

"There's no evidence that many of these things make any difference."

The Study

Jefferson and 11 colleagues based their conclusions on 78 randomized controlled trials, six of them during the Covid pandemic, with a total of 610,872 participants in multiple countries.

They also tracked what has been widely observed in the United States: States with mask mandates fared no better against Covid than those without. The study shows that mask mandates were a bust when it comes to the population-level benefits of masking. Those skeptics who were furiously mocked as "anti-maskers" and censored for spreading "misinformation" for opposing mandates were right. And the mainstream experts and pundits who supported mandates lacked solid evidence to support their argument.

The Response

In light of this meta-analysis, during congressio-

nal testimony, Rochelle Walensky, director of the CDC, insisted that her agency's guidance on masking in schools wouldn't change. She also called into question the Cochrane analysis's reliance on a small number of Covid-specific randomized controlled trials. Of

to wear a mask, the other not wearing a mask," and that masks were ineffective against virus-laden aerosols, as airborne viruses can *"penetrate or circumnavigate a face mask."*

- A May 2020 study found no difference in case rates between U.S. states that had mask mandates compared to those that didn't, and a British survey of infection rates among school children found *"no evidence that face coverings, 2-metre social distancing or stopping children mixing were associated with lower odds of COVID-19 or cold infection rates in the school."*

Harms in Masking

Mask mandates were a fruitless endeavour from the start. And, as noted in the Cochrane review, *"Harms were rarely measured and poorly reported."* Most notable is the psychological harm imposed on young ones. Entire knowledge bases of early literacy and speech development are formed on seeing human faces. Here is just a small sample of studies that illustrate this:

- A study (Stajduhar et al.) showed that masks were disruptive to school-aged children's ability to process human facial cues
- An observational study by Brown University (Deoni et al.) found significantly lower cognitive scores in toddlers since the beginning of the pandemic
- American Speech and Hearing Association study (Grieco-Calub et al.) found restrictions and mask mandates had negative impacts on communication skills

Interestingly, while Canadian provinces mandated 2-year-olds wear masks, *The Cochrane review* failed to find any study conducted on the efficacy of facemasks on 2-year-olds. It seems they realized that if they don't study it, the answers they don't want to come to light will stay hidden — at least for a little while.

Indeed, physical well-being may not have been the primary purpose of facemasks. Instead, they served as a constant reminder that we were living in a "pandemic" and should be living in fear of the virus.

The Final Lesson

Pandemic theatre is not science. Wearing a mask should have been left as a personal choice, not a public mandate. And the people who had the courage to say as much never deserved to be called names like "anti-masker" and "conspiracy theorist." No one should have lost their job for questioning the "science." They may never get the apology they deserve, but at least they have been vindicated.

course it's a small number because very few randomized controlled studies were actually done on masking and COVID — almost as if the CDC and other health authorities didn't want to know the results. But this goes the other way too — where are their randomized controlled trials that find masks *do* protect against COVID-19?

The Science

Remarkably, the absence of evidence to support mask-wearing for infection control was confirmed from the very beginning by the same agencies and organizations that ended up mandating universal mask-wearing. For example, a CDC policy review paper, published in May 2020, concluded that there's *"no evidence that surgical-type face masks are effective in reducing laboratory-confirmed influenza transmission, either when worn by infected persons (source control) or by persons in the general community to reduce their susceptibility."*

Similarly, guidance by the World Health Organization, published in June 2020, stated: *"At present, there is no direct evidence (from studies on COVID-19 and in healthy people in the community) on the effectiveness of universal masking of healthy people in the community to prevent infection with respiratory viruses, including COVID-19."*

And the well-designed studies that were conducted while mask mandates ramped up in 2020 continually found no evidence to support masking:

- A randomized controlled trial in Denmark, which looked at COVID-19 infection specifically, also concluded there was *"a non-statistically significant difference between two groups of participants, one requested*

Is This a Controlled Demolition of Our Banking System to Set Up For a Central Bank Digital Currency As The “Solution”?

While many are grumbling loudly about the cost of everyday items and worrying about the national debt, another crisis is brewing. Commercial banks are sitting on trillions of dollars of unsustainable private debt. In recent years, the commercial banks have been able to issue new credit almost without limit in what is known as the 0% reserve system. Now they are scrambling to meet increased capital requirements. As the economy tightens, the banks are in a precarious position. From January 2020 to December 2021, we witnessed a frenzy of Quantitative Easing (QE). Quantitative easing is a monetary policy action whereby a central bank purchases predetermined amounts of government bonds or other financial assets in order to stimulate economic activity. But as interest rates rise, credit conditions are tightening private sector banking money creation. Diminished earnings are taking a toll on stock prices including bank stocks, and no surprise, no one in the media is mentioning it. The strongest Canadian banks at the moment are Royal Bank, National Bank then BMO and TD. Both CIBC and Scotiabank are carrying the heaviest debt loads according to current data.

This sounds risky but it gets even worse. As interest rates rise, loan failures could trigger a major derivatives crisis; as happened in 2007/8 during the sub-prime mortgage fiasco. Last time, a big tax-payer funded **bail-out** occurred, and those who recklessly gambled money away were never punished. *Maybe the banks learned a lesson at least*, you may think. Unfortunately, they did not learn; they have continued with their high-risk derivative trading, and their exposure today is at least 5 times higher than it was in 2007 according to the Office of the Comptroller of the Currency (OCC) in the United States.

The movie *The Big Short* is a must watch to understand how this all happened. The fall-out here from the current financial fiasco could — and likely will — be much worse, as it is combined with all the other fiascos being perpetrated on Canadians, such as: higher and higher taxes including the ridiculous carbon tax; wild inflation, soaring food prices and supply chain issues in many sectors causing increased bankruptcies along with attempts to bring in increased totalitarian controls including the Digital ID

Did you know that legislation was introduced years ago to allow for “**bail-Ins**” in future, rather than bail-outs? What does that mean you ask? Anyone with a bank deposit, legally speaking, is now considered an ‘unsecured creditor’ of the bank, and the savings of depositors can be confiscated to fix shaky balance sheets. This is of concern to all of us who have families to feed and bills to pay and need to trust that our savings are protected by the CDIC (Canadian Deposit Insurance Corporation).

Is it too late to stop the collapse? According to my recent Podcast guest, David Ward, former Bond Trader

and Financial Commentator, Canada must reform its banking system regardless of what happens this year or in the future although a collapse is likely. The commercial banks have demonstrated that they will not reform of their own accord, and sooner or later, their greed will bring about a total implosion of our current financial system. Will we return to a full reserve system or create legislation like the *Glass-Steagall Act* (which was established in the wake of the 1929 stock market crash) to separate investment and commercial banking activities to protect us from corruption and fraud? How can we reform our monetary system?



Needed changes:

A move to 100% reserve/full reserve banking is crucial. This option must be revisited, as in Switzerland, here in Canada, and elsewhere. In the 100% reserve system, banks would act simply as ‘financial intermediaries’ (as everyone currently thinks they operate), lending out only the money they have on deposit. In a full reserve system, banks are not actually creating our money (as they do today). From the Bank of Canada: ‘Commercial banks and other financial institutions provide most of the assets used as money through loans made to individuals and businesses’. In a fractional reserve system, commercial banks do actually create money (bank credit), ‘multiplying up’ deposits, and this has been the primary driver of inflation in this country from the 70s on. This has been hugely profitable for the banks, and extremely costly for Canadians. Our national debt is a direct result of this process. In the 0% reserve system, post-1994, profits for banks grew massively, but this system is a Ponzi Scheme by every definition. Our economic woes today are a direct result of the implementation of this ‘capital adequacy’ system.

Tax Reform. Did you know that before the Federal Reserve was created in 1913 as a “temporary measure”, there was no personal income tax? People could keep their hard-earned money. Future taxes will need to fair and not be used to siphon wealth from poor and middle class. A flat tax may be introduced along with other tax reforms since most of the taxes collected have not benefited citizens in the past.

Some form of currency control is required to pre-

vent sovereign Canadian dollars from leaving the country and also to prevent inflows of cash that distort both domestic markets and the political process. To prevent ‘rent seeking’ the recycling of offshore money must be strictly limited. The influx of other offshore money is the most important factor driving bubbles in asset prices, including real estate. The next generation of Canadians must be able to afford a home of their own; right now, they have to compete with massive private equity firms.

Preservation of physical cash, even if a Central Bank Digital Currency is introduced for both practical and technical reasons.

Resistance to all forms of Digital ID, Central Bank Digital Currency (CBDC) ‘programmable money,’ Carbon Credits, Social Credit Scores and vaccine passports.

Is this a controlled demolition of our banking system to set up for a Central Bank Digital Currency as the “Solution”? Many believe this is the case. Or we might see it being introduced with the carrot of Universal Basic Income (UBI) as long as you sign up for the Digital ID and are compliant with other Social Governance Requirements (aka Chinese style social credit system). Time will tell and that time is approaching us very rapidly. In the meantime, it doesn’t seem like a bad idea to move to a credit union and get some solid real assets like precious metals and land and even tradable items like coffee and chocolate if you can, although this is not intended as financial advice. Whether it is a soft landing or a

very hard one, everyone with a comfortable nest egg can do their part to help the less fortunate as many families are breaking under massive increases in the cost of living. It is good to shore up your savings, pay down debts, keep cash on hand and opt to support local companies over globalist enterprises so we can avoid a massive collapse of our small business sector.

Many “conspiracy theorists” also talk about a new quantum system in the future that will include GESARA which stands for Global Economic Stabilization & Reformation Act. GESARA proponents state it will bring back precious metals backed assets and a level playing field for all countries with currency revaluation and will include compensation to repay citizens for massive frauds with income tax and over-taxation. Sounds great but some wonder if GESARA is real or another magic trick by the elites to get everyone on CBDCs?

We also see that the BRICS nations (including Brazil, Russia, India, China and South Africa plus many more) have grown in strength and are considering a common gold backed currency which could topple the US fiat currency being used widely today. Soon more than 51% of the world’s population will be members as Argentina, Algeria, Iran, Indonesia, Saudi Arabia, Turkey, Egypt and Afghanistan have applied (and will likely be accepted) as members. How will their new financial system impact the old one? Is the petrodollar on its last legs?

Despite the many financial challenges ahead, I am long term optimistic about our future. It takes a big mess to wake up the masses and boy are we in store for a big mess. Time will reveal how the financial “reset” plays out.

Remember that your spending (and saving) can change the directions of our future so do not support globalist companies with your hard earned money. Every dollar counts in this war on our finances. I am confident that good things are ahead but can see very choppy waters ahead so prepare!!

How to Recognize Social Engineering, Propaganda, and Psychological Warfare

We are being subjected to intense social engineering via our governments, public health, news, entertainment and social media. Some have described this as 5th-generation warfare. The following is intended to assist you to identify propaganda and psychological manipulation in an effort to better protect yourself and your family from the effects of social engineering.

Acknowledge Your Vulnerability to Propaganda

We are all susceptible to propaganda. Those who think they are too smart to be manipulated are the most vulnerable. Be wary and constantly vigilant of efforts to manipulate you. We are in a psychological war where the goal is to control the minds and hearts of humanity.

We Are Being Manipulated Beyond Our Awareness

The advances in behavioural sciences have increased dramatically in recent years. People can and are being manipulated without their conscious awareness. Messaging developed by governments and corporations is carefully evaluated for its impact. There is extensive research behind the propaganda we face today. Those designing the messaging know what influences us, consciously and unconsciously. Their efforts to control us are intentional.

Influence, Not Information

This is an ‘influence’ war, not an ‘information’ war. The goal is not to inform us so that we can make better decisions, but rather influence our behaviour without our awareness such that we act in ways desired by those producing the propaganda.

Consider Information from Multiple Sources

In addition to any “official” government sources, people should consider other sources of information that are independent of government and corporate influence. Important sources of information are the voices of the censored, cancelled or shamed. Ask why we are not allowed to hear their perspective.

Numbers Can Lie

Be wary of statistics. Numbers don’t equal the truth. Data can easily be manufactured and manipulated. It’s important to understand how science has been corrupted and that statistics are used to deceive you.

Identify Conflicts of Interest

Ask who funds the research from “trusted” organizations such as the CDC, FDA, Health Canada, medical journals, and mainstream media. Identify conflicts of interest and ask why somebody is promoting an issue or product. Notice how many television programs today are sponsored by Pfizer. What is the impact when Bill Gates is the largest funder of the World Health Organization? There is little true philanthropy by governments and big corporations. They expect a return

on their investment.

Be Skeptical of Group Think

Employ healthy skepticism towards messaging such as “do the right thing” or “greater good” — messaging that insists everyone think and act a certain way. Be wary of messages that are promoted in unison. This is not a coincidence. These messages are scripted, intentional and coordinated.

Does The Messaging Evoke Strong Emotions?

Behavioural scientists have long known that fear makes people compliant with authority. As such, fear is an indispensable social engineering tool. Fear-based emotions shut down our ability to think critically, which is exactly what they want. Be wary of propaganda that has the effect of creating division. If you feel fear, shame or guilt, it’s likely propaganda.

Check the Fact Checkers

Just because they are called ‘fact checkers’ doesn’t mean they are acting honestly, independently, responsibly, are qualified, or are correct. Most fact-checkers are employed by organizations wanting to control your behaviour.

Turn OFF the TV

The television is effectively a programming device. Broadcasters are in the business of selling products and ideas. Be wary of all forms of mainstream media including news, entertainment and education programs. They are tools of propaganda, not truth. Their goal is to influence you, not educate you.

Don’t Be Too Agreeable

Most people are agreeable and want to get along with others. Those involved in propaganda use our good nature against us. They use our concern for others as a way to manipulate us. We saw this with the campaign that declared — “We are all in this together”. They also want us to think that everyone thinks a certain way, and that we should all think the same. Be wary of efforts to use your good nature against you.

Think for Yourself

There is a saying that warns: “If you don’t think for yourself, someone will do it for you.” Be wary of those who want you to take the advice of another rather than decide for yourself. The medical industry has been very successful with its “Ask your doctor” and “Trust the science” campaigns. Ultimately it is your responsibility to gather information and utilize your common sense and critical thinking skills. It is you, not the government or media, who will experience the consequences of your decisions. Life is too important to allow others to think for us. It is your responsibility to keep yourself safe and healthy; no one, including the government, can do that for you. Be wary of those who want to erode or deny personal responsibility and instead have you blindly follow the advice of others.

The Threat of Censorship

The reality is that our access to honest and unbi-

ased information is under threat. We now live in an age where discussion mostly takes place online, and the Internet is directed by corporations that collaborate with governments and secret agencies to control what we can and can’t see. It is important to recognize that without the free exchange of opinions and access to information, democracy cannot thrive. Freedom of expression is the prerequisite for all other human rights. Therefore, our free democratic society is at stake, it is as simple as that.

Good News Tidbits

- **The entire Yukon Territory has now been truth-bombed with Druthers.** A freedom group fundraised to have a *Druthers* newspaper arrive to every deliverable address via *Druthers’* Neighborhood mail program.
- **The Court of Appeal for Saskatchewan has overturned a decision that would have allowed a divorced father to have his teenage daughter vaccinated for COVID-19 against her will.** The court said its decision was to save the child’s mental health as forced vaccination would be traumatic.
- In a groundbreaking decision, **NY State Supreme Court Judge Gerard Neri held that the COVID-19 vaccine mandate for healthcare workers is now “null, void, and of no effect.”**
- Congressman Roy, joined by several of his House colleagues, **introduced legislation to prohibit US funding for the World Health Organization.** The “No Taxpayer Funding for the World Health Organization Act” would prohibit the US from providing assessed or voluntary contributions to the WHO. Doctors have a duty to warn patients of any material risks associated with the treatment as well as ensuring their decisions are being made without undue coercion.”
- US Rep. Louie Gohmert **files a bill (HR 9366) to hold pharmaceutical companies liable for injuries caused by publicly mandated vaccines.** In the US, Canada, and many other developed nations, COVID-19 vaccine makers are shielded from liability.
- **A district judge has vindicated Texas cardiologist and outspoken COVID vaccine critic Dr. Peter McCullough, dismissing a \$1 million lawsuit** filed against him by his former employer Baylor Scott and White Health system. Our way Toward Peace, Order and Good Governance

Imagine yourself on some night in the not-so-distant future. As an engaged and informed citizen, you would have enrolled in a citizens’ committee operating in our newfound form of democracy. Tonight, you would be meeting with your fellow members to discuss some important issue in your community and create appropriate policy. Getting into your car and buckling your seatbelt, you would remember how, around the year 2023, your country had come dangerously close to sinking into a full-fledged tyranny under the control of what used to be called the World Economic Forum (WEF). The only form of democracy in Canada is **parliamentary democracy**. As the name states, only parliamentarians can use this type of democracy. These are the major reasons why we are now in a WEF-infiltrated Canada that wants nothing to do with your opinions and your preoccupations. In a parliamentary democracy, petitions, protests, and convoys have no legal value. Sadly, those are used to vilify the honest and concerned citizens who wished to stand up against corruption and injustice.

Canada and the UK have signed International Universal Human Rights Treaties. Isn’t it illegal for the Federal and Provincial Governments, and City Mayors to derogate from these legal treaties, even in times of emergency or war?

Siracusa Principles, namely, that any limitation of, or derogation from, rights obligations must be lawful, pursue a legitimate aim, be strictly necessary and proportionate, be non-discriminatory, of limited duration and subject to review.”

The fact is, only certain aspects of our rights can be derogated from, and only for very short periods of time. Yet our government and Justices have been stealing our rights since 1982, and before, by not following the *Rule of Law*.

So why are they getting away with it?

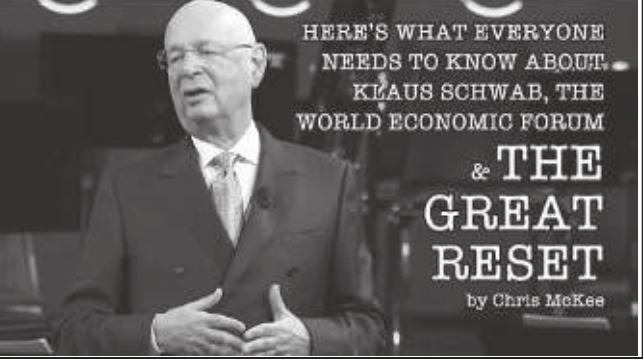

Midazolam Murders

Were the elderly in Long Term Care homes killed with euthanasia drugs and labeled as COVID-19 deaths?

COVID-19 deaths in Long-Term Care homes in 2020:

The official narrative is that the elderly in Long Term Care homes were at high risk for COVID-19 infection and death. In 2020, most COVID-19 deaths occurred in Long Term Care homes.

New evidence strongly suggests that these were not unavoidable COVID-19 deaths, but that something much more sinister and dark happened in these homes. There were at least two types of intentional harm that the elderly faced:

Vulnerable elderly were given a high dose “euthanasia drug cocktail” of Midazolam and Morphine which lead to their death, which was then labeled a “COVID-19 death”

Elderly who developed pneumonia were intentionally denied antibiotics, leading to their death, which was then labeled a “COVID-19 death”.

Midazolam

Midazolam is a benzodiazepine medication used for anesthesia, procedural sedation and to treat severe agitation.

“Midazolam injection may cause serious or life-threatening breathing problems such as shallow, slowed, or temporarily stopped breathing that may lead to permanent brain injury or death.” (medlineplus.gov/druginfo/meds/a609014.html)

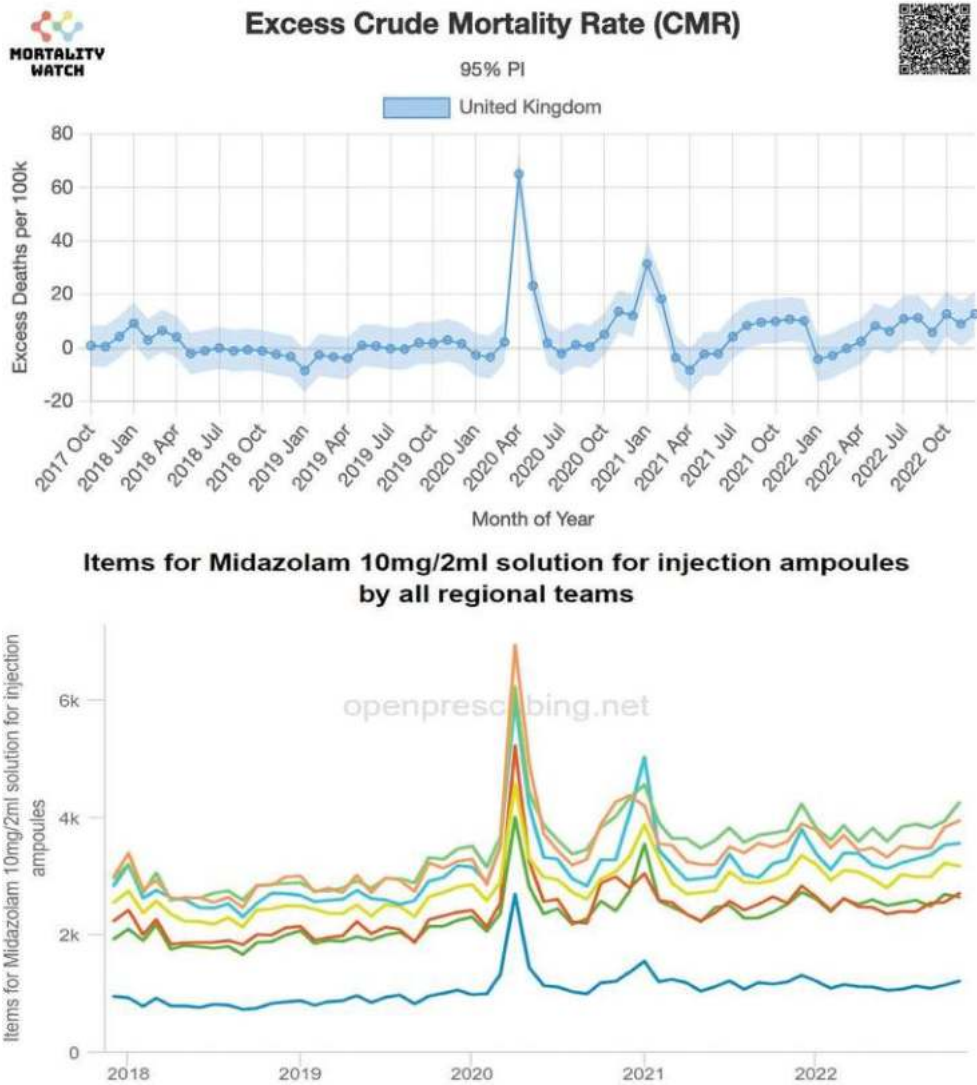

The Monster in the Basement

US Department of Defense Exposed as Central Crime Protagonist

It appears agencies such as the FDA, CDC, WHO, etc. and directors such as Dr. Anthony Fauci have only pretended — *play acted*, really — to operate as oversight organizations and regulators.

The documentary evidence was produced and released by three female researchers: Long-time pharma industry professional Sasha Latypova — who’s affiliated with research group Team Enigma — and her colleague Katherine Watt — an independent paralegal who publishes her discoveries on *The Bailiwick* substack — plus pharmaceutical patent expert Karen Kingston.

The details were released to the public over the winter of 2022-2023 via these researchers’ websites and interviews on alternative media programs, including the Dr. Jane Ruby show and Australian indie broadcaster Maria Zeee’s program (among others). Dr. Jane Ruby framed

the situation best when she recalled the plot of an old film in which a couple of teenage girls make prank calls to their neighbours while their parents are away. The girls begin receiving prank calls themselves from someone who makes terrifying threats. The girls contact the police, who then monitor the phone line. The film hinges on a plot twist: the police call the girls to urge them to flee the residence. They’re told (to their horror) that the threatening calls are coming from *inside the house*.

Ruby felt like those girls when she learned the military of her own country has been the monster in the basement



all along, not some foreign actor. Even intellectual Naomi Wolf has until recently pointed the finger at China and the CCP as the mastermind of the virus narrative and mass injection program. As I suggested in my article “THEY” – *Who Exactly Is Behind The Psyops?* (Druthers, June 2021 edition), the current corporate *coup d’état* and depopulation program is being coordinated via a network of shadowy intelligence agencies and secret societies, whose ultimate puppet masters are a cabal of ultra-rich families and individuals that former MI6 agent Dr. John Coleman described in his book *Conspirators Hierarchy: The Story of the Committee of 300*. Since that article, questions have remained about the roles of agencies such as the CIA, and nation-states such as China and Russia. Whoever is at the tip-top of the pyramid certainly went to great lengths to direct us toward the viral labs in Wuhan and Chapel Hill, North Carolina, and bad actors like Dr. Anthony Fauci and his gain-of-function research there and in Ukraine. The injection program skipped important safety studies, and most recipients didn’t know (and therefore did not receive *informed consent*) that the drugs were in Stage Three trials. The most common effects include myocarditis and other heart ailments, strokes, clots, and cancer, plus all kinds of neurological disorders. Canadian pathologist Roger Hodgkinson says at least 20 million souls have perished worldwide, so far, directly from these injections, including children (both pre and post-natal) and pregnant women.

Many aspects of the apparent DoDs’ coordinated attack remain uncertain. Microscopy from labs such as La Quinta Columna shows the presence of graphene oxide and self-assembling nanotech (that increases in the presence of EMF radiation). Others claim spike protein is causing the sort of damage that’s led so many athletes to collapse on the field. US attorney Todd Callender points to the presence of Caesium 137 in the shots (a potent toxin that may set an atomic “clock” for the complex processes of the technology). Certainly — as the film *Died Suddenly* revealed — enormous clots (containing metals and not made from blood) are being pulled from cadavers, possibly presaging a tsunami of illness and death among injected people. And it now appears something is transfecting from the injected to the non-injected. Is the bioweapon self-spreading? It appears so.

However these details are resolved, the system is undoubtedly about surveillance and control — and possibly population reduction — and not health protection. Unfortunately, a dispute erupted between Kingston (with support from broadcaster Stew Peters) and the Latypova-Watt team. Kingston accused Latypova of saying there’s no point prosecuting Pfizer, because of the DoD protection. Latypova responded that she believes it’s still worth pursuing the drug companies in court, but that the secret contracts make them suppliers to the true culprit — the DoD and other federal agencies — which is far more difficult to take on.

Whatever more is discovered, we must understand the core revelation from these researchers, which is that the US government (and likely those of the Five Eyes nations) was infiltrated and taken decades ago. Appeals to politicians and bureaucrats are likely worthless, and our salvation now resides with We the People. And prayer.

We are the white hats. We are the saviours we’ve been waiting for.

Pay Attention to Local Land Use Bylaws: Check With Your Municipal Council

Implore you all to IMMEDIATELY familiarize yourself with your local Land Use Bylaw. Also, pay attention to whether it has been updated recently or is in the process of being updated. Keep reading to find out why!

I reside in Thorhild County. Thorhild county, North East of Edmonton, is a small municipality that is more than 99% rural by land use. There isn't even one town in our county, but there are 7 hamlets ranging in population from 24 to 391 people. In fact, in our entire county of 1997.17 km², the total population is only 3,042 people.

Currently, we are fighting a proposed Land Use Bylaw (LUB) complete rewrite. A company called Green Space Alliance Urban Planning Firm (GSA) was contracted at a price of \$100k to do the rewrite. They have an office in Edmonton but are based out of India and their specialty is large urban centres (Mumbai, for example). The rewrite they did for our county is deplorable, excessively punitive, and very clearly not designed for rural communities, but rather more strongly patterning large urban center templates.

I will say the county did the bare minimum of their due diligence to make people aware of this incoming change through advertising on their FB, Twitter, website, and in local newsprint. However, a quick glance at their social media shows that their engagement is embarrassingly low. They should have realized at some point that the information was not being received. In fact, when GSA sent surveys out, only 61 people participated. Does that sound like adequate participation numbers to confidently say you have satisfactorily engaged the public in the process? I would say not.

At any rate, not to pat myself on the back, but had it not been for me one morning sitting down with a coffee to read this bylaw (about one week prior to the Public Hearing) and rapidly hopping on social media to sound the alarm, I am quite certain this bylaw would have been passed, without contest, on January 10. I began an aggressive social media campaign to ensure as many of my community members were aware of the dangers if this bylaw were to pass, and the movement took on a life of its own! Prior to that, literally NO ONE was talking about it.

We had 47 people show up to the Public Hearing, ten of whom gave impassioned presentations about all the ways this by-law would affect them, and the whole community, negatively. The council had no choice but to put forth a motion to take more time to go through the information provided in the presentations. They have not given us a timeline as to when they will revisit this.

We (a group of us concerned citizens) booked a community hall and had a staggering 193 people attend where they were presented with what we know so far about what our legal options are for interceding in this LUB process. It was pretty incredible.

I believe there is a province-wide campaign for Alberta municipalities (perhaps even nationally?) to update their land use by-laws right now. This is no mistake. I believe this is NWO driven. I hope to somehow bring awareness to what's going on here but NO MEDIA outlets will provide us any kind of coverage or support whatsoever. I would love if we are able to bring some attention to this provincially, maybe even nationally (that's too much to hope for.) and IF we are successful in staving off this assault on our liberties, to make it VIRAL and help other municipalities stop the local abuses of power that are working to prevent us from living freely, providing our own food security etc. — you know, ALL the things they want to use to control us!!

Highlights of how this impacts us:

Like I mentioned, we are a predominantly rural community. Less than 1% of our total land use is rural/agricultural, while by population, we are approximately 72% rural/agricultural, so approximately only 28% of the County's population lives in the hamlets mentioned. Despite this, the proposed LUB includes the following

regulations which are just a few examples of the atrocities contained therein:

- ALL zones will require a permit for barbed wire fencing (in a farming community!)
- ALL zones are subject to a sister bylaw titled the

maximum of four — and if you know anything about farming, this is beyond ridiculous!

Also for any buildings that have not been used in six months, you will be required to apply for a new permit to use them. So, if your grain crop is not good and you only use half your grain storage, those unused grain storage buildings become instantly illegal and a new permit must be applied for.

Country residential areas are limited to ten shrubs that must be a 50/50 mix of coniferous/deciduous shrubs, as well as have only 2 coniferous TREES and 2 deciduous TREES. Certainly if you live in the city, this may not seem offside. But if you live in the country where your nearest neighbor is literally miles away, you can see how ridiculous this is!

There are more than 100 instances where it states that permits will be issued "at the discretion of" "based on the opinion of" etc... Extremely subjective.

I could go on and on... ..

THE MOST INSIDIOUS PART is that it's 100% RETROACTIVE! So even if you are in compliance with the existing LUB, once the new one comes into effect, the new one applies — and you will be subject to

daily fines for non-compliance!!!

We have been in contact with Municipal Affairs who have provided us with some limited guidance. They have no authority or jurisdiction to intercede however.

I fully believe our situation up here in Thorhild County is in no way isolated, and I would **strongly** suggest that each and every one of you become intimately familiar with your own LUB.

For anything you find issue with, **immediately** send an email to the councillor for your division, and cc the CAO at minimum. It would not be offside to cc every councillor and anyone else on your administration payroll.

"Urban Hen Bylaw" which, in it's current state (though not yet passed) limits you to have a minimum of 2 and a maximum of 4 laying hens. In order to secure a permit to possess these hens you must be a landowner, take an approved Hen Care course, apply for a parcel identification or PID number, apply for a permit, secure a written letter of consent of every neighbor who has property adjoining yours — in a county where farmers have hundreds of farmed acres, provide the Land Title certificate to your home secured no more than 14 days prior to your application — which is impossible given how backed up they are....I've been waiting 11 months, adhere to strict regulations on the size, design, placement of your "hen enclosure", have the enclosure inspected and pass inspection prior to use, and agree to the county requirement that an inspector/peace officer can enter your premises at any time without a warrant to inspect, as a condition of your license. Again, this is written in a Land Use Bylaw in a county that is 99% rural/agricultural by land!

In addition to that nonsense there is now a limit on the number of "accessory" buildings you can have — a

New BC Law Gags Healthcare Workers

The new *Health Professions and Occupations Act* of British Columbia (HPOA) mimics the new law that was passed in California on January 1 this year, in

attempting to gag doctors and to punish them for expressing opinions contrary to those that the government approves. However, while the California law targeted physicians and surgeons, the HPOA casts the net much wider. It may also affect nurses, physiotherapists, massage therapists, acupuncturists, naturopaths, chiropractors, and other health practitioners.

The HPOA was tabled on October 19, 2022, by NDP Health Minister Adrian Dix as Bill 36. It was then pushed through with little opportunity for discussion and became law in British Columbia on November 24, 2022.

The HPOA contains new provisions that can only

be described as Orwellian. It gives the Health Minister power to appoint College Boards, which then:

(1) must impose vaccination requirements on all health practitioners under their authority, for any illness the government deems necessary.

(2) must impose proof of up-to-date vaccination status as a condition of licensing.

(3) must dismiss, without notice or a hearing, any application for licensing or renewal of license that does not contain proof of vaccination.

(4) if any health worker dissents (speaks out against College policies or fails to comply), may be disciplined with loss of license.

(5) if an individual is deemed to have made a false or misleading statement (as determined by the government), may without notice to the person affected, apply for court orders to:



A Personal Declaration Of Truth

It was May 19, 2006, Kandahar Afghanistan. As the aircraft captain that day, I stood at attention beside the ramp of my C130 transport. The sun was rising behind eight stone-faced members of Captain Nichola Goddard’s artillery platoon as they walked slowly toward me, shouldering the casket containing her body for her long journey home to rest, in Canada. Only hours before, she and these same men had been in a ferocious firefight, when the shrapnel from a rocket-propelled grenade pierced her skull, ending her 26 yr old life.

I saluted as they walked up the ramp and watched them come undone emotionally, as they gently set her down. Their final goodbyes complete, they returned to stand with the thousands of other soldiers on the tarmac, there to honour her departure. These men would soon be back ‘outside the wire’ in harm’s way. They would not get a long break to reflect and recover. There was work to be done.

A young soldier from Capt Goddard’s platoon accompanied her home, and he sat with us in the flight deck on that first leg back to our air base in the Emirates. We spoke briefly. Quiet, respectful, he said little, likely suffering the initial onset of what we used to call shell shock.

The mission was concurrently surreal, poignant, and emotional. It was the greatest honour of my 32-year military career.

Mission complete and back in camp, I was at the dining hall in camp that same night, still somewhat reeling from the experience. Several fellow military members nearby began complaining loudly that the trolley of Hagen Daaz ice cream (wheeled around the hall for their benefit) was pathetically short of appealing choices.

That’s the abrupt end of my ‘war story’, but why do I relate it? Because the contrast between the morning in Kandahar and dinner in camp reminds me of a troubling disconnect in our nation.

Capt Goddard and her men were fully invested in the battle, up to and including giving their lives for the cause. Others, on the very same mission, were living largely sheltered from what was at stake.

Today only a small element of society grasps the seriousness of our national situation. Liberty is under attack. The enemy of our God-given freedoms is at the gates. When thieves begin beating down the door, there is no neutral ground. You’re either engaged in fighting them off or you’re cowering, enabling the looting.

Comfort, convenience, and safety cannot be priorities, yet it seems at times we have a desperate grip on the benefits of simpler times while saying just enough to *appear* engaged. But speaking (or posting online) will never be enough. In the words of Viktor Frankl, “Our answer must consist, not in talk and meditation, but in

right action and in right conduct.”

My Christian faith undergirds all of my convictions and a Bible passage jumped off the page to me last year, speaking of Moses’ choosing to leave the relative privilege and ease of Egypt to lead the wandering Israelites through decades of suffering.

Hebrews 11:24-29 “By faith Moses, when he was



grown up, refused to be called the son of Pharaoh’s daughter, choosing rather to be mistreated with the people of God than to enjoy the fleeting pleasures of sin. He considered the reproach of Christ greater wealth than the treasures of Egypt, for he was looking to the reward. By faith he left Egypt, not being afraid of the king, for he endured as seeing him who is invisible.”

2023 Canada: We need leaders who will fix their eyes resolutely forward, just as Moses did. Forward to a nation where our grandkids do not live under dark authoritarian rule; forward to a nation and time where autonomy, the ability to freely worship, to speak our minds openly once again thrive, unfettered; forward to the abject defeat of statists, globalists and the budding totalitarians seeking to steal our futures.

We’re inundated with pronouncements on how dire the situation is, but what are we supposed to do? Well, like Moses, Solzhenitsyn, or Bonhoeffer, we embrace a sold-out, unrelenting commitment to truth. Make no mistake, we’re at a historic crossroads. Now is the time to count the cost.

I’ve wrestled with these thoughts for months and out

of that penned a personal declaration. I humbly challenge you to consider it as a call on our collective lives:

* I will wholeheartedly pursue truth and will not speak, sign, or write anything that is not, as far as I know, the truth;

* I will not repeat nor support radically progressive, ideological mantras. I will walk out of state, corporate or privately enforced indoctrination on the same;

* I will never acquiesce to the state’s violation of my God-given freedoms of speech, worship, conscience and bodily autonomy;

* I will persevere in the face of threats to livelihood, status or reputation, in spite of the pain or my own self-doubt;

* I will support with my words, actions and finances, others convicted of this need for a relentless commitment to truth and conscience.

All this I undertake, accepting that I may suffer the loss of social status, comfort, and ‘safety’. I am willing to do so, in exchange for the far superior and lasting bedrock of truth upon which our futures and freedom (and that of our children) must be grounded.

Many ask, “when will things improve?” From my view, when enough Canadians prioritize this battle over their own comfort, safety and convenience. A small tipping point of society can change the course of history - but

not without personal sacrifice.

These past years we’ve had ribbons to wear, signs to carry, rallies to attend and memes to post. I’ve done all of the above and they all have a place. But they will never effect change on their own. That will only come through individual (sometimes agonizing) moments of personal responsibility, where we determine what’s right and then courageously act upon it, day after day after day.

May God give each of us that courage and the wisdom we need for the challenging year and years ahead.

- enter into premises to search, seize, or copy property [section 506],
- lock up premises and prevent an owner from entering [section 511],
- fine healthcare workers up to \$200,000 for non-compliance [section 518(1) a-c], and
- order jail time up to two years, in addition to a fine [section 518(1) a-c].

Corporations are subject to stiffer penalties, including fines of up to \$500,000. In addition, directors may be fined up to \$200,000 or be sentenced to up to two years in jail, or both [section 518(2) a-b].

By this new law, the BC government encroaches upon the professional autonomy of healthcare workers and their governing bodies. It also removes hitherto protected rights of bodily autonomy for the workers. It also threatens their livelihood if they, for any number of valid reasons, believe they should not or cannot comply with government dictates.

All this destroys proper democratic functioning. Further, since healthcare workers can be fined or imprisoned for providing information or advice that the govern-

ment deems misleading, the government is now, in effect, the people’s doctor through coercion: only its opinion is allowed. Further, patients are effectively barred from seeking a second opinion concerning “taboo” topics.

The chief taboo topic on the government’s agenda will no doubt, at least in the short term, be Covid vaccines. While information pointing to their risks is withheld from the public by a silent media, along with studies from all over the world that highlight serious concerns, now healthcare workers will also be obliged to keep silent or lose their livelihood, face stiff fines, or suffer imprisonment.

Finally, the HPOA threatens to harm the public by creating further service shortages. The BC healthcare system is already struggling with chronic staffing shortages, due in part to the firing or retirement of health workers under Covid vaccine mandates. These harsh new measures could only worsen the situation if more practitioners choose to retire, or move to provinces where their rights are protected.

Whatever Happened to Pfizer’s Covid Vaccine Trial in Pregnant Women?

The trial began in 2021. But over a year after the last woman was enrolled, the company just admitted it still doesn’t have the data

When covid-19 vaccines were granted emergency use authorization in Dec 2020, there was consternation over whether pregnant women should be vaccinated. Pregnant and breastfeeding women were excluded from the original Pfizer and Moderna phase III clinical trials, so any recommendation to vaccinate them was a gamble.

The world was dealing with a novel vaccine technology, tested under ‘warp speed’ conditions, and no long-term safety data to speak of.

For this reason, the WHO did not widely recommend the covid-19 vaccine during pregnancy because of insufficient safety data. But not everyone agreed.

In January 2021, soon after the vaccine roll-out commenced, US Centers for Disease Control and Prevention (CDC) updated its website saying that the mRNA vaccines were “unlikely to pose a specific risk for people who are pregnant.”

Professional societies such as the American College of Obstetricians and Gynecologists (ACOG) and the Society for Maternal-Fetal Medicine (SMFM) both advised that covid-19 vaccines not be withheld from pregnant or lactating women.

Similarly, the UK’s Royal College of Obstetricians and Gynaecologists (RCOG) released a statement saying that “COVID-19 vaccines are strongly recommended in pregnancy.”

So, as the months passed, hundreds of thousands of pregnant women globally, rolled up their sleeves to receive the vaccine, despite the absence of any clinical trials.

The message from authorities was clear — the harm from covid-19 infection outweighed any harms from the mRNA vaccine — but in truth, they couldn’t possibly have known.

Animal studies

Pfizer’s official product labelling information for pregnant women refers only to animal studies, stating “No vaccine-related adverse effects on female fertility, fetal development, or postnatal development were reported”.

But a freedom of information (FOI) request to the Australian drug regulator in June 2021, shows the study was only carried out in 44 rats (22 injected with 30µg of mRNA vaccine, 22 injected with saline).

The study found the vaccine led to a statistically significant doubling in fetal loss (9.77% mRNA vs 4.09% saline), but Pfizer concluded that the difference between the two groups was “not biologically meaningful.”

The label also states that Pfizer’s mRNA vaccine was not tested for its potential to cause carcinogenicity (ability to cause cancer), genotoxicity (ability to damage genetic information), or impairment of male fertility.

Unlike Pfizer, Moderna kept its pregnant rodents alive to test the embryos. Documents accessed by Judicial Watch, showed a “statistically significant” number of rats were born with skeletal variations after being injected with Moderna’s mRNA vaccine.

But Moderna concluded that the “Skeletal variations are structural changes that do not impact development

or function of a developing embryo” and therefore “not considered adverse.”

Human trials

In the absence of any human data, Pfizer announced it would begin recruiting volunteers for a clinical trial to examine the safety and efficacy of its mRNA vaccine in pregnant women and their newborns.

The trial, which began in Feb 2021, originally intend-

ed to enroll 4,000 women, but enrollment stopped in late 2021 with just 349 participants. There has been no explanation for why they stopped recruiting participants, nor have the data been published in a conference abstract, preprint or medical journal. It has been over a year since the last woman was enrolled in the trial, and all of them would have given birth by now.

Recently, Marty Makary, a public policy researcher at Johns Hopkins University, objected to the secrecy. “They should say something. They have a moral duty to speak up. Here we are 18 months later, the results of those 349 women have never been made public,” said Makary. “They just recommended it for pregnant women with zero data. And maybe that’s why [Pfizer] stopped the study ... running a study runs the risk of showing that there may not be a benefit in pregnant women,” he added.

Declining enrollments meant that there were insufficient numbers of participants in the trial to carry out the intended analysis.

Pfizer’s full response:

In the fourth quarter of 2021, enrollment was stopped in C4591015 Study (a Phase 2/3 placebo controlled randomized observer-blind study to evaluate the safety, tolerability, and immunogenicity of BNT162b2 against COVID-19 in healthy pregnant women 18 years of age and older). This study was developed prior to availability or recommendation for COVID-19 vaccination in pregnant women. The environment changed during 2021

and by September 2021, COVID-19 vaccines were recommended by applicable recommending bodies (e.g., ACIP in the U.S.) for pregnant women in all participating/planned countries, and as a result the enrollment rate declined significantly. With the declining enrollment, the study had insufficient sample size to assess the primary immunogenicity objective and continuation of this placebo controlled study could no longer be justified due to global recommendations. This proposal was shared with and agreed to by FDA and EMA.

Pfizer does not yet have a complete data set from the maternal immunization study, C4591015. Pfizer and BioNTech plan to complete the analysis of the clinical trial C4591015 and share it with global public health regulators and seek publication or presentation as is our standard practice. It is important to note that relevant real-world evidence on the use of COVID-19 vaccines in pregnant women has been presented and published numerous times by various parties in multiple journals and forums.

The FDA said it does not comment on ongoing studies. TGA FOI 2389 and 2289

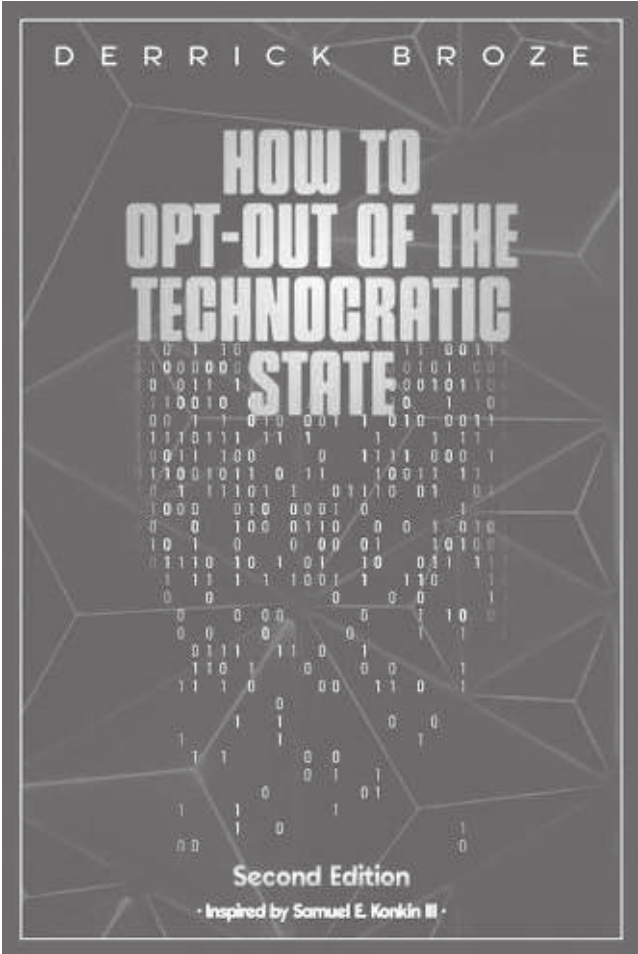

Some Of The Most Absurd Things That Have Happened In Recent Weeks

- **Government finds government not guilty of government overreach.** The Public Order Emergency Commission inquiry concluded that Trudeau was “justified” in his decision to invoke the Emergencies Act and freeze protesters’ bank accounts.
- **Roald Dahl’s children’s books have been rewritten to remove language deemed “offensive”** by the publisher Puffin. The word “fat,” for example, has been cut from every new edition of relevant books. Gender-neutral terms have been added in places — *Charlie and the Chocolate Factory*’s Oompa Loompas are now “small people” instead of “small men.”
- **UK’s counterterrorism program says interest in great literature is a sign of far-right extremism.** The taxpayer-funded research noted that the works of William Shakespeare are “key texts” for “white nationalists/supremacists.” Other works of fiction that were flagged include *The Lord of the Rings* by JR Tolkien and George Orwell’s *1984*.
- **Tim Hortons collected your data without consent, so you can now claim a free coffee and donut.** This is the result of a 2022 class-action lawsuit settlement after a 2020 joint investigation between the federal privacy commissioner and provincial counterparts found that Tim Hortons had sold the geolocation data of its app users.
- When asking Google “can men menstruate?” Google’s new answer is: “Having a period is not a feminine thing, and **people of all genders menstruate**, including non-binary people, agender people and even plenty of men! Menstruation doesn’t change anything about your gender, it’s just a thing that some bodies do.”
- The FAA just telegraphed the fact that a substantial number of airline pilots have had serious heart damage after the vaccine roll-out by widening the EKG parameters for pilots. On October 24, 2022, the FAA Guide for Aviation Medical Examiners quietly widened the EKG parameters for pilots beyond the normal range. The PR (a measure of heart function) was changed, for the first time ever, from a max of 200 msec to 300 msec. This is a very wide range that accommodates people who have cardiac injury.
- A study by the Cleveland Clinic of over 51,000 participants finds that the more shots you get, the greater the risk of COVID infection. All participants were working-age employees of the hospital.
- Health authorities in Victoria, Australia have denied a mother of two a heart transplant for being “unvaccinated.” She did not receive the vaccine because she relies on a ventricular assist device to help keep her ailing heart functioning and is concerned that taking the vaccines could increase her risk of heart conditions such as myocarditis or pericarditis.
- Due to a shortage of doctors (perhaps, in part, due to the firing of unvaccinated doctors) pharmacists across Ontario will soon be able to prescribe medications for 13 common ailments including: urinary tract infections, herpes, and pink eye.

- After the World Economic Forum 2023 in Davos, a new analysis commissioned by Greenpeace International revealed the ecological hypocrisy of its attendees. While the WEF claims to be committed to the 1.5°C Paris Climate Target, its attendees (consisting of lobbyists, corporate bosses, and political leaders) arrive in droves of private jets. The research, conducted by Dutch environmental consultancy CE Delft, found that last year’s **World Economic Forum saw over 500 private jet flights arrive with meeting attendees.** 53% were short-haul flights below 750 km that could have easily been train trips, with 38% flying ultra-short distances of under 500 km. The shortest flight recorded was only 21 km (about a 23-minute car ride, or one-hour bike ride).

- Oxfam’s “Survival of the Richest” report finds that **the richest 1% grabbed nearly two-thirds of all new wealth (worth \$42 trillion) since 2020.** This is a huge increase compared to before the pandemic, when the richest 1% soaked up 50% of all new wealth created. The report also found that 95 food and energy corporations more than doubled their profits in 2022. Additionally, 95% of countries froze or cut taxes on corporations during the pandemic. The report concluded that excess corporate profits have driven at least half of inflation in Australia, the UK, and the US.
- In a must-watch viral video now banned from YouTube and Facebook, Project Veritas catches the Director of Research at Pfizer on a hidden camera revealing that **Pfizer is exploring manipulating COVID through “directed evolution” to make it “more potent” by infecting monkeys.** This helps them predict what future variants might appear so they can have customized shots sitting on the shelf, ready to disseminate to the public. This directed evolution of a pathogenic virus has the potential to unleash a genuine ‘monster virus’ and is a form of gain-of-function research that is

- prohibited in the US.
- The Ontario **Court of Appeal has overturned the decision made last year that allowed a separated mother to not vaccinate her children,** claiming “misinformation” was brought into the courtroom. The appeal court Justice Jonathon George has now given the decision-making authority to the father, who plans on vaccinating the two children.
 - **Before the Feb. 6 Ohio train derailment that resulted in the “controlled burn” of a plume of highly toxic chemicals, Norfolk Southern lobbied against safety rules.** Railroads spend heavily while lobbying in Washington, according to records analyzed by the transparency organization Open Secrets. Norfolk Southern is among the biggest spenders, paying \$1.8 million last year for the services of 36 lobbyists. On February 6, hazardous chemicals used to make PVC plastics were burned off the derailed freight train contaminating the soil and water which resulted in thousands of fish and other animals dying, ill effects, and an increased risk of cancer for people living in the area. During the 2022 “Surface Transportation Hearing on Urgent Issues in Freight and Rail Services” the President of the Transportation Trades Department stated that in an effort to raise their profits, class one freight trains “have collectively shrank their workforce by 29% over the last 6 years.”
 - **FDA quietly extended the end date for the Pfizer study on heart inflammation after COVID vaccination in 16-30-year-olds by AN ENTIRE YEAR** (despite Pfizer needing only a few months to develop, complete their study, and release the COVID vaccine back in 2020). Study 4591031 would be the only randomized controlled study on mRNA vaccine-induced myopericarditis and was supposed to be completed in June and published in December 2022. This isn’t the first time Pfizer has done this. Their first-ever study on the vaccine in pregnant women was completed in July 2022 but they have yet to release that study and data as well.
 - A new Study titled: “Limitations of the Food Compass Nutrient Profiling System” (*Ortenzi et al.*) studied the Food Compass (the nutrient profiling system is often touted by nutritionists as the most comprehensive science-based system to date) and found **“the chosen algorithm is not well justified and produces results that fail to discriminate for common shortfall nutrients, exaggerate the risks associated with animal-source foods, and underestimate the risks associated with ultra-processed foods. We caution against the use of Food Compass”** On a scale of 1-100 (with 100 being the healthiest) Frosted Mini Wheats was given an 87, frozen yogurt 80, lucky charms 60, boiled eggs and canned pineapples 51, ground beef 26. These results are not surprising given the level of regulatory capture going on in the food industry. Last year, a study by Cambridge University titled *Conflicts of interest for members of the 2020 Dietary Guidelines Advisory Committee* (Mialon et al.) found that **95% of the committee members had conflicts of interest with food and/or pharmaceutical companies.**
