# An Open Letter to the Senators and Parliamentarians of Canada

## Regarding Bill-C 11 and the Siracusa Principles (revised edition)

Dear Senators and Parliamentarians,  
We, the Canadian Peoples' Union NFP (C.P.U.) – represent Canadian citizens and Indigenous Peoples throughout Canada. We are requesting your help to ensure that our civil and political rights above our government, as well as yours, are properly respected. With the imminent approval of Bill C-11, the Notwithstanding Clause (article 33) as well as Province of Ontario Bill-3, these rights can, once more, go unaddressed by our governments.

With your dutiful collaboration as our representatives, we are asking you to declare Bill C-11 unconstitutional in its entirety. The government cannot deny us any of our rights as specified in the *Siracusa Principles*, which include **non-derogation** of “**freedom of expression**” as stated by the United Nations subcommittee of which the Canadian government and the Quebec Government are very aware of. The subcommittee further commented on the Notwithstanding Clause (article 33):

Fact: Québec Premier Bourassa passed Bill 178, which included the notwithstanding clause to restrict the use of commercial signs in languages other than French. After the new law was criticized by the United Nations Human Rights Committee, the Premier had the National Assembly rewrite the law so that it conforms to the Charter. The notwithstanding clause was removed.

To continue to ignore these facts and the RULE OF LAW indicates that those who write our laws, including those who approve them without the knowledge of the *Siracusa Principles*, or instill them even though they are aware of them, create an injustice to all Canadians and Indigenous Peoples of Canada, especially to those worldwide who fought for these rights during and after WWII.

These are the very principles our laws and human, civil and political rights were created for. They also complete the foundation of the Rule of Law. Anything else is a rule *by* law, which is contradictory to the very cornerstone of this country.

The responsibility to respect International Laws and universal rights, such as the *United Nations Universal Declaration of Human Rights* as well as the *International Covenant on Civil and Political Rights* 1966 which Canada and the U.K. have signed in 1976, falls upon both the U.K. and the Canadian Parliaments. In addition, the Courts *must* uphold both the Constitution and the International Laws under the Rule of Law Principles (principles that protect the people from governments that create seemingly arbitrary laws that are neither based on the Rule of Law, nor on protecting the people). Instead, by not honoring the citizens' collective rights, Canada has been ruling BY law since 1982.

A request for an official constitutional correction placing the collective people in our rightful place was addressed to the United Kingdom by the C.P.U. in March 2022; unfortunately, we received no response. On July 30, 2022, in Ottawa, the C.P.U. and its supporters stood up and activated our collective civil and political rights, which was another step in initiating a dialogue with the U.K. and the Canadian governments. Prior to 2022, the C.P.U. had also written to Minister of Justice David Lametti and various other officials hoping to shed light on the neglected state of democracy in Canada, including the disregarded non-derogation of the rights of our peoples during the pandemic; no response was received.

The deliberate malfasant advice given by Minister of Justice Mr. Lametti, and the legal stance of the Canadian government reflects a gross injustice perpetually committed against Canadian citizens and Indigenous Peoples, and to yourselves “our Senators and Parliamentarians”.

It does not matter which province you are from or rep-

resent; all Canadians are equal across the provinces and territories. No provincial or municipal government has the right to have different rules under these legislatures ignoring equality rights of all its peoples. The last 3 years could have been very different if our rights had not been omitted; the World Health Organization cannot override these rights any more than the Canadian Governance. These are serious breaches of international treaties and a complete disrespect of the peoples of our country.

It is crucial that these issues be addressed by all Parliamentarians, all Canadians, and all Indigenous Peoples of Canada. Furthermore, utilising “controlled” surveys or inviting favoured people to speak at inquiries without getting input from all sides of the situation does not and cannot show that Canadians want what the gov-



erning bodies do. More needs to be done before making such claims or applying unconstitutional laws.

You will find attached in PDF or paper format the *Siracusa Principles* which has been successfully used in courts of law and in Canada by our Justices when in conflict with the Canadian Government. These key principles are not included as part of the curriculum in law education in Canada. All lawyers and Canadians need to know about these principles as court challenge outcomes could have been different than what we have witnessed in the last 3 years and before; this includes the prevention of the use of the Emergency Measures by the Canadian Government, as they did, thus making the inquiry null and void.

The irony in all of this, is that Canada claims to be excellent in protecting the rights of Canadians, and our human rights agencies are there to make sure that Canada implements its obligations. From our research their statements are hypocritical.

Please refer to sections 30, 31 and 32 of the *Siracusa Principles* below:

30. National security cannot be invoked as a reason for imposing limitations to prevent merely local or relatively isolated threats to law and order.

31. National security cannot be used as a pretext for imposing vague or arbitrary limitations and may only be invoked when there exists adequate safeguards and effective remedies against abuse.

32. The systematic violation of human rights undermines true national security and may jeopardize international peace and security. A state responsible for such violation shall not invoke national security as a justification for measures aimed at suppressing opposition to such violation or at perpetrating repressive practices against its population.

States parties should not derogate from Covenant rights or rely on a derogation made when they are able to attain their public health or other public policy objectives by invoking the possibility to restrict certain rights, such as article 12 (freedom of movement), article 19 (freedom of expression) or article 21 (right to peaceful assembly), in conformity with the provisions for such restrictions set out in the Covenant, or by invoking the possibility of introducing reasonable limitations on certain rights, such as article 9 (right to personal liberty) and article 17 (right to privacy), in accordance with their provisions;

(d) States parties may not resort to emergency powers

or implement derogating measures in a manner that is discriminatory, or that violates other obligations that they have undertaken under international law, including under other international human rights treaties from which no derogation is allowed. Nor can States parties deviate from the non-derogable provisions of the Covenant – article 6 (right to life), article 7 (prohibition of torture or cruel, inhuman or degrading treatment or punishment, or of medical or scientific experimentation without consent), article 8, paragraphs 1 and 2 (prohibition of slavery, the slave trade and servitude), article 11 (prohibition of imprisonment because of inability to fulfil a contractual obligation), article 15 (principle of legality in the field of criminal law), article 16 (recognition of everyone as a person before the law) and article 18 (freedom of thought, conscience and religion) – or from other rights that are essential for upholding the non derogable rights found in the aforementioned provisions and for ensuring respect for the rule of law and the principle of legality even in times of public emergency, including the right of access to court, due process guarantees and the right of victims to obtain an effective remedy; see the attached pdf below Read more here: <https://www.ohchr.org/en/press-releases/2020/03/covid-19-states-should-not-abuse-emergency-measures-suppress-human-rights-un?LangID=E&NewsID=25722>

Furthermore, as stated by the Human Rights Committee, our rights are also protected online. No government can use laws to regulate our online access under freedom of expression. Nothing in law states that the government has the right to rule *over* the people. The government does not have this right, even if it thinks it does through the election process.

The Canadian Governments and Parliamentarians need their votes to reflect the **conscience of the people** when laws being passed affect them directly. This is why parliamentarians should not be allowed to vote as partisans on statutes and Acts but rather should vote their conscience in consideration of their fiduciary obligations to the people. It is obvious that during parliamentary votes, parliamentarians do not reflect taking into consideration the **right of conscience** of all Canadians since they must act according to their party's orders on how to vote. Bill C-11 and other bills like it, should not get drafted in the first place.

Our livelihood is in peril due to our governing bodies' decisions. Where is the justice in all of this? If we can't depend on our Senators and Parliamentarians to provide a “Sobering Second Thought” with the ability to veto what is unconstitutional, who can we depend on when so many breaches are being orchestrated?

Looking at the big picture of what Canada has become since 1982 given the RULE OF LAW and the concealment of the *Siracusa Principles* from lawyers and observing the Canadian Human Rights Tribunal along with the provincial agencies fraught with abuse and negligence of all of our rights; it is never too late to take positive action. You can all help make a huge difference by eliminating Bill C-11 and to further assist us in disallowing unconstitutional laws that derogate from our rights, and yours.

Appended is an excerpt of the forgotten *Universal Declaration of Human Rights* which are automatically embedded in our constitution under international Instruments that Pierre Elliot Trudeau and all Prime Ministers and Premiers since, have hidden from public knowledge. As well, the *Siracusa Principles* are attached for your perusal so that the Canadian Government, Parliament, Provincial and Municipal legislatures can no longer ignore it.

# The Covid Trojan Horse


Remember, July of 2001 was only two months ahead of 9/11

# Myocarditis in Kids Under 18, Cases Up by Over 100 Times in Canada

**Large Canadian hospital: before COVID, they'd see 2 cases per year. Now they see 27 in just 6 weeks. That's a 117 Times increase. But the CDC says it's only "slightly elevated."**

COVID-19 could lead to heart damage in children. The IWK Health Centre is a major pediatric hospital and trauma center in Halifax, Nova Scotia that provides care to maritime youth, children and women from Nova Scotia, New Brunswick, Prince Edward Island and beyond.

They've seen 27 myocarditis cases in a 6 week period for kids under 18. Normally, they see 2 cases a year. So they are seeing an increase of 117 times the normal rate.

I heard this from a hospital insider. Don't expect them to publicly say anything. That's just not the way it works nowadays.

Since the baseline rate of myocarditis in kids is 1 per 100,000, this suggests that we are seeing 1 per 1,000 vaccinated kids getting myocarditis and it's probably even more than that especially since a Thailand study showed almost 30% of kids sustain cardiac injury of some sort from the vaccines. Since there are nearly 80 million kids under 18 in the US, if all of them got vaccinated, we'd expect to see 80,000 kids with myocarditis which is always very serious.



# What is Happening in the Skies Above Manitoulin Island?

For years now, persistent lasting contrails have marked the skies above us. What is happening?

According to Oxford University, geoengineering is the deliberate large-scale intervention in the Earth's natural systems to counteract climate change. # Safety Third

*Death and life are the same thing, like the two sides of my hand, the palm and the back. And still the palm and the back are not the same. They can be neither separated nor mixed.*

— Ursula K. Le Guin

I was driving my son Cary, age 10, to a small gathering where some buddies and I do our cold plunge in a frozen pond. We were discussing safety. Our friend is a substitute teacher in the public school system. Safety is the top priority, and “safe hands” is the constant refrain of each day of behavior management. I told Cary of my favorite motto (which I’m told derives from Burning Man), “Safety third.” Of course, that motto does not mean to imply a linear ranking of life’s priorities. Its commonsense translation would be something like, “Safety is important, but not the most important thing in life.”

Cary, taking the saying literally, asked me, “If safety is third, then what comes first and second?”

I hesitated for several seconds. Then I said, “First and second are giving and receiving, not necessarily in that order. Giving is what you put into the world. It is your art and music, it is your mom’s healing work, it is the love you show to others, it is everything you do to make the world more alive and more beautiful.”

“Receiving is to fully enjoy being alive in this world. It is to behold with awestruck wonder the magnificence of creation. It is to delight in the gifts of others, and the animals and plants and the sky, the singing of the birds, the creativity of other people, to play and enjoy. As your grandmother said before she died, ‘Life has so much to offer!’”

Cary was well satisfied with this answer. I then added, “It isn’t that safety is unimportant. If you break your leg or have a fatal accident, then you won’t be able to give or receive in this world anymore. But safety is subordinate to giving and receiving. It must not come before them. We are here to be fully in the world, to live fully, not to play it safe and go to our graves having never risked anything.”

I first publicly invoked the phrase “safety third” at some point in 2021 or 2022, in the context of Covid. I was a little taken aback by the vehemence of some of the responses. People accused me of being selfish, lacking compassion, and not caring about others. I will paraphrase the criticisms: “By ignoring safety and not masking and vaccinating, by leaving your home and questioning public health measures, you are putting others at risk for your selfish ‘freedom.’ Furthermore, even if you are risking only your own safety, that still imposes a cost on society. If you fill up a hospital bed due to your risky behavior, you are denying that bed to someone else.”

Let us leave aside the fact that “freedom” is not first, second, or third on my list—not as a disembedded ideal, anyway. Freedom is intelligible only as freedom from, or

freedom to. Freedom to give and receive. Freedom to be alive. But I don’t want to make this a question of freedom, because, contrary to media narratives, freedom was never the main motivation of so-called “anti-maskers” and “anti-vaxxers.” We thought these were bad policies, founded on hysteria, captured science, and systemic ideology, then exploited by authoritarian forces as a pretext for more social control. Compassion and concern for the public welfare were the main motivations of our dissent.

**Stay home.  
Stay safe.  
Save lives.**

The argument cited above takes for granted exactly what I mean to challenge with the words “Safety third.” Now, I do not think masking, lockdowns, and the vaccines actually saved lives, but what if they did? What if we could save a thousand lives a year (that is, postpone a thousand deaths a year) by mandating a permanent lockdown society. Should we do that? What if we could save fifty deaths a year, and reduce hospital bed occupancy, by prohibiting swimming at the beach. Should we do that? No? Tell that to the grieving mothers of the children who drown and the spouses of those who get skin cancer from too much sun exposure. Early in the pandemic, Anthony Fauci and other public officials said we should never hug or shake hands again. Filthy habit, isn’t it? Well, all of these ideas make perfect sense if we install safety as our god. But we are here to live, not to survive life. We are here to play in the waves, to hug, to associate with each other, to live in materiality with all its inherent risks. I do not call on others to take risks that do not serve, giving or receiving—that is called recklessness, not courage—but neither does anyone have the right to demand that others, or society at large, curtail life to minimize risk.

Since most people today behave as if they have forgotten that the Covid pandemic ever happened, I won’t belabor Covid-era issues. I raise them mostly as a case in point, the point being the politically hazardous and spiritually deadening effects of the obsession with safety.

The political hazards are obvious. Authorities can manipulate a safety-obsessed population by conjuring up one threat after another. Safety as top priority justifies any measure that will keep you safe. Safety first, civil liberties an afterthought. We saw a foreshadowing after 9/11 of what was to come in 2020. First it was “security,” then it was “health” that justified new extensions of centralized power. Eventually though, both terrorism and pandemic lost their ability to terrorize, and thus their usefulness as pretexts for totalitarian policies (surveillance, censorship, propaganda, etc.). However, the social and psychic conditions for a new fear campaign remain in place.

It is equally obvious why safety-obsession deadens the spirit. It wraps a constriction band around life. It is always a little dangerous to probe one’s boundaries. It is always a bit dangerous to venture into the unknown. “Safety first” shrinks the horizons of possibility. What starts as caution becomes comfort, then habit, then a prison. The prisoner carries the key in his back pocket, taking comfort in his pretend helplessness. I’m not lecturing you, I’m speaking from personal experience. One feels less and less alive. What is there to live for, confined to the fortress, looking wistfully out the windows at a lush but distant landscape?

It is pointless to denounce safety-obsession without investigating its source. Under what conditions does avoiding injury and death become the point to life? Put that way, safety obsession is exposed as a form of insanity. It makes sense only if one is in denial of his or her mortality. It is no wonder then that our society performed such extreme rituals of protection during the pandemic. We are a culture that paradoxically and simultaneously denies death even as we make it the subject of the most extreme dread. We deny it by hiding it behind euphemisms, by banishing the public and private sight of it, by performing pointless heroics to extend the lives of dying

people a few more torturous weeks or days, as if to thwart something preventable. Most of all, we deny it through distance, living apart from nature’s cycles, never witnessing the rabbit’s writhe and shriek in the hawk’s talons. Yet for all the denying and distancing, death looms all the larger on our psychic landscape. Its terror comes in large part from separation from life. The separate individual of modern self-conception goes extinct on dying. The relational, interdimensional self of indigenous conception cannot be extinguished, since what dies is but a small part of the true self. For the modern mind, for the separate self, death is a final and unutterable catastrophe, too terrible to countenance. So of course we become obsessed with safety, as if to reassure ourselves that with proper care, the ultimate calamity need never happen.

There is another cause of safety obsession that is more important still. If safety rises from third to first rank, one wonders, what happened to the first two? What happened to giving and receiving? Beneath “safety first” lies a cultural forgetting, an abdication even, of the true purpose of the human being. It isn’t hard to see that we as a society have largely abandoned our devotion to life and beauty on earth, and built instead a civilization that mars and ruins creation. Less obvious but more tragic

is the narrowing and numbing of our receiving. We have become too busy, too distracted, too alienated, too hurting to fully receive the magnificence of all we can see, hear, feel, and praise. Full reception is a function of intimacy, and modern life has dulled the vividness and intimacy of our connections. Taking in only a tiny fraction of the sensory nourishment we need, we are forever hungry, craving ever more intense stimuli to meet the need to feel. Addiction, then, is not a failure of character or will. It is a sign of a real unmet hunger.

Please do not read any of this as a condemnation. It is more of a diagnosis. Recruiting shame to motivate change won’t restore our aliveness. What will? Grief. Grief is the embodied realization of loss. If we can recognize the magnitude of our loss, the profundity of our dis-possession, we will turn in a new direction. We will have full information. Without feeling grief, we don’t really know what has been and will be lost. Grief integrates what is lost as precious. Grief makes death real.

We have wandered far, far, far into the territory of separation. We must admit that we are lost. We dissolve in tears. We turn then and see on the horizon the golden land. Only teary eyes can see the path back.

# Dissent Into Madness: Escaping the Madhouse

Statist propaganda in the West tries to convince us that we live in a democracy, exemplifying Abraham Lincoln's famous ideal of "government of the people, by the people, for the people."

But this is gaslighting. In truth, we live in a pathocracy, which, borrowing from Lincoln, might be described as "government of the psychopaths, by the psychopaths, for the psychopaths."

Although "pathocracy" is still a foreign concept to many, it is by now a well-established and thoroughly documented phenomenon. The term was coined by Andrew Lobaczewski — a Polish psychologist whose life's work was shaped by his experience growing up first under the thumb of the brutal Nazi occupation and then under the equally brutal Soviet regime — in his book, *Political Ponerology*.

Lobaczewski defines pathocracy as a system of government "wherein a small pathological minority takes control over a society of normal people." Then, in a chapter of *Political Ponerology* devoted to the subject, he describes how pathocracies develop, how they consolidate power, and how they trick, cajole, intimidate and otherwise induce non-psychopaths into participating in their madness.

How can soldiers' natural aversion to pulling the trigger on complete strangers be overcome? How can doctors who have sworn an oath to do no harm participate in the scandemic madness of recent years? How can regular, salt-of-the-earth, working-class policemen be induced to brutally beat peaceful protesters? These are the questions that keep both the pathocrats in power and those looking to escape the pathocracy up at night, albeit for very different reasons.

Thankfully, we do not need to ponder these questions in a vacuum. In fact, the conditions for creating an environment in which the average person can be induced to participate in evil acts has been studied, catalogued and discussed by psychologists for the better part of a century. Unsurprisingly, though, this research, ostensibly intended to better understand how people can guard against such manipulation, has instead been weaponized by the pathocrats and used to fine-tune the creation of systems for generating more obedient order-followers. In fact, this was part of the point of the well-known but almost completely misunderstood Milgram experiments (more on which below).

At this point in our exploration, we are finally beginning to grasp the full extent of the problem posed by psychopaths in positions of political, corporate and financial power.

The problem isn't just that psychology has been weaponized against those of us who would engage in political dissent. And the problem isn't simply that this system

for suppressing and pathologizing dissent has been created by literal psychopaths and their sociopathic lackeys.

The problem is that the state itself is psychopathic and is actively warping the morals of otherwise mentally sound individuals, causing them to adopt psychopathic traits in return for material reward and positions of authority.

This is the problem of pathocracy.

system as a whole can we appreciate that the very existence of those seats of power from which a handful of individuals can rule over the masses is itself a construct of the pathocracy. Unless and until those seats of power are eliminated altogether, we will never rid ourselves of the struggle for dominance that rewards the psychopaths with control over others.

The elimination of those seats of power, however, will not happen until we overturn the underlying

assumption that centralization of power is necessary in the first place. And sadly, as G. Jinping correctly observes, given the relatively infantile state of humanity's political development, we should not expect the Ring of Power to be cast into the fires of Mount Doom anytime soon.

So, for those of us morally sound individuals currently living under the rule of the psychopaths, the question remains: what can we possibly do to overthrow the pathocracy?

As it turns out, the answer to that question may be much simpler than we think.

## Circuit Breaker

In the 1960s, psychologist Stanley Milgram set out to study the extent to which people's blind obedience to

perceived authority influences their behaviour. It was with this goal in mind that Milgram began his infamous study of obedience on August 7, 1961.

The results of those experiments, well-known to the public by now, ostensibly demonstrate that average, everyday people can be induced to deliver what they believe to be potentially lethal electric shocks to complete strangers based solely on the say-so of an authority figure. This finding is most commonly summarized with the factoid that a whopping 65% of participants in the original 40-person study were willing to deliver a 450 Volt shock — what they were led to believe could be a potentially lethal shock — to an audibly distressed person based on nothing more than a prompt from a person in a lab coat wielding a clipboard.

As one of the most famous psychological studies of the 20th century, the Milgram experiments have generated no end of debate, controversy and scrutiny. The NPR-promoted critics of the experiments, who contend that most of the study's participants knew that the entire situation was phoney and that they disobeyed even more often than was reported, are often pitted against the establishment psychologist defenders of the experiment, who correctly note that the experiments' shocking (pun intended) conclusions have been independently reproduced time and time again in country after country around the world. (In one particularly twisted reproduction, the researchers even sought to ensure that no subject would suspect the experiment was fake by delivering real electric shocks to cute puppies).

What almost everyone misses about the Milgram experiments, however, is that the study was not one experiment that was conducted on one set of 40 participants one time to yield one final result. In fact, Milgram conducted the experiment a total of 17 times with 17 separate cohorts of 40 to 60 test subjects, with each iteration of the study employing a number of experimental variations.

In one variation, he changed the site of the study from the Yale University campus to a rundown office building. In another variation, the test subjects were allowed to instruct an assistant to deliver the shocks instead of pressing the switch themselves. In still another variant, the lab coat-wearing actor playing the "experimenter" was called away on business and replaced by an ordinary man wearing a suit. And in yet another variation, the test subject was obliged to wait and watch other actors become the "teacher" and go through the experiment before assuming the role himself.

Each variation produced markedly different results. When the test subject could instruct someone else to deliver the shocks instead of doing it himself, for instance, the percentage of participants willing to deliver the maximum (supposedly potentially lethal) shock rose to an incredible 92.5%. When the experiment took place in an office building instead of on the Yale campus, the number willing to administer the maximum shock



Once we realize the gravity of this situation, the obvious question presents itself: how do we throw off the yoke of the political psychopaths and topple their pathocracy?

As usual, the quality of our answer to this question is directly dependent on the depth of our understanding of the underlying problem.

For example, in The Corbett Report comments section recently, Corbett Report member TruthSeeker framed the problem of toppling the pathocracy this way: "Perhaps we can find a way to eliminate psychopaths from all positions of power."

At first glance, this suggestion seems like a reasonable course of action. After all, if we could find a way to "eliminate psychopaths from all positions of power," then that would automatically solve the problem of political psychopathy, wouldn't it?

But, as Corbett Report member G. Jinping noted in his reply to TruthSeeker:

"We'll have to come up with a solution (for getting psychopaths out of power) that takes into account that the number two man, number three, etc. are probably just psychopaths who are at an earlier stage in their ascent to the top. Maybe we could just pick names at random from the phone book, if we still had phone books! Seriously, this is an intractable problem, that can only be addressed with the decentralization of power. I don't expect that to happen anytime soon."

Indeed, as G. Jinping rightly observes, the problem is more pervasive than many are willing to believe.

TruthSeeker's proposal would be viable only if there are a few isolated psychopaths who happen to have ascended to positions of political power. But if there are in fact many psychopaths who are all vying with each other for political control, then we have to understand that eliminating the current political psychopaths would merely open the door for others to step into those vacant positions. Worse, given the psychopathic nature of the power structure as it exists, the system itself actually ensures that psychopaths and sociopaths who, by definition, show no remorse or moral qualms about hurting others will end up winning the vicious battle to fill the top spots in the political hierarchy.

Only when we step back and interrogate the political

# The Evidence: Lockdowns Killed People Sweden Was Right All Along

## Sweden: The Control Group

Remember the early days of the pandemic, when we first locked down and everyone was exhorting us to “follow the science”? The injunction made little sense because: what science? Never in human history have all healthy people around the globe been confined to their homes for months without an end in sight. What about the unintended deaths that would occur as a result of a lack of health care, sunlight, and exercise, and an increase in poverty and depression? Where was the cost-benefit analysis? What research was done? The answer, at the time, was none. Today, however, the results are in. We have our trial group (the world) and our control group — the one country that held out — Sweden.

It’s true that at one point in May 2020, Sweden did have the highest COVID-19 death rate in the world. But today, the number of COVID-19 deaths and all-cause mortality deaths they’ve experienced since the start of the pandemic pales in comparison to other European nations.

## Eurostat Data

Recent data by Statistics Sweden/Eurostat published in Svenska Dagbladet (by Therese Bergstedt and Swedish state epidemiologist Anders Tegnell at [www.svd.se](http://www.svd.se)) shows that in the pandemic years 2020-2022, Sweden’s excess mortality was the lowest, not only in the European

Union but of all the Nordic countries, beating even global COVID-19 success stories, such as Norway, Denmark and Finland.

The data, collected from Statistics Sweden in collaboration with Eurostat, calculated the cumulative number of deaths in 2020, 2021, and 2022, and compared the figures with an average of expected deaths. The expected average value is based on death statistics from three

and age, what the figure should be for any given year. The excess mortality figure, the percentage above the expected baseline, can be calculated with the same methodology throughout the world. It is, in short, the one statistic that there is no getting away from.

Judged by this metric, the one real outlier was Sweden, which had the lowest excess mortality in Europe, and one of the lowest in the world, throughout 2020 and 2021.

In 2020, many assumed that Sweden would emerge with a higher death rate, but a much stronger economy. But according to Our World in Data, Sweden had a perfectly average COVID-19 death rate compared to other Western nations. What is astonishing is that Sweden’s pandemic response (or lack thereof) led to far fewer people dying overall during the pandemic. It seems the lethal impact of the lockdowns themselves was vastly underestimated (or vastly undermined) by officials. And officials are not loving the fact that they’ve been proven wrong.


## Officials’ Response

Leaked WhatsApp messages by Matt Hancock (UK’s Health Secretary of State during COVID) referred in his messages to the “f\*\*\*ing Sweden argument”, and asked officials to “supply three or four bullet [points] of why Sweden is wrong”.

But Sweden was not wrong, and no amount of desperate deflection can disguise it. The horrible truth is that lockdowns killed people. Sweden had lots of coronavirus cases but relatively few excess deaths.

Will politicians ever admit that the challenges we experienced and are still experiencing — undiagnosed diseases, isolation, obesity, debt, poverty, lost education, inflation, mental health problems — are unnecessary government-inflicted harms.

Let’s share this information widely, or we will go into the next manufactured crisis with the same skewed incentives.



years before the outbreak of the pandemic, i.e. the years 2017-2019.

That finding blows the case for lockdowns out of the water. In the early days of the pandemic, when the Swedish Government was being criticized for what looked like a high death rate (largely because sick patients were sent to care homes), Swedish medical advisers urged us to wait until all the evidence was in.

They had a point. COVID was a new disease, and countries had wildly differing approaches to measuring it. There was debate about whether people had died “of COVID” or “with COVID” and questions about if there was adequate testing (or too much).

But one thing that no one can fake is the overall number of deaths. We know how many people die annually in each country. We can predict, based on population size

# WEF & 15-Minute Cities

The World Economic Forum (WEF) once infamously said that in the future “You’ll Own Nothing and You’ll Be Happy.” Of course, what this really means is: they will own everything and you will be poor. Recently, the WEF has been pushing the “15-minute city” concept — with a plan to bring us all a whole lot closer to a dystopian future.

If you’ve never heard of the WEF, it’s an international lobbying organization for multinational companies. They are made up of some of the most powerful institutions in the world, including former and current presidents of nations, big tech CEOs, asset managers, banks, and non-governmental organizations. The end of private ownership is one of the main goals of the WEF, and they apply this to

everything from cars to private homes, enabled by 15-minute city design principles.

If you’ve read the mainstream news, you may see that 15-minute cities are being advertised as something we want, rather than what they (the international lobbying organizations for multinational corporations) want. As the Ontario newspaper *The Peterborough Examiner* put it: “Imagine being able to walk your kids to school or daycare, commute to work, enjoy recreational opportunities, and be able to pick up what you need from the store. Imagine being able to do all that while always being within a 15-minute walk or bike ride from your residence!”

Funnily enough, the WEF is known for its annual meeting in Davos, Switzerland, where politicians, business leaders, celebrities, and journalists fly annually in droves of private jets, spewing more carbon in a single trip than the average car does in its lifetime. An analysis commissioned by Greenpeace International found that last year’s WEF gathering in Davos saw over 500 private jets arrive with a single meeting attendee. 53% were short-haul flights under 750 km, while 38% were flights under 500 km. The shortest flight recorded was only 21 km (about a 23-minute car ride, or one-hour bike ride). Yes, that’s right, the “climate friendly” 15-minute city concept is being promoted by the same elite group of people polluting our planet.



While this concept first started in Paris, England’s City of Oxford is the furthest along in their 15-minute city implementation. The pilot project involves dividing the city into six districts and the roads between districts are off-limits to cars without permits between 7 am and 7 pm, 7 days a week. This means setting up cameras everywhere to keep track of where everyone is driving to ensure that they do not leave their designated district too frequently. Starting in January 2024, boundaries will be enforced through traffic filters that will automatically issue fines to violating vehicles.

Here at home, Edmonton, Alberta is set to be Canada’s first pilot city. Phase 4 implementation of

# Australian Government Document Shows; the Public was Deliberately Misled About Pfizer Vaccine

Thanks to UK nurse practitioner and online commentator, Dr. (Ph.D) John Campbell, we were alerted to the late March 2023 release of a study completed by Australia's Department of Health in January 2021. The redacted study, released as a result of an Australian Access to Information request — is entitled "Nonclinical Evaluation Report: BNT162b2 [mRNA] COVID-19 vaccine (COMIRNATY™) and was created in reply to Pfizer Australia's "application for provisional registration of a new biological entity, the Covid-19 (COMIRNATY) vaccine".

The document is an evaluation of the claims made by Pfizer as it sought government approval to make its product available to the Australian public. It is a key document because it sheds shocking light on what the Australian government knew about Pfizer's product and when precisely they knew it. For anyone with a long enough memory, this information can be evaluated against the public health messaging at the time "vaccines" were being rolled out by Western governments. The data contained in this report is thought to have been available to the US, UK, Canadian and European governments at the same time it was available to the Australian government.

Both the two-year delay in getting the document released and the substantially redacted parts of it suggest that its findings contain information that the Australian (and other Western governments) would prefer not ever see the light of day. As we will explore below, the Evaluation makes it plain that Western governments were lying to their citizens about several key facts related to Pfizer's product, while simultaneously and strenuously — (even irrationally) — pushing it on their trusting populations.

## Site of Injection

Who can forget the government narrative that stated unequivocally — that after injection, "vaccine" contents remained at the point of injection? The Australian report proves that at the same time, governments were promoting this as an indisputable fact (and labeling any criticism a conspiracy theory), they were aware it was demonstrably untrue.

The Australian study shows that the lipid nanoparticles contained in the shots did not remain at the injection site. These lipids (which carried the mRNA payload) were systematically distributed throughout the body of test animals (monkeys, rats), via the plasma in the blood. The study included a useful if disconcerting table (Table of Organ distribution — Table 4.2) proving the lipids gathered in dozens of places outside the injection site, but mainly in the liver, spleen, ovaries and adrenal glands. After discovering that the lipids traveled throughout the test animal's systems — to the bladder, bone, bone marrow (where blood cells are produced by the body), brain, eyes, heart, kidneys, pancreas, lungs, lymph nodes, prostate, spinal cord, testes, and uterus — the Australian Health authorities decided not to investigate or inquire as to whether the spike proteins manufactured by the mRNA, might be distributed similarly.

The report noted... "a slow but significant distribution of lipid nanoparticles from the site of injection with major uptake into the liver". Remember when even suggesting the jabs might travel was labeled tinfoil-hat theory by government officials, captured scientists and mainstream media across the Western world?

Equally disturbing for a health agency whose job it is to evaluate such matters; upon noting this worrisome lipid distribution in the first 48 hours after injection, Australian health authorities stopped looking. One might have expected that upon confirming the lipid's travels over 2 days, they might continue looking for results after say, 3 days and 4 days. They did not.

The report clearly shows that the fact of systemic distribution was known in January 2021. Consequently, any Western health authority or politician who repeated that false claim after January of 2021 was either uninformed or lying. If they were uninformed, they were grossly negligent since it was their job to be informed, with vast resources available to them for this purpose. If they were

lying, one might consider it reasonable that they are held criminally liable.

## Infection

At Page 4, the report notes very similar lung inflammation results in test animals whether the infected (with Covid-19) animals received the Pfizer shot or not. In plain terms, the virus was given to unvaccinated animals and they ended up with the same levels of lung inflammation (infection) as the ones who were administered



the "vaccine". Based on that finding, Australian Health concluded that the jab was efficacious enough to push out to everyone.

On page 4, the report acknowledged that there was no data in January 2021, to determine where the S-antigen encoding mRNA went after it was injected or how long it stayed in the animal's system. The report noted, "there was no distribution or degradation data". Strangely, Australian Health did not ask Pfizer to test for the systemic distribution of the spike protein produced by mRNA. Health authorities appear to have assessed this lack as irrelevant to the overall calculus when deciding to tell everyone it was safe to inject into their bodies. Lipids went absolutely everywhere in the body. It should have been determined whether the mRNA and the spike protein it produced, similarly traveled (it was, after all, using the lipid nanoparticle as a means of conveyance). The Evaluation also showed that there was "No data" on how long the spike protein persisted (in the body). Based on that lack of data, the vaccines were authorized to go into everyone's arms.

At Page 5, the Evaluation notes that Antibodies and T-cells declined quickly 5 weeks after injection, after the 2nd booster. For Australian Health, this discovery raised "concerns about long-term immunity". Having raised these important concerns about the limits of the so-called vaccine's durability, the governments rolled it out to all. Australian Health seemed content with Pfizer's statement on long-term immunity that... "The animal studies were of short term; long term immunity was not assessed. The sponsor indicated that long term immunity would be addressed by human data."

Whether Pfizer meant this important element would be determined by later human clinical trials, or the upcoming vaccine rollout to a global population, is unclear.

Interestingly, the Report noted there was one study showing natural immunity produced a good Helper T-cells response in precisely 100 percent of people who had Covid. In plain speak that meant that antibodies to Covid-19 were naturally produced in 100 percent of test subjects! Recall that natural immunity was roundly poo-pooed at the time, with irrational emphasis placed on "vaccines" as the only solution. Why were authorities silent on the natural immunity noted in the Evaluation? Claiming they were merely silent is generous. In fact, in their single-minded quest to get a jab in every human within their grasp, western governments went out of their way to destroy the long-since-proven scientific fact that infection resulted in natural immunity in the human body.

## The Evaluation acknowledges several other important unknowns.

- A lack of short-term protection studies;
- Lack of pharmacokinetic data, which is a lack of data

about the way the body affects the drug/vaccine. i.e. how mRNA is broken down by the body. Health authorities had no idea;

- Lack of knowledge about how the mRNA vaccines affected genotoxicity (i.e. how it affects one's genes). There was no data examined about whether these vaccines were having a toxic effect on genes. The paper acknowledges — they did not know;

- Lack of studies investigating the potential for autoimmune diseases to be triggered by the vaccines. The report acknowledges the potential that this could be an undesirable outcome of the shots but then requests absolutely no further study to explore that possibility.

- Long-term immunity was unknown. The report put it this way: "Long-term immunity, vaccine-induced autoimmune diseases were not studied in the nonclinical program and should be addressed by clinical data post provisional registration".

As Dr. John Campbell rightly notes, we took senior public health authorities scientists at their word because they said everything had been done normally when the vaccines were rolled out. There was nothing to worry about, they told us. This Evaluation that they fought to keep out of the public eye, confirms that many things the public was told were untrue — and known to be untrue at the time they were conveyed to a trusting public. Judging by this report, it is clear there was plenty to be concerned about. If we had been told the truth, our calculation would quite

possibly be different.

Anyone can access this report and all are encouraged to download it and read it for themselves. It is not an easy read at over 50 pages, but worth the effort, for posterity's sake.

the 15-minute model across 15 districts, blanketing the entire city is already in place. Phase 5 will finalize the plans and is expected to happen between July and January of 2024. Among the goals outlined in the Edmonton City Plan include: reduced reliance on single-occupancy vehicle use and increasing the collection and sharing of data between government institutions and nonprofit groups. While they don't elaborate on how this data will be collected, the increased connectivity through technology like SMART streetlights will help to facilitate this data capture.

While Edmonton is in the most advanced stage of the plan, Ottawa, North Vancouver, and other Canadian cities have also been making plans for 15-minute cities.

So how are residents of these cities reacting to the plans? They are not loving it. When the residents of Oxford were asked by city planners, 93% were against the 15-minute city plan. There were a lot of concerns, with one area of issue being segregation. Dividing cities into districts will guarantee that the poor stay poor and the rich stay rich. Some would say that is the entire purpose of the plan because a WEF panelist discussion revealed that different cities will have different rules for different districts. In other words, the rich will remain free.

But probably the biggest concern is economic inequality as a result of giving more power to governments and big businesses. Instead of saving our planet, 15-Minute Cities are a one-way path to a society that favours both big-government control and the corporate interests that will benefit from their big-government contracts used to help implement the plan, and the agendas being pushed forward.

While it's unclear how the plans will evolve and to what degree restrictions will be put on us, what we do know is that the 15-minute city is one step closer to "You'll Own Nothing and You'll Be Happy."

dropped to 48%. And when the test subject watched other people take the "teacher" role before them and observed them refusing to obey the experimenter's command to deliver the shocks, that subject's willingness to deliver the maximum shock plummeted to 10%.

Let me rephrase that. When the test subject saw someone disobey the experimenter, they themselves refused to proceed with the experiment 90% of the time.

This is the surprising conclusion that has been scrubbed from most accounts of the Milgram experiments: Disobedience, once modeled, becomes an option in the mind of the public.

This point is crucial to understand because, exactly as Étienne de La Boétie pointed out nearly 500 years ago, a small cadre of tyrants, no matter how psychopathically menacing, are incapable of administering a tyranny all by themselves. They require the active participation of a much larger number of obedient order-followers.

Indeed, it is important to become conscious of the fact that none of the worst excesses of the pathocracy in recent times would have been possible without the active participation of vast swaths of the population. So-called vaccine "mandates" were not achieved by one psychopath in a position of political authority, or even by a gaggle of such pathocrats. They were enabled by the doctors who participated in the vaccination drives against their own experience, judgment and training, the employers who imposed vaccine requirements on their employees, the business owners who implemented vaccine certificate checks on their premises, the police officers who threw the unvaccinated in quarantine facilities, the workers who kept those quarantine centers functioning, the judges and lawyers who rubber-stamped all these actions, etc.

The same goes for any number of pathocratic abuses that we have been subjected to in recent years. These programs can only be implemented when most of the people comply with their orders and thus fulfill their role in the operation.

Just as in the time of La Boétie, our enslavement to the pathocracy is, by and large, a voluntary servitude born of obedience.

Combining La Boétie's insight with Milgram's lesser-known experimental results, then, we find a template for toppling the pathocracy: highly visible acts of disobedience.

But is this true? Can a single act of disobedience really bring down a pathocracy?

But then, something extraordinary happened. Someone booed. The boo was taken up by others and became a jeer. Chants of "Timișoara!" rippled through the crowd, a reference to a massacre of political dissidents by Ceaușescu's security forces that had taken place just days earlier.

The dictator, unused to any sign of dissent from the population over whom he had ruled so brutally for decades, called for order. His wife demanded the crowd's silence, prompting Ceaușescu to tell her to shut up, and then he attempted to continue with his speech. But the jeers began again.

The footage of the incident, including Ceaușescu's look of utter confusion as he realizes that the crowd has turned against him and that the threat of violence is not enough to subdue them, is priceless. There, captured on tape for posterity, is the moment when the realization dawns on the tyrant that the people have rejected his tyranny. The rest of the story — the riots and unrest, the attempted escape of Ceaușescu and his wife, their capture by military defectors and their execution on Christmas Day — all stems from that precise moment when one person in the crowd simply voiced what the rest of the crowd was feeling.

This is the circuit breaker effect. By saying no to illegitimate authority, resisting bullies and tyrants, disobeying immoral orders, refusing to comply with unjust mandates and demands, we make it that much easier for those around us to stand up for what they, too, know to be right.

But wait, it gets even better...

### Escaping the Madhouse

First, the good news: pathocracies are inherently unstable and they are doomed at some point to topple under their own weight.

Indeed, as Lobaczewski points out in his discussion of the phenomenon, pathocracies by their very nature possess numerous weaknesses that make their downfall inevitable. They require, for instance, that key administrative positions be filled not by finding the most competent men and women in the general public and promoting them based on ability and merit, but by recruiting the most serviceable lackeys from the much narrower pool of psychopaths and sociopaths. This leads to the seemingly endless parade of low-grade morons and feckless, out-of-touch imbeciles who end up in positions of power, greatly degrading the effectiveness and stability of the pathocratic state.

Pathocrats, like all psychopaths, also live in mortal fear of being exposed as pathological. Commenters on psychopathy have long pointed out that the mask of sanity — the psychopath's ability to hide their moral defect from others — is incredibly important to them. After all, once identified, psychopaths can be effectively shunned and "eliminated" from positions of power, as TruthSeeker suggests above. As Lobaczewski writes:

Normal people slowly learn to perceive the weak spots of such a system and utilize the possibilities of more expedient arrangement of their lives. They begin to give each other advice in these matters, thus slowly regenerating the feelings of social links and reciprocal

trust. A new phenomenon occurs: separation between the pathocrats and the society of normal people. The latter have an advantage of talent, professional skills, and healthy common sense.

Next, the even better news: if it is true that psychopaths can fashion a psychopathic society that twists people into sociopaths, then the opposite is true, too. Healthy, non-pathological humans with love, empathy and compassion can fashion a society that brings out the better side of human nature.

This is the real goal of the erstwhile victims of the pathocrats. Not to eliminate the political psychopaths and assume their positions of power in the psychopathic political system that they created, nor even to abolish that system altogether, but to envision a world in which compassion, cooperation, love and empathy are not just encouraged but actively rewarded. A world in which every person is allowed to become their best possible self.

It is up to each one of us to model that which we wish to see in the world. Just like the brave dissenter who can break the circuit of tyranny by voicing opposition to the tyrant, we can also become the models of love, understanding and compassion that will motivate others to become the same.

After all, if the psychopaths have spent centuries weaponizing psychology to more effectively control us, can't we wield our understanding of human nature for something good? And isn't that what healthy, non-psychopathic individuals forming a healthy, non-psychopathic society would spend their time and resources doing?



## Letting Men Play Women's Sport Puts Women in Danger – as I Discovered

One of the joys of hockey (field hockey if you are in North America) is that young and old can play together. This is not just knocking a ball about; you will often see fathers and sons and mums and daughters playing in the same teams in competitive matches, particularly in the lower leagues. You even see parents taking the game up just so they can play against their kids.

The youngsters tend to be not quite as strong as the oldies, but can outrun them, and are often more technically skilled, having learned the game on synthetic rather than grass pitches. However, they can usefully absorb tactics and gameplay from the more experienced players around them for a couple of years, before moving on to try their luck against players closer to their prime.

This works because hockey is a non-contact sport. Essentially, if you make body contact with someone when you are tackling, you commit a foul. Not every tackle is clean, of course, but the differences in size, strength and speed are small enough to make it a reasonably fair contest, and everyone has fun.

The non-contact nature of the game means that juniors get a chance to play with the adults at quite young ages. Rules vary league by league, but where I play, boys are allowed in from 14. It's quite common to see talented girls given a run out at age 12, if they've been through their growth spurt.

My coaching role is to help girls through this transition from kids' hockey to the adult game. Mostly, we're playing friendlies with teams made up of juniors, with a few adults thrown in to provide guidance. However, occasionally, we are called on to send a few extra players up to the ladies' section to make up numbers. I pick the biggest and most skilled girls – the ones I think can cope.

However, when this happened a few weeks ago, we got a nasty shock and I think came quite close to disaster. That's because the opposition turned up with a transgender player, in physical prime, built like something out of the backs division of a rugby team, and who played like it too – faster, stronger and

much more aggressive than anything the girls are used to.

Some of them were clearly frightened, and stood off tackles. Some tried to get stuck in but were so completely outmuscled that it was mostly fruitless. Then, about a third of the way through the game it got very unpleasant.

Our striker, a girl of 15, is something of a rocket ship. Tactically, we get a lot of joy feeding her balls to run on to because there are so few in the league who can catch her. But not this time. Despite a 10-yard head start, and running at full speed, she was closed down by the rugby player over an astonishingly short distance, and was tackled. And as the stick landed,



she crumpled, going to ground in a heap. The impression was of watching a wildlife documentary; a leopard taking down a gazelle, perhaps.

She was down a long time, but eventually was able to get to her feet and step off the pitch. She had been on the end of a tackle that crossed the line from non-contact to contact. It was a slight touch, nothing more, but the difference in weight and speed between the two players was enough for her to be wiped out. And it was enough to mean that she ended up with injuries to hip, wrist and – more worryingly – to her neck. Her match ended there and then.

While it was open to the umpires to issue a yellow card (or another colour) to the offending player, neither felt it appropriate. They agreed that it was an unfortunate touch, and nothing more; there was no malicious intent. And that's the nub of the problem. Even in the absence of malice, and in a non-contact sport, there is a serious risk of injury to players if there is a major imbalance in size, weight, speed and aggression. Make no mistake, this is a disaster waiting to happen.

But we are dealing with a transgender player, so we are walking on eggshells. What should we do?

Some of the parents think we should speak to the authorities, but it's fair to say that most people within the club are fearful of the consequences if we do. Nobody wants to be labelled a bigot. "Don't say the word 'transgender', and don't say 'juniors'," is a common theme of our soundings on the issue. So we are forced to go along with the pretence that neither of these characteristics had anything to do with what happened. We are forced to live a lie.

Some of the parents of the girls in the team have also told us they do not want their children facing such risks. They are right to do so – they could see the danger, as could I. As the responsible adult, I know that fingers will be pointed at me if we do get another injury, so I have undertaken to tell them if I think a fixture will feature a transgender player, so that they can be absent themselves. In reality, in a team in which more than half the players are juniors, that will mean conceding matches. That's grossly unfair to the children, some of whom don't get to play competitive fixtures often anyway. Worse, if a transgender player appears unexpectedly with an opposition team, we may have to refuse to play on the spot. That's unfair to everyone, but is an inevitable consequence of the pretence that the girls are simply playing against another woman. And it's better than a child being seriously injured.

- Washington State's senate passed a bill (SB5599) that gives the state the power to take children away from their parents if the parents do not consent to the child's gender transition surgery.
- It's official: NIH did indeed fund "gain-of-function" coronavirus research at Wuhan Lab — officials no longer have plausible deniability. On April 26th, Judicial Watch announced it received 552 pages of records from the U.S. Department of Health and Human Services through a FOIA request. The documents included the initial grant application and annual reports to the National Institutes of Health (NIH) from EcoHealth Alliance, describing the aim of its work with the Wuhan Institute of Virology in China to create mutant viruses "to better predict the capacity of our CoVs [coronaviruses] to infect people."
- The City of Toronto announces that as of April 1, 2023, "feeding wildlife will be prohibited across Toronto and on private properties" noting that "feeding wildlife can lead to public safety issues." In addition, the city is also limiting the permitted number of guinea pig and rabbit ownership to four per household and is "allowing" dog owners 24 hours to remove dog waste from their personal property.

- Oxfam erases "mother" and "father" in its new language guide. British charity Oxfam released its Inclusive Language Guide, which, among other things, discourages staff from using the words "mother" and "father" across websites, media, and other forms of content.
- Members of the Ontario Legislative Assembly are pushing a bill titled "The Protecting 2SLGBTQI+ Communities Act" where "offensive remarks" would be prohibited within 100 meters of a drag show and could lead to a fine of up to \$25,000 for "offenders".
- The US Department of Justice announced that the FBI have arrested two people on charges of operating a secret police station in New York City on behalf of China's regime — not unlike the Chinese police stations that have operated across Canada, and still are in some cases.
- Atlantic Council has announced that 114 countries, representing over 95 percent of global GDP, are now exploring a CBDC (Central Bank Digital Currency). A new high of 60 countries are currently in an advanced phase of exploration (development, pilot, or launch) and 11 countries have fully launched a digital currency.
- Two-thirds of occupations across America could be partially automated by artificial intelligence, Goldman Sachs economists have warned. In a report published on April 5, economists Joseph Briggs and Devesh Kodnani said that a new wave of AI systems, such as ChatGPT, could have a "major impact" on employment markets across the globe, while advances in such technology could trigger shifts in workflows that could "expose the equivalent of 300 million full-time jobs to automation" across 900+ different occupations.
- Home improvement products retailer Lowe's has introduced surveillance robots that monitor license plates, mobile devices, to detect repeat offenders. The 5-foot-tall, 400 pound, eggshaped robots, that go by the name "K5", have been released in a handful of stores throughout North America.
- If you use the terms "red-pilled," "based," "looks-maxxing," and even names like "Chad" and "Stacey," you may be a violent extremist, according to the FBI. As revealed in documents obtained by The Heritage Foundation's Oversight Project, the FBI has a secret list of flagged terms that it uses internally to indicate an individual's involvement in "violent extremism."
