### Divide and Conquer

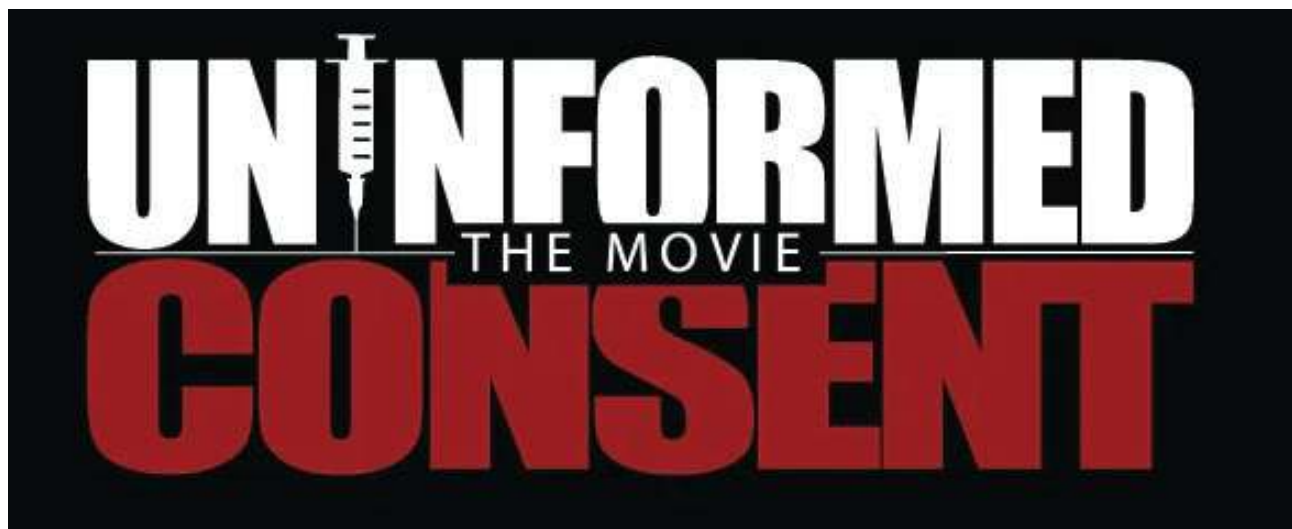
As noted by B.C. physician Dr. Stephen Malthouse, who is interviewed in the film, “divide and conquer” is an age-old war strategy. - The massive conflicts of interest between Big Pharma, the agencies that regulate them and politicians who create our laws.
- The collusion between private entities and governments to bring forth global totalitarianism under the banner of biosecurity.

I hope you’ll take the time to watch *Uninformed Consent*, and share it with others. Harris specifically tried, he says, to create a film that would help open the eyes and minds of those who still cannot see what’s happening, or don’t fully believe what they’re seeing.

# Fourteen Young Canadian Doctors Die After Getting The Shot

This is a list of just the docs my doctor friend in Canada heard about passively. In the past 30 years, he’s never heard of a single death like this. Not one. Now there are at least 14.

### Executive summary

A doctor friend of mine in Canada heard about 15 deaths of Canadian doctors over the last 9 months. He’s been in practice for 30 years. He’s never heard of any such unusual deaths before of doctors. Zero in 30 years. Why is he now, all of a sudden, hearing of so many deaths, and why are these deaths all happening very soon after vaccination?

From July 13 to July 28, 7 doctors died... an average of one doctor every other day for 2 weeks straight. And the causes of death were statistically unusual: two died swimming (which is very rare), one died in her sleep (very rare), etc.

The fact checkers assure us all that all of these doctors died for other reasons; the fact that they all died right after the vaccine was simply bad luck. That’s not the right metric. The fact checkers need to tell us the last time this happened where 7 doctors died in 14 days from unusual causes. They cannot. This is unprecedented.

The Canadian doctors continue to ignore the deaths in plain sight and continue to believe what they are told to believe. I predict the next shots will be even worse.

Sadly, I don’t think the Canadian doctors are ever going to figure this out.

14 deaths of young doctors in the last 9 months, all shortly after the jab.

Canadian doctors keep lining up to get the shots to be “protected” from a disease which is easily treatable with a combination of drugs with little to no side effects.

A doctor friend in Canada has been passively noticing the untimely death of doctors in Canada shortly after they were forced to get the third and fourth doses of the vaccine. He sent me these images below which had been sent to him. He’s not proactively researching these. There are likely a lot more deaths he doesn’t know about.

Guess how many similar deaths (young doctors dying unexpectedly of odd causes) he’s noticed in the past 30 years in practice? Yup, zero.

What’s astounding is that this is a vaccine, which according to this CDC study, makes it nearly impossible for you to die after the shot. Yet, these doctors all died shortly after the shot. The doctors are dead, so the CDC study must be wrong.

Oddly, none of the deaths were covered in the Canadian mainstream media, so I thought you should know about them.

There was coverage of six recent deaths in *Health Impact News*: 6 Canadian Medical Doctors Died Within 2 Weeks After 4th COVID Booster Shots for Employees Started at One Hospital.

Let me be very clear. You cannot have 14 Canadian doctors die shortly after the vaccine if there isn’t something wrong with the shot. Period. Full stop. Each of these is a very rare event. Having them clustered like this is a sure sign the vaccines killed them.

Any honest scientist would start with this hypothesis as the most obvious hypothesis and only reject it if there was compelling evidence to the contrary.

The vaccine kills people in subtle ways that are NOT being investigated by medical examiners. They are deliberately looking the other way.

Two of the most popular methods used by the vaccine to kill people are accelerating a cancer (which may have started from an earlier dose) and by causing a sudden death which, if the person is driving or swimming, appears to be a car accident or drowning.

Nearly all the medical examiners all look the other way when assessing a vaccine-caused death.

For example, I know a technician who works for a medical examiner who is seeing all these odd “blood clots,” but he says the pathologists “won’t listen or investigate”!

Why are people looking the other way? It’s because they want the pandemic to go away and they are told that the vaccine is the only way out of the pandemic so they look the other way when there is bad news.

Fact checkers: Nothing to see here folks. Move along.

According to the fact checkers, none of these doctors died from the shots, they all died of other causes.

Duh. The vaccine always kills people by stopping their heart, brain, etc. so it always looks like they died from something else because they did.

But when normally healthy people all of a sudden die like this in rapid succession, you are being totally disingenuous if you rule out the vaccine as the likely instigator of the death.

What the fact checkers fail to point out is that in many cases, the diseases often first started after the first vaccine shot, and then got worse with progressive shots. Somehow, they always miss that point that the vaccine accelerated the death. The fact that all these doctors died in close proximity to the shots is just too coincidental.

od. This is the type of observational study the CDC should be doing... but they aren’t for obvious reasons (it would create vaccine hesitancy).

Does that sound like a safe vaccine to you?

The evidence just doesn’t seem to matter, even when it is in plain sight. 40.2% of women had their reproductive organs affected by the vaccine and we still are mandating this vaccine?!?!

Are there any anecdotes showing the reverse, i.e., only unvaxxed getting sick/dying? I couldn’t find any!

When I looked for anecdotes that are opposite to this one (where it was the unvaxxed who were being injured or dying), I couldn’t find any.

### Summary

This is a partial list of Canadian doctor deaths. I’m sure there will be more in the comments.

The key point is the sheer number of events are simply too high in the doctor category alone. These doctors all dying shortly after the jab suggests a most likely hypothesis be that the jab killed them, e.g., by accelerating their existing medical condition, or creating a new medical condition, or by a mysterious sudden death.

So while it could be that one or maybe two of the deaths were just coincidences,

odds are that the rest were not. This sort of pattern has not happened before.

Science is about figuring out which hypothesis is a better match to the data. For the data I’m seeing, it’s always that the vaccines are too unsafe to use.

# Back To The Land

## Canadians are heading to the countryside to build tiny homes and intentional communities

As I drove with windows down to Canada’s Tiny Home Show in Ancaster, Ontario under a cobalt August sky, my thoughts turned to the *Whole Earth Catalogue* — a mashup of hippie bible and Sears Roebuck catalogue first published in 1968.

The *Whole Earth Catalogue* was an icon for Baby Boomers, like Woodstock, channeling the Zeitgeist via eclectic articles and items for sale, including instructions on bee hive building, geodesic domes, survival arts of the primitive Paiutes, Tantra art and creative glass blowing. You could even order (on page 6) Arthur Koestler’s book *The Ghost in the Machine* for \$6.95, postage paid!

Though an urban person, I’ve long been an armchair traveler in the realms of off-grid living, which is back in fashion as people flee lockdowns and other rights infringements in urban centres. My library once contained well-thumbed back issues of *Harrowsmith* and *Mother Earth News* in whose pages I first encountered Earthship home designs and other “biotecture” from iconoclastic architect Michael Reynolds, later documented in the film *Garbage Warrior*. I even spent a day in the 1990s stomping earth into scrap tires that formed

the walls of environmentalist Pat Potter’s adobe-style Earthship home.

My day at the Tiny Home Show represented a shift;

my wife and I are taking practical steps to live off-grid, and are kicking the tires (literally) of Earthship homes,

tiny homes, and the intentional communities that freedom-loving people are establishing on unorganized land throughout our province. We’ve already begun, having spent the summer living in a 30-foot travel trailer in a wilderness resort in Northern Ontario. We’ve navigated the ins and outs of two adults, a teenager and a full-size dog living in the equivalent of a section of the International Space Station. The problem is, it’s not suitable for Canada’s harsh winters, which will grow colder in the coming years as we step deeper into the Grand Solar Minimum that’s upon us. We need something winterized.

As I pulled into the parking lot of the show, I was impressed with the large array of different tiny homes outside the conference centre where I purchased a ticket, walked the trade show floor, and eavesdropped on a few well-attended conference sessions.

My hunch was right: interest in alternative dwellings and homesteading is exploding. In addition to the expected laminate flooring, furniture and HVAC displays, exhibitors promoted tiny home associations, insurance and lending options, and legal advice. The latter item is important: many non-conforming

home and community plans run afoul of municipal planning departments and building codes. Even if your home is self-reliant for all energy and water and sewage needs, and even if it’s built to withstand a hurricane, it’s likely going to be a square peg in the round hole of urban planners and building inspectors. Eventually, many municipalities will embrace the tiny home and homesteading movement, but in the meantime, we mustn’t be naive. (For example, I was interested to learn it’s illegal to live year-round in Ontario in a home on wheels.)

Outside, throngs lined up to walk through different tiny home models, most of which incorporated heavy wheeled trailers. Some were unfinished metal containers that had been wired and plumbed, awaiting the interior designer’s touch. Others were finished with high-end kitchens and living rooms with clever places to stash stuff. Overall, the tiny homes weren’t much different than our two-bedroom trailer, except most had a second-storey loft bedroom, and were winterized. They were also *way more expensive*; high-end finishes targeted city-dwellers who favour granite countertops and stainless steel appliances. As I plan to build my own off-grid home – tiny or not – I spent more time than most photographing solar battery arrays and propane tank setups.

Yes, moving to the country and growing your own food makes sense in a Hunger Games society — but the *details* of *what to do* are daunting. Should we install solar, wind or geothermal? Should we burn wood, pellets, or something else? What about raised bed gardens? Permaculture? Or vertical farms? Do chickens, goats or rabbits yield the most nutrition? Should we invest in yurt, hempcrete or timber frame construction?

I spoke about all this with Andrew Miller and his partner Kate Waugh of Nine Mile North Tiny Homes and Domes ([ninemilenorth.com](https://www.ninemilenorth.com)). Their outdoor booth displayed a micro turbine and a white wooden geodesic dome and they build all kinds of cabins and structures for off-grid living.

“This year we’re launching the Nine Mile North Mentorship Academy,” Kate said. “We’re teaching essential life skills, including carpentry and organic farming, and will expand from there.”

As she spoke, I found myself staring at Andrew who, with his height and beard, looks like a Viking. *He’d be useful for security*, I thought as I envisioned *The Walking Dead* hordes of city folk wandering into our future intentional community.

I don’t know if guns and hunting licenses were advertised in the *Whole Earth Catalogue*, but I plan to get mine. I already have boating and fishing licenses. I don’t know if we’ll settle in pastoral farmland or a rugged pine wilderness. Either way, we plan to thrive — not just survive — in the new world that’s being birthed. If you aim to do the same — and especially if you plan to homestead — I suggest you visit the Tiny Home Show next year, and explore the resources on its website, [tinyhome.show](https://tinyhome.show)

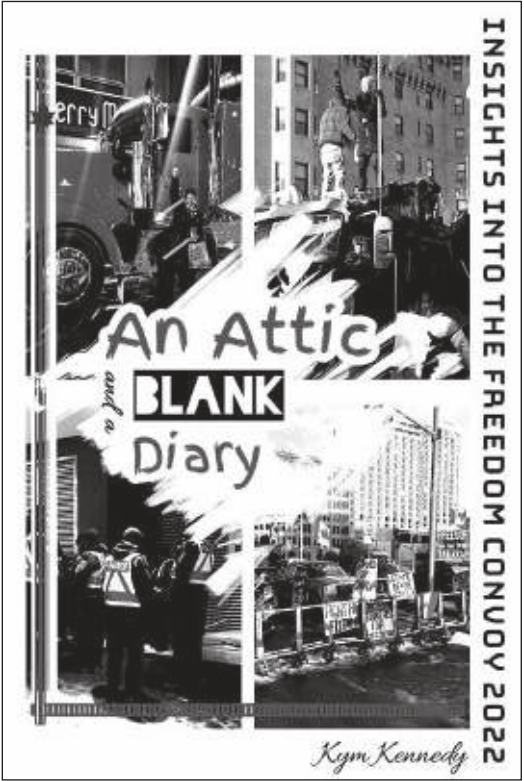

# Why We MUST SAY NO to Bill C-11

The Canadian Bill of Rights recognizes freedom of speech and freedom of press as fundamental freedoms and human rights. Having the right to voice one's personal opinions is critical in allowing humanity to grow and flourish. In an age that is quickly digitizing all aspects of humanity, social media has become the de facto town square, where individuals can stand on a symbolic soap box and speak their minds.

Individuals, content creators and independent journalists are growing increasingly concerned with the direction of these laws. Given how one-sided mainstream media has become, social media has been crucial for Canadians to express and explore multiple points of view, and make informed decisions for themselves. It seems that the mainstream news simply parrots the narrative dictated by their advertisers or shareholders — with very little investigative journalism being performed — allowing global political & financial interests to be shaped into a 'cohesive' narrative. It became very clear early on in the pandemic that the ability to share one's opinion openly and without fear was quickly eroding. This proves extremely dangerous, especially at a time when freedom of speech has never been more important. The reality is that the number of doctors and citizens who have spoken out against the 'Science' account for more than a mere 'Fringe Minority'. If one were to combine them with the number of individuals who recognize that something is wrong but have been fearful of the repercussions of speaking against the narrative, we're certain this would represent a majority.

Buried within a rather large bill, obscured by actions intended to preserve Canadian "culture" and language, is section 4.2 of Bill C-11. This will give the CRTC significant control over every Social Media platform and algorithm, severely hindering independent journalism. Bill C-11, known as the "Online Streaming Act", is a thinly veiled attempt at censoring the internet. This is why it is sometimes referred to as the "Internet Censorship Act" or somewhat offensively the "Great Firewall of Chinada Act". This is due to the eerily reminiscent nature of China's strictly regulated internet/firewall. China blocks much 'Western' content in an attempt to shape the behaviour of its citizens. Frighteningly, this seems to be a worldwide trend, as many democratic countries are developing similar measures; like the United States' "Board of Disinformation" and the United Kingdom's "Online Safety Act". Author, Bruce Coville once said "Withholding information is the essence of tyranny. Control of the flow of information is the tool of the dictatorship." To dismantle freedom of expression under the guise of keeping people safe by stopping misinformation, disinformation, and mal-information is incredibly dangerous.

The failed predecessor, Bill C-10, excluded user-generated content. This exclusion was quietly modified as the bill was updated to Bill C-11. The bill claims to only affect monetized users but the terminology could be interpreted to include non-monetized users if they include licensed content in their upload. There will be requirements for English, French and Indigenous content. As well as requirements for accessibility to disabled individuals in terms of consumption *and* creation of content. This may create significant financial barriers for new social media services, limiting competition against existing services like YouTube. These new rules could also result in frivolous fines for non-compliance, exorbitant licensing fees, and restrictions and manipulations to the algorithms affecting what content is promoted to individuals. Bill C-11 was quickly passed through the House of Commons, skipping consideration of amendments suggested by the opposition, and now sits with the Senate in the second reading.

Social media companies have already taken it upon themselves to define what is considered truthful by the standards of their platforms — like how frivolously

users have been de-platformed, de-monetized, disparaged and cancelled for disagreeing with the narrative — or with inaccuracies of the 'Fact Checkers', hired by Big Tech, often without specialized knowledge.

One might think this is a good reason to allow the CRTC to take tighter control of social media. Yet how are we to trust that the CRTC can neutrally fulfill this role, without bias, given what many would see as an apparent recent conflict of interest? — having made a decision

row, in a year, a decade or even a generation from now? Where do we draw the line in outsourcing our knowledge and critical thinking to the Elite Globalists who influence politics throughout the world?

The worldwide lockstep response to Covid-19 could be interpreted by many as the largest psychological operation experienced by the human race. Allowing the media to control the messaging of medical information gave them the ability to instill fear using skewed

statistics resulting in a widespread sort of culture shock. Their protocols forced restraints on the social fabric of humanity, with very little evidence that these methods are effective. 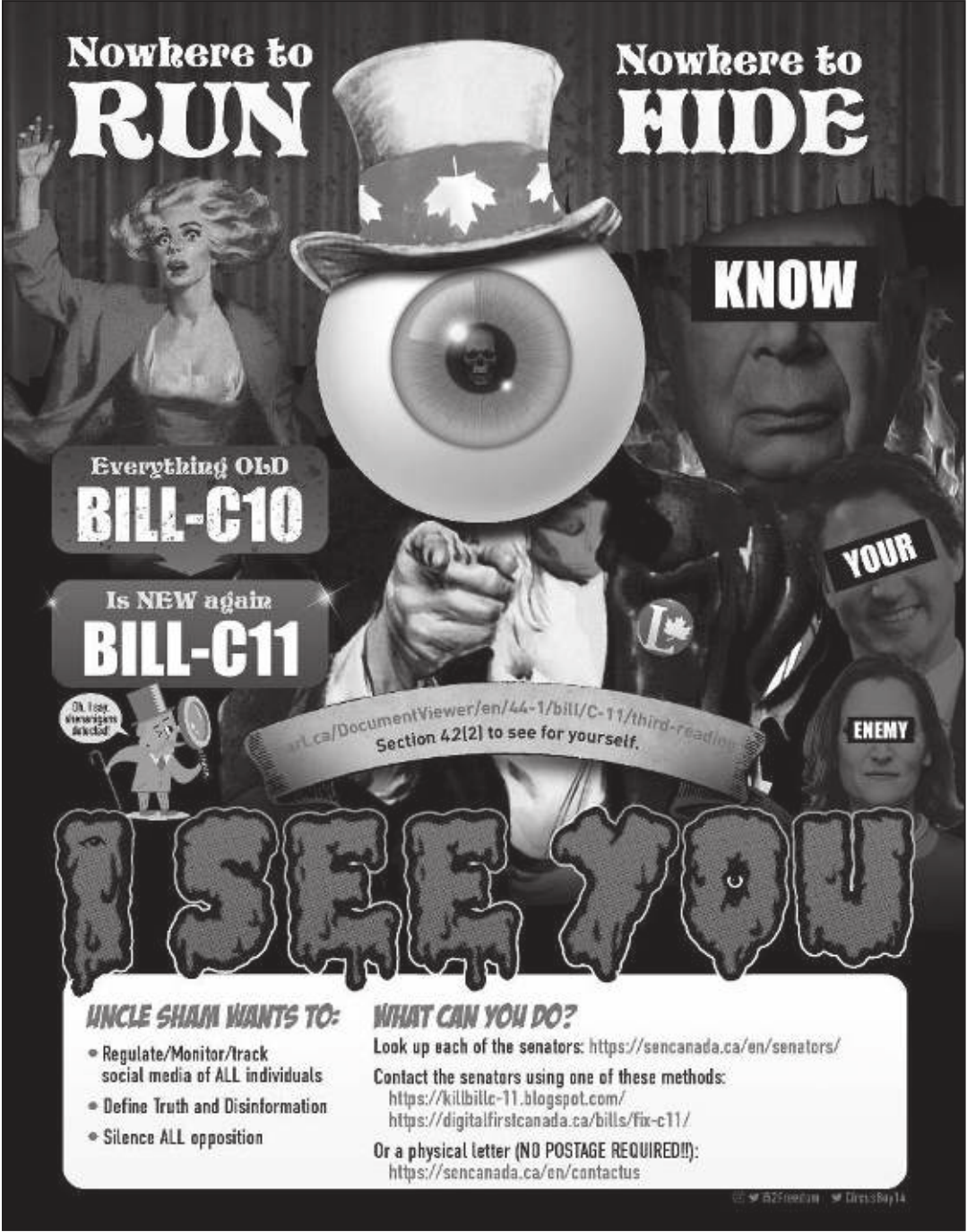

## Without safe elections, there is no democracy

I come to you in an effort to secure support for an action to protect the integrity of municipal elections in Ontario.

Many municipalities across Ontario have contracted with Scytl, a technology company based in Barcelona, Spain to provide internet and phone voting in municipal elections on October 24<sup>th</sup>.

The problem is that Scytl works in cooperation with Dominion Voting. There is credible video evidence from around the world that these voting services are not secure and can be manipulated. There is also credible evidence the mail-in process for voting can be undermined by fraudulent voting.

We must remove ourselves from contracts with Scytl. Without safe elections, your vote may not count. Without safe elections, there is no democracy. I contacted my local municipal council and asked

them to reconsider their decision to work with Scytl. I encourage you to determine if your municipality is working with Scytl and if so, do the same. Ask your Mayor, Deputy Mayor and councillors to vote for a reconsideration of this contract. Urge them to present/support a motion which includes the following elements:

1. One day elections -- no mail-in ballots;
2. Identification required to vote;
3. Votes counted on election day with the results presented the same day; and
4. Paper ballots only -- which can be recounted and confirmed for accuracy.

Having been in political office, I am confident that a vote of reconsideration is still possible given the timelines between now and the municipal election.

We need to return to closely controlled paper ballots that can be recounted and confirmed for accuracy.

Thank-you for considering my appeal. These are perilous times. Please take action.

## Retirement Home? or Political Prison?

The conditions in publicly funded long term care facilities have long been less than ideal but most are not aware of the conditions in private retirement facilities. With the illogical and inhumane lockdown rules imposed during this pandemic, it has become even more unbearable for our elderly. Lockdown after lockdown has been justified by faulty positive tests from residents with few to no symptoms (i.e. runny nose or scratchy throat). How could Public Health officials see this as sufficient grounds to separate and lock away seniors and leave them feeling lonely for extended periods of time? Solitary confinement is how prisoners are punished. Have they no consideration for the mental health of seniors who were likely already missing their families? Now they were condemned to solitary confinement for reasons that some could not even understand.

The latest lockdown in July 2022 affected 6 out of the 300 residents directly — one tested positive for Covid and because the other five shared the same

dinner table — all were confined to their rooms for 10 days. Their rooms were not cleaned, nor the beds changed for this entire period. This is both unsani-

tary and cruel treatment of human beings. One senior was so traumatized that he stopped eating and drinking for the full 10 days. It is a miracle that he is still alive and doing well.

Another shining example of absurd rules during this particular lockdown was the attempt to make the dining area “safer” by piling everyone into one room instead of using the two available rooms. The facility

I work for has a large dining room as well as a smaller tearoom. However, the new Covid protocol stated all residents were now to be restricted to just the dining room, while only 10 feet away, the tearoom was locked up and empty. Additionally, the hairdresser was denied access to the facility for the lockdown period and the tuck shop was closed. Residents requiring incidentals like toothpaste and tissues were forced to go without. Where is the logic in this?

One would naturally assume that in a health care facili-

ty, cleanliness and personal hygiene would be of the utmost importance. Keeping patients comfortable and clean should be top priority and an automatic

given, yet this is not the case. For example, for each resident, PSWs only have access to 2 facecloths, 2 hand towels and 2 shower towels for an entire week. One facecloth is for hands, back and face, while the other is for peri-care. Can you imagine using the same washcloth everyday on the peri area? I believe this is leading to multiple urinary tract infections among residents as using a dirty cloth is not sanitary. In an attempt to prevent this, PSWs will try to use strategies such as using the opposite end of the same hand towel for different areas. There is no opportunity to use extra cloths as they are locked up.

Nothing is included with the \$4000 monthly rent except 4 walls and meals served in the dining room — no services at all — EVERYTHING is extra!! Some of the extra costs include (roughly): \$56 for a 30 minute room cleaning, \$17 for a mealtime reminder, \$7 for a meal tray delivered to a room, \$100 for help with a shower, \$500 annually for maintenance and \$500 monthly to have a nurse dispense medication.

To make matters worse, last month the residents received notice of a rent increase of \$130-\$180 monthly. This is nothing short of highway robbery of our vulnerable seniors. They are paying more and more for less and less. These private corporations do not give a damn about our seniors. They only see dollar signs.

To illustrate this point more clearly, let me tell you what happened to a resident just one week ago. A lady fell during her stay at the facility and was admitted to hospital. When she returned, she was in a wheelchair and also had a urinary catheter. This lady drinks copious amounts of liquids, thus filling her catheter bag often. In talking to her, I was very upset to learn that she is not seeking help to have the bag emptied regularly because she knows it costs her more money every time a nurse walks through her door.

Is this how we want our seniors to be treated? I should hope not! And now Doug Ford wants to privatize all health care. This is not good news for Canadians at any stage of life. In short, our seniors are being fleeced and extorted by our governments, health officials and private corporations. We need to stand up and protect them. We will all be seniors someday.





# Pfizer’s COVID-19 mRNA Product is 13-Times Less Effective at Preventing Infection With SARS-CoV-2 than Naturally Acquired Immunity

A high-impact peer-reviewed scientific paper was just brought to my attention. It has been accepted for publication but has not made it into the print version of the journal yet. It was posted ‘online ahead of print’ back on April 5th, but I had not seen it until today. The paper is entitled “**SARS-CoV-2 Naturally Acquired Immunity vs. Vaccine-induced Immunity, Reinfections versus Breakthrough Infections: a Retrospective Cohort Study**”. It is being published in the journal *Clinical Infectious Diseases*, which has an impressive impact factor of 20.999. For a layperson, this means it is one of the top medical journals in the world.

Here is the take-home message as concluded by the authors in the discussion section of the paper:

“Our analysis demonstrates that SARS-CoV-2-naïve vaccinees had a 13.06-fold increased risk for breakthrough infection with the Delta variant compared to those previously infected, when the first event (infection or vaccination) occurred during January and February of 2021. The increased risk was significant for a symptomatic disease as well.”

This study represents a critical head-to-head comparison of naturally acquired immunity to SARS-CoV-2 versus the SARS-CoV-2-specific immune response conferred by the two doses of the Pfizer-BioNTech mRNA product that was required to obtain the so-called ‘fully vaccinated’ status. This largely occurred in the context of the wave of cases that was dominated by the Delta variant. People whose first exposure was to natural infection with SARS-CoV-2 were compared to those whose first exposure was via receipt of Pfizer’s mRNA product. In other words, which source of ‘immunity’ could confer the best long-term protection against infection with SARS-CoV-2, which is the virus that causes COVID-19 in some people.

As demonstrated in this paper, **people whose immune**

response was induced by Pfizer’s mRNA product were at 13-times greater risk of being infected with SARS-CoV-2 as compared to people with naturally acquired immunity! For those who had received Pfizer’s mRNA product, **this increase in risk of infection also translated into a greater risk of the infection progressing to the disease that we call COVID-19.** This news will be shocking for many. However, for many of us who have actually

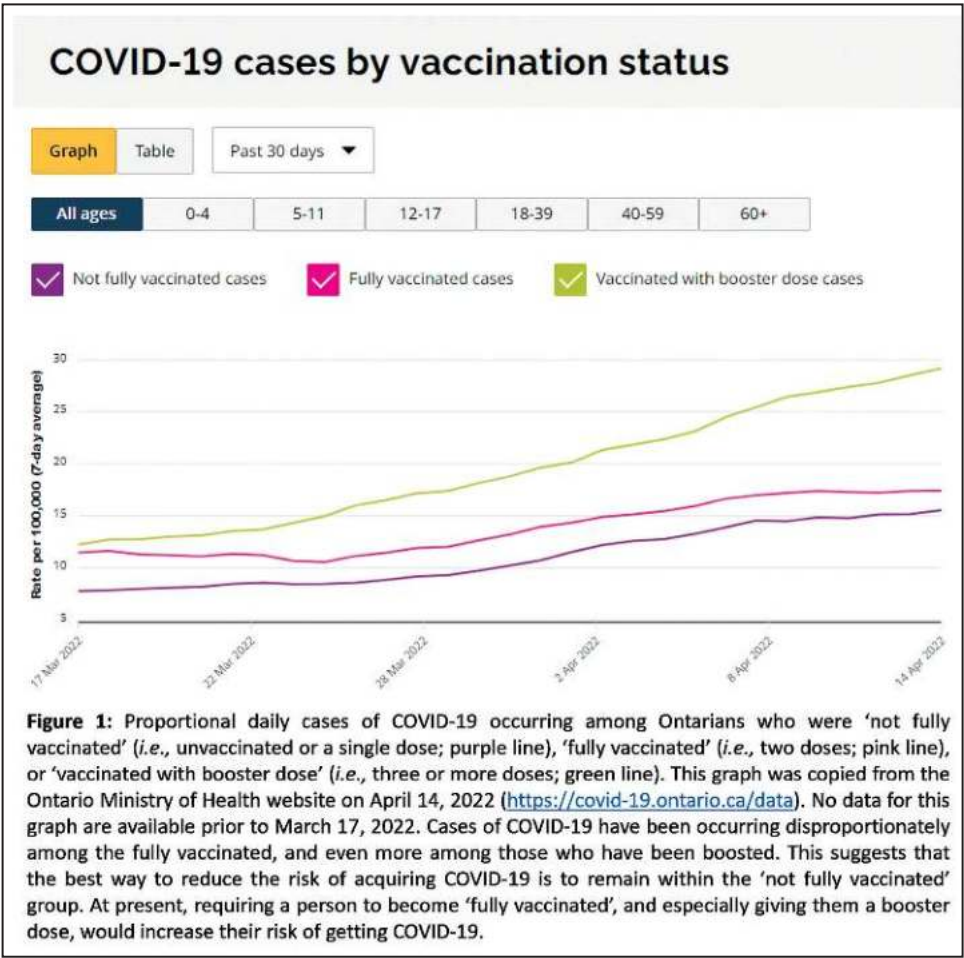
those with broadly reactive naturally acquired immunity. This was based on a plethora of public health data. I used this particular figure to highlight the additional risk posed by three or more doses. Some of this risk is likely accounted for by an increase in ‘risky behaviours’ by inoculated individuals who have become over-confident about the misleading information that overestimates the effectiveness of the shots. But a bigger concern is the potential for vaccine-enhanced infection or similar harmful mechanisms.

Here is an interesting side-note. As has been happening at high frequency throughout the declared pandemic, readily accessible and easy-to-digest data like those shown in Figure 1 above are no longer provided to the public. Check for yourself. Go to the same link from which I acquired the graph on April 14th. The best that you can do is get tabulated raw data that you would need to graph yourself. Public health agencies should be held accountable for failing to consistently provide fully transparent and highly informative data in easy-to-interpret formats. They should also be questioned as to why they have constantly changed the way data are provided and shown; apparently correlating with when the data start to consistently contradict the so-called ‘acceptable narrative.’

## Human Immune Systems Can Still Function Naturally in the Year 2022

What the scientific article by Gazit, *et al.* tells us is that naturally acquired immunity against SARS-CoV-2 is superior to the limited protection conferred by Pfizer’s mRNA product. This is just one of >150 peer-reviewed scientific publications that now confirm that natural immunity against this particular virus is better in every way to what can be conferred by the Pfizer shots. # World Climate Declaration - “There is NO Climate Emergency”

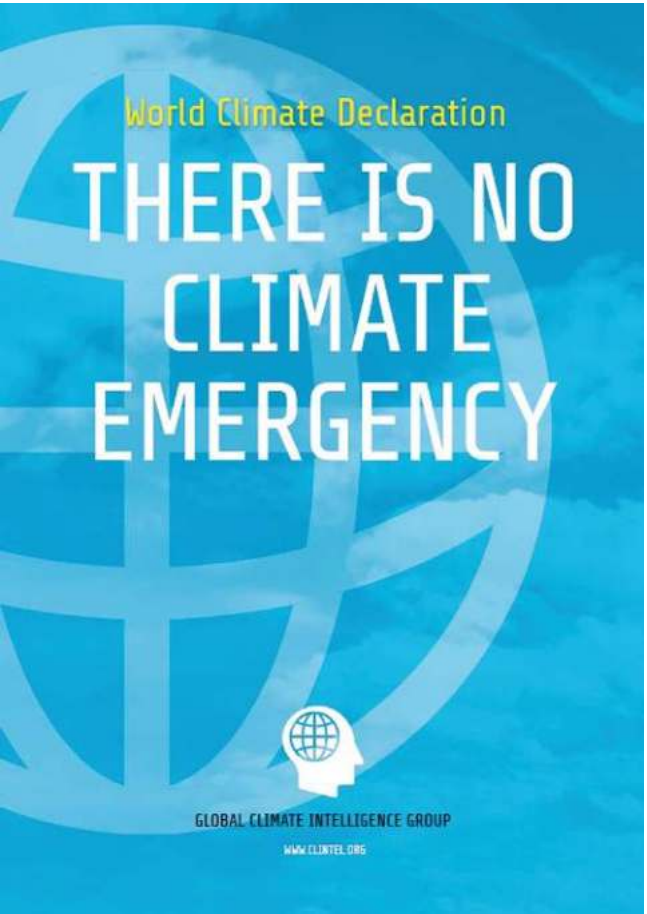

# The Sky Is Falling

*“The sky is falling! The sky is falling!” cried Chicken Little. And the sky fell, and no one listened, and all was still.*

A scholarly literature search for “electromagnetic” + “biological effects” produces the astonishing number of 76,400 studies, more studies than for most other environmental threats, yet the world continues on, looking yet blind, listening yet deaf, mistaking silence for comfort, the advancing flames for a bright future.

On the Dutch island of Texel, being the south end of a line of islands separating the Wadden Sea from the North Sea, a large breeding colony of seabirds called Sandwich terns (“great terns” in Dutch) made headline news recently by dying. Of the 7,000 birds nesting in the De Petten nature reserve until the end of May, none were left by the middle of June. 3,000 avian corpses were collected, and the rest either died or abandoned their nests.

The correspondent who sent me this news, Antonia in the Netherlands, also sent me to a Dutch website that monitors all cell towers and antennas throughout the country. The tern catastrophe was being blamed on “bird flu” and she suspected something else might be going on. When I looked at the website I was floored. The first 35 dead terns at De Petten were found on May 29, 2022. There are three cell towers on the edge of the reserve, and actually *in* the territory which the terns inhabit. According to the website, 18 new 4G antennas had just been added to those towers — 6 by Vodafone to its 83-foot tower on May 25, 2022, and 12 by KPN to its 108-foot tower on May 29, 2022. The number of frequencies emitted by those two towers had increased overnight from 5 to 11.

In addition to having all those antennas right *at* the reserve, De Petten is located on the northern edge of a waterway that separates the North Sea from the Wadden Sea, and a large number of antennas on both sides of that waterway — the antennas in Den Helden to the south and the antennas on Texel to the north — are aimed at that busy waterway, which is intensely used by the ships that continually pass through it. Consequently, according to my research, there are a total of 105 4G antennas within 7 miles of De Petten that are aimed directly at it.

Were Texel’s Sandwich terns already in bad shape from all the radiation they had been exposed to in the last few years? And did the sudden increase in both the number of antennas and the number of frequencies finally kill them?

I decided to investigate further. What I have discovered, both in the Netherlands and elsewhere, is consistent but not simple. Here are some rough rules:

- (a) *A sudden dramatic increase in the number of antennas and frequencies whose source is within a breeding colony or on its border is lethal. Nesting birds cannot avoid the radiation; they must either abandon their nests or die.*
- (b) *The effect of antennas aimed at a breeding colony from a distance depends on the human population. In a sparsely populated region, the antennas emit little radiation and few frequencies because few people are using them. By contrast, cell towers located in major ports are heavily used, both by residents and ships, and emit maximal radiation. The same is true of antennas aimed at heavily used shipping lanes.*
- (c) *Distance does not matter as much as terrain and tower height. The radiation from a taller tower travels further. And when there is nothing but water between the tower and the bird colony, the water reflects and amplifies the signal and distance matters very little.*
- (d) *4G towers are generally worse than 5G towers. This is because 4G towers broadcast their radiation in all directions while 5G towers emit most of their radiation in focused beams, aimed directly at people holding 5G phones in their hands.*

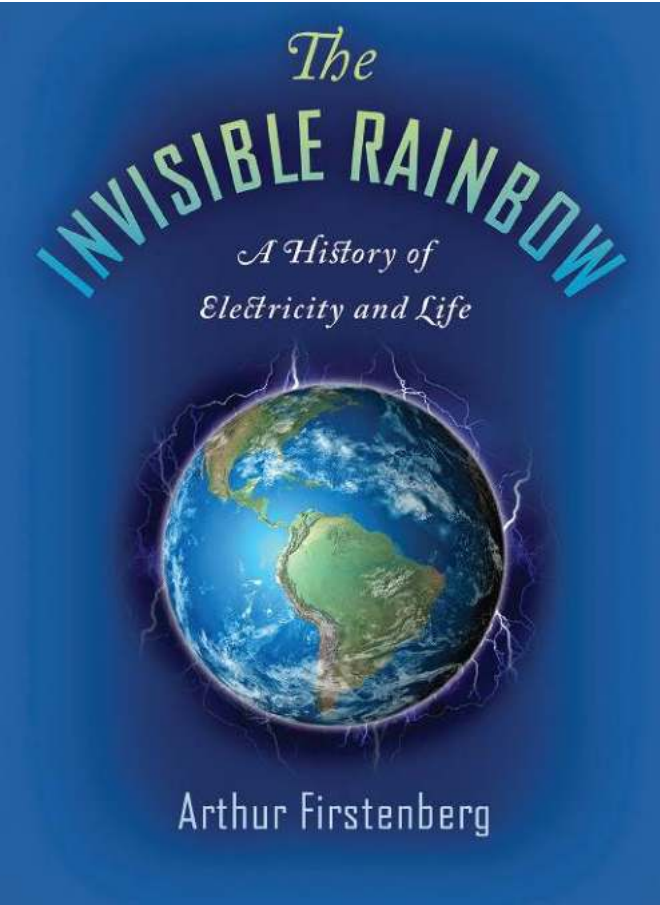
With these rules in mind, let us look at a few other breeding colonies of Sandwich terns and see what has happened to them this year:

Another large breeding colony of Sandwich terns made headlines a bit later, and for the same reason: the one at Waterdunen, at the opposite end of the Netherlands, in Zeeland province. Like De Petten, the Waterdunen nature reserve is located on a busy shipping lane at the entrance to a busy port. The largest colony of these birds in the Netherlands, Waterdunen hosted 7,000 pairs of terns that flew up from Africa to breed there this spring. But on June 24, 2022, it was reported that 4,600 dead adult and young Sandwich terns had been collected there during the previous two weeks. By the end of June, this colony no longer existed either.

The nature reserve at Waterdunen has 318 heavily-used 4G antennas aimed in its direction from distances of from 0.5 to 8 miles. Most of these emit between 1,000 and 2,000 watts of radiation each. 46 of these antennas are new, having been added to existing towers in April, May and June 2022. One 55-foot tower less than 2 miles down the beach from Waterdunen was upgraded on May 18,

2022 from 6 antennas to 12 and from 2 frequencies to 4. Another, 40-foot tower in the same location was upgraded on June 22, 2022 from 6 antennas to 18 and from 2 frequencies to 6. As Sandwich terns live on fish, that tower is within the foraging area for that colony.

Did the same thing happen to all nesting Sandwich terns in the Netherlands? No. Just 20 miles from Waterdunen was a small, healthy colony of terns at a nature reserve called Yerseke Moer. And from April to July, i.e. throughout the 2022 nesting season, this colony thrived and no dead birds were found there. Unlike De Petten and Waterdunen, this reserve is located in a relatively isolated place, is not near a major port and is not on a shipping lane. A total of 35 4G antennas are aimed at this reserve from distances of up to 8 miles. Only two of those antennas have been added



since April.

**Likewise in France**, two very large colonies of terns had two completely different experiences. At the Platier d’Oye nature reserve near the port of Calais, a colony of 3,000 Sandwich terns began nesting in April. The first 100 dead birds were discovered on May 20, and within a few weeks the colony was almost completely wiped out.

The situation at Platier d’Oye is similar to that further north in Texel: dozens of new 4G and 5G antennas were added near the reserve during the months of May and June. 3 new 4G antennas and 6 new 5G antennas were added to an existing 90-foot cell tower bordering the reserve. Another 6 new 4G antennas and 6 new 5G antennas were added to an existing 140-foot tower about two miles to the southeast. Another 6 new 4G antennas and 6 new 5G antennas were added to an existing 95-foot tower about two miles to the east. At this writing there are the astounding number of 355 antennas of all kinds on 26 towers at 13 locations ranging from 10 feet tall to 255 feet tall within about 4 miles of this nature reserve.

**An even larger colony — the largest breeding colony of Sandwich terns in France — had no disease during the 2022 breeding season.** It is called the Polder de Sébastopol and was host to several thousand pairs of nesting birds. But like Yerseke Moer, it is on an isolated island with few human residents. The island’s land area is largely devoted to parks, nature reserves and visitor accommodations. None of the antennas on the two cell towers a half mile west of the Polder are aimed at it. And even though there are a large number of antennas between one and four miles away that are aimed directly at the Polder, no ships pass by offshore and those antennas are little used except by visitors to the reserve walking its trails.

Looking at the details and different experiences at particular breeding colonies of these birds, the official story breaks down. How can one make sense of the extermination of so many of these birds in a matter of a few weeks in such widely scattered places? According to the bird conservation organizations, bird flu is so contagious that it spreads among Sandwich terns all over Europe in a matter of days, yet it is so *non*-contagious that a small colony of terns 20 miles away escapes scot-free. Bird flu travels from one end of the Netherlands to the other in a few days, but not between two Dutch colonies 20 miles apart, and not between the two largest colonies in France?

Apparently the conservation organizations also do not think it strange that suddenly and for the first time ever, in 2022, bird flu is (a) killing Sandwich terns and (b) is occur-

ring during their breeding season. In decades of monitoring them, bird flu has never affected Sandwich terns before anywhere in the world. And it has always been a seasonal disease, occurring only in autumn and winter, and has never before affected any types of wild birds in spring and summer until 2022. It has also never affected so many different kinds of wild birds at once — terns, seagulls, avocets, gannets, skuas, guillemots, puffins, oystercatchers, ducks, geese, godwits, pheasants, magpies, sanderlings, storks, cranes, pelicans, herons, swans, loons, sparrows, pigeons, red-winged blackbirds, owls, cormorants, grebes, dunlins, crows, ravens, bald eagles, hawks, falcons, vultures. Both the bird organizations and the authorities are reacting reflexively by wearing masks and hazmat suits when they visit these colonies and handle dead birds. **But they should begin questioning the cause of such an unprecedented catastrophe.**

There is no doubt that sick birds have tested positive for a virus called H5N1. But when every testing laboratory is constantly amplifying fragments of that virus in untold numbers of PCR tests, one has to suspect that the walls, floors, air, equipment, and personnel in the testing laboratories are contaminated with this virus. When one remembers that samples from a goat, a quail and a papaya, sent to the National Health Laboratory of Tanzania, all came back positive for COVID-19, the results of PCR tests, whether for people, birds, or fruit, should be regarded with caution. Yes, both birds and people are getting sick and dying, but there is another obvious factor that is being ignored. The tendency to blame all illness on microorganisms is destroying our world.

It is the uncontrolled irradiation of our world that is killing us and wiping out all the birds. Both 4G and 5G antennas are being erected more quickly and in greater numbers than ever before, not only on land but even on the surface of the sea. Wherever there are offshore wind farms, the cell phone companies are placing cell towers on those platforms. Seabirds will soon not only have no place to lay their eggs and raise their young, but they will not even be able to hunt for their food and feed their young without being irradiated. The largest company building cell towers on the surface of the sea is called Tampnet. In 1918, at the very height of the Spanish influenza, attempts by medical teams in Boston and San Francisco to demonstrate the contagious nature of the flu met with complete and resounding failure. They collected mucous secretions from the mouths, noses, throats, and bronchi of sick flu patients in various stages of the disease and transferred these secretions to the noses, throats, and eyes of hundreds of healthy volunteers. They injected blood from sick flu patients into healthy volunteers. They had healthy volunteers sit nose to nose with severely ill flu patients while they spoke to each other and then the patient coughed five times directly in the face of the volunteer. None of the volunteers got sick in any way. These experiments were published in the *Journal of the American Medical Association*, the *Boston Medical and Surgical Journal*, and *Public Health Reports*.

Horses also came down with influenza, and similar failures attended attempts to transfer influenza from one horse to another. As a result of these experiments, Lieutenant Colonel Herbert Watkins-Pitchford wrote that he could find no evidence that influenza was ever spread directly from one horse to another.

Many are the scientists, over the years, who have observed that influenza, whether in humans, horses, birds, or pigs, is an exceedingly strange disease. No one has ever explained why the flu is seasonal, for example. Or why flu epidemics end. Or why out-of-season epidemics do not spread. Or why flu epidemics explode over whole countries at once, and disappear just as miraculously, as if suddenly prohibited. Or how human influenza can spread around the world in days, and has always done so, even centuries ago when neither airplanes, automobiles, railroads, nor steamships existed. At least 23 scientists over the years, including Richard Shope, the scientist who first identified the flu virus in 1931, have published papers questioning the contagious nature of the flu and/or suggesting an electrical cause for it.

Chapters 7, 8 and 9 of my critically important book, *The Invisible Rainbow: A History of Electricity and Life*, are devoted to a complete, detailed examination of the history and science of influenza. Chapter 16, the longest chapter in the book, is devoted in part to the effects of electromagnetic radiation on birds. I suggest that all bird conservation organizations should acquire my book and read it carefully.

1. Iodine (daily)
2. Magnesium glycinate (daily)
3. Boron/zinc/vitamin D/vitamin K/Vitamin C (daily)
4. Quercetin (daily or weekly)
5. Melatonin (daily)
6. N-acetylcysteine aka NAC (daily)
7. Glutathione (daily or weekly)
8. High quality daily multivitamin with selenium, iodine, vitamin A, vitamin E, B vitamins, trace elements, etc.
9. Probiotic/prebiotic (daily)

10. Fish oil/flax/chia (daily)
11. Lemons (weekly)
12. Chlorophyll rich foods or supplements (daily)
13. Green foods and cruciferous vegetables (daily)
14. Milk thistle/dandelion tea/astaxanthin (weekly/monthly)
15. C-60 (occasionally)
16. Chloride dioxide/MMS (occasionally)
17. Colloidal silver (occasionally)
18. DMSO ointment (occasionally)
19. Hydrogen peroxide nebulized
20. Essential oils in diffuser: pine needle, frankincense, myrrh, clove, rosemary etc.
21. Pine needle tea/artemisia tea (monthly)  
\*do not drink if pregnant
22. Intermittent fasting (weekly/monthly)
23. Infrared sauna
24. Regular cardiovascular exercise and sweating (preferably in nature)

Get a rat and put it in a cage and give it two water bottles. One is just water, and one is water laced with either heroin or cocaine. If you do that, the rat will almost always prefer the drugged water and almost always kill itself very quickly, right? — within a couple of weeks. So there you go. It’s our theory of addiction.

Bruce came along in the ’70s and said, “Well, hang on a minute. We are putting the rat in an empty cage. It’s got nothing to do. Let’s try this a little bit differently.” So Bruce built Rat Park, and Rat Park is like heaven for rats. Everything your rat about town could want, it’s got in Rat Park. It’s got lovely food. It’s got sex. It’s got loads of other rats to be friends with. It’s got loads of coloured balls. Everything your rat could want. And they’ve got both the water bottles. They’ve got the drugged water and the

normal water.

And here’s the fascinating thing...

In Rat Park, they don’t like the drugged water. They hardly use any of it. None of them ever overdose. None of them ever use in a way that looks like compulsion or addiction. There’s a really interesting human example I’ll tell you about in a minute, but what Bruce says shows that both the right-wing and left-wing theories of addiction are wrong. So the right-wing theory is it’s a moral failing, you’re a hedonist, you party too hard. The left-wing theory is it takes you over, your brain is hijacked. Bruce says it’s not your morality, it’s not your brain; it’s your cage. Addiction is largely an adaptation to your environment.



# The Freedom Movement in Canada is Growing

When the Covid-19 ‘Pandemic’ first emerged in Canada, only a small number of people recognized it as a tool of control and enslavement by the ruling class. However, as a result of our government’s unprecedented heavy-handedness, obvious hypocrisy and lack of legal, medical, or moral justification for the ensuing mandates and restrictions, we now have a growing population in Canada awakening to the unwarranted assault on our individual freedoms.

This is partly because, as numerous as our voices have become, we are not yet all speaking with one voice. We are not yet united.

### The Truckers’ Freedom Convoy

The Truckers’ Freedom Convoy gave us the best glimpse of what unity actually looks and feels like. It is not just a collective agreement around what is right; more fundamentally, it is an experience of the shared feeling of love, care and respect that human beings have for one another. And those who were in Ottawa during the Freedom Convoy got that magical feeling everywhere they turned.

One of many stories that embodied this feeling of unity involved a cook from Quebec, who had stocked his truck up with breakfast supplies and drove to Ottawa with a mission to feed breakfast to all the truckers for free. He began his work in front of Parliament Hill early in the morning and saw that many others had brought food for the truckers as well. It was not long before the truckers had all been fed, and so he began giving food away to passers-by, so festive and generous was the mood.

Soon, someone insisted on giving a donation out of gratitude, and put some money into a cup on his table. The cup filled up quickly, and the cook used it to replenish his food supplies once he ran out. This continued throughout the day, and eventually there was still plenty of food, plenty of money, but no more hungry passers-by. That’s when the cook recruited a few people to bring food to the homeless in the city wherever they could find them.

This story illustrates the unity we are all seeking: it is a heart-centered connection between human beings, as well as respect for each other’s uniqueness. What people experienced in Ottawa is that the people can — in fact we need to — create this unity ourselves. We don’t need any ‘authority’ to do it for us. And that is why the Freedom Convoy was so threatening to the ruling class. Because if we realize that we can do this ourselves, then the ruling class is no longer needed.

The government used many tried and true tactics to shut down this seminal effort, including violence, ridicule, and deception. They labeled brave individuals like organizers Tamara Lich and Pat King as ‘leaders of the occupation’ and tried to convince us that these ‘leaders’ were responsible for crimes by putting them in jail. This is right out of their social engineering playbook, to make us feel shame by association and forget that the Truckers’ Freedom Convoy was a triumph of the human spirit over tyranny and oppression.

The greatness of the Trucker’s Freedom Convoy was not inspired by any ‘leader’ but rather by the authenticity of the courage and sacrifice of many truckers simply trying to live and work in freedom. It motivated many people in Canada to come together, onto frigid bridges to wave on the convoy as it passed through, and into Ottawa and other locations, to be part of a genuine experience of comm-unity.

### Many Still Look to Leaders

The version of ‘unity’ brought forward by the ruling class is always based on control and fear, like a dog coralling sheep. This has maintained some form of ‘order’ in society over the centuries, but it has always come at the expense of personal freedom. For humans to be united on the basis of freedom, each individual needs to know at a deep level that they are inherently sovereign. The challenge is that many in the Freedom Movement have not yet had this deep realization, and as a result, they are still waiting for ‘freedom leaders’ to unite us.

This is exactly what the ruling class wants. They don’t mind that new political parties are formed, because political parties will naturally support the current top-

down power structure, no matter how much the candidates are running on a ‘freedom’ platform. I don’t doubt that some of the political freedom candidates are sincere in wanting to bring more freedom to Canadians. But one has to wonder if, even in the unlikely case that such a politician gets into power, whether they will be able to unite us. The very fact that they have not all been able to unite into one party under the fundamental principle of freedom gives a telling clue.

Yes, one can argue that political systems do bring people together, but the people only end up united around one polarity or another, usually based on a subset of their core values and the appeal of the leader. When people identify with and unite under one polarity (i.e. ‘liberal’), it ultimately activates more unity around the other polarity (‘conservative’), resulting in division and ideological conflict that will keep going on until the end of time. All issues in society are perceived through this dialectical prism, and so reconciliation is impossible. Since people always have the other side to blame, they are never encouraged to look at themselves and take some responsibility for the problems of society. The individual is thus constantly disempowered. The fact that we can choose one polarity or the other provides the illusion of free choice. But this system doesn’t make us free, it keeps us trapped and dependent.

Creating a free society which respects the innate sovereignty and uniqueness of each individual is ultimately not a political matter. It is a spiritual one. Our broader mission as ‘freedom fighters’ is not any particular act of defiance; it is the promotion of a shift in consciousness within each individual. We will never get there by putting a different leader or a different political party in power; we will only get there if we find the courage to begin to walk away from this obsolete top-down power structure entirely.

### The People’s Union

I created the People’s Union of Canada as an umbrella group that, rather than endorsing any particular strategy or action, offers local support to each group and each individual who are standing up for freedom, through support teams within each electoral district across Canada. Our mission is ‘to unify the freedom movement in Canada and build the decentralized human network that will support it.’

The union is rooted in a freedom declaration so simple, so fundamental that everyone can agree on it: “I am free.”

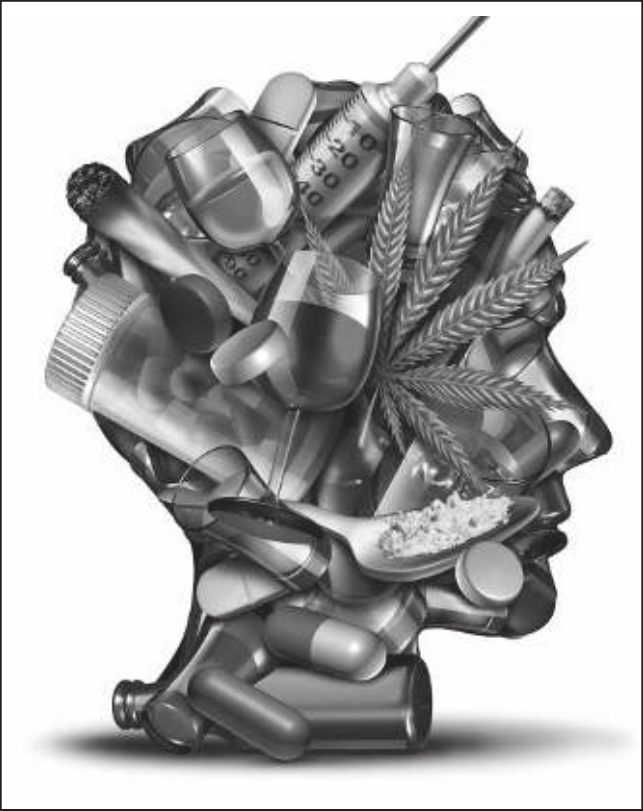
We don’t declare “I wish to be free,” “I ask to be free” or even “I demand to be free.” **I am free.** This declaration has profound consequences, as it causes each individual to deepen the embodiment of their own sovereignty. to induce sub-par responses compared to natural immunity because we still have an imperfect understanding of the inner workings of the immune system. However, when it comes to responses induced by Pfizer’s mRNA product, they have obviously fallen far below the gold standard of natural immunity.

### Another Call for Critical Thinking and Promoting Scientific Debate

I understand that many people are completely sold-out on the single public health narrative that has been deemed acceptable by power brokers. However, for the sake of their safety, that of their loved ones, and to avoid unnecessary mandate-induced segregation of the well-informed again, they really need to start critically assess-

ing the science and asking tough questions of their physicians, public health officials and others who are promoting these inoculations. Following are a few examples of questions for which answers should be demanded. Importantly, demand that a person’s answers be backed up by original science. Have them show you their reference(s). Hearsay evidence based on things like ‘because so-and-so said it is true and they seem to have a good reputation’ carries no weight. I am an expert in vaccinology and this has been officially confirmed in many court cases. This does not preclude me from having to provide references to justify all of my major assertions, nor should it. A fact is not defined by a person’s reputation. Scientific principles are defined by the weight of the scientific evidence.

### Key Questions

1. Why would I want to get a ‘vaccine’ targeting an outdated version of the SARS-CoV-2 spike protein that leaves me at a 13-fold greater long-term risk, compared to natural immunity, of getting infected with the virus and acquiring the disease that it is supposed to protect me against?
2. I keep hearing that the ‘vaccine’ will dampen the severity of disease. Isn’t the best way to dampen severity by not acquiring the infection and the disease in the first place? As such, why is the importance of natural immunity being downplayed?
3. If naturally acquired immunity is superior to immune responses conferred by Pfizer’s inoculations, why hasn’t testing for acquisition of natural immunity been made a priority? In Canada, we shut-down our task force assigned to monitor acquisition of naturally acquired immunity early in the declared pandemic.
4. Why would anybody want to push a ‘vaccine’ on me without first knowing my natural immunity status, especially since the latter has proven to be superior to the former?
5. Why would anyone push Pfizer’s mRNA product on children who are at almost no risk of experiencing severe COVID-19 when their immune systems are naïve to SARS-CoV-2; and worse, when the vast majority already have superior naturally acquired immunity?
6. When most people have likely been exposed to SARS-CoV-2, especially following the highly infectious Omicron wave, why are outdated booster doses being promoted?

# News From Around The World

## British Communist dubbed ‘Stalin’s nanny’ Appointed to the World Health Organization (WHO)

British scientist and longstanding Communist party member Susan Michie has been appointed Chair of the World Health Organization’s Technical Advisory Group on Behavioural Insights and Sciences for Health. Professor Michie was a member of a sub-group advising SAGE, the UK government health advisory body that imposed Draconian lockdowns and mandates.

The health psychology professor was a keen advocate and zealot in trying to bring about stringent Zero-Covid communist style restrictions in the UK including a Christmas lockdown. Michie was a regular contributor on mainstream TV and radio with constant doom-laden forecasts. She once called opening up society again as building terrifying new “variant factories.”

In an interview on Channel 5 in 2021, when pressed about the timeline of masks and social distancing, she said: “I think forever, to some extent.” During the same interview, she compared and normalized Covid restrictions to wearing a seatbelt and picking up dog poo in a park.

Michie was a key player in weaponizing fear by using covert psychological tactics on the population to push the Covid narrative in the UK. It comes as no shock that the WHO would appoint the ilk of Susan Michie to their ranks. Recently re-elected to serve a five-year term, Director-General of the WHO Tedros Adhanom also has a questionable communist past.

Originally from Ethiopia, he grew up in the northern Tigray region and became a member of the communist leaning Tigray People’s Liberation Front (TPLF). He rose through the ranks of the TDLF party leading to important roles in the Ethiopian government first as health minister and then as foreign minister.

A former Nobel Peace Prize nominee, David Steinman, has accused Tedros of genocide for his alleged role in directing security forces to kill and torture its own people from 2013-2015. Steinman has lodged a complaint at the International Criminal Court in the Hague. Tedros has denied the allegations.

Steinman claimed that while Tedros was in a senior government position, the regime was ‘marked by widespread or systematic crimes against humanity by subordinates’. Steinman was a foreign advisor to the Ethiopian democracy movement for 27 years.

Tedros is a close ally of the communist regime in China and heaped unwanted praise on their initial Covid response back in January/February 2020. He hailed the Chinese response to Covid as ‘beyond words’. It is no coincidence that China has made financial contributions to both the Ethiopian aid budget and to the WHO while Tedros has been in charge.

It comes as no surprise that the WHO have selected a self-confessed communist to their ‘Nudge Unit’. Susan Michie will fit right in with her new ‘commie’ friends.

## French Farmer Wins Court Case Over 4G Phone Tower

A resolute farmer in central-east France recently won a battle in court resulting in a court order requiring local authorities to temporarily turn off a 4G antenna for two months over animal welfare concerns on his farm.

According to Mr. Frederic Salgues, since the installation of the 4G antennas in July 2021 — 200 metres from his farm — 40 of his 200 strong herd had died, his herd were feeding less, and milk production had decreased by nearly 20% within days of the cell phone tower being switched on. He added, “There are no medical elements that could [otherwise] explain this brutal drop in milk production.”

In May 2022, the administrative court in Clermont-Ferrand ruled in favour of the French farmer by stating that, “it is appropriate to order the temporary cessation of the operation of this antenna for a period of two months, taking into account its general impact, with monitoring, by the judicial expert, of the behaviour of the herd, and of the dairy cows in particular, during this period.”

The mobile network operators who installed the 4G antenna now have three months to act on the court hearing recommendations. A judicial expert has been tasked with monitoring and supervising the entire process to record data and compile a detailed report in their findings to see if there is a possible link between the antenna and the odd behaviour from his livestock.

In 2021, in a separate incident regarding 5G technology in France, two Catholic monks based near Lyon were arrested for setting fire to a 5G antenna. According to Agence France-Presse (AFP), the men admitted to the crime, telling a local prosecutor that they acted to “protect the population from the harmful effects of 5G.”

After the positive court ruling, Mr. Salgues told AFP news that he hoped his cows would be able to “recover as soon as possible” and called the case ruling, “a major relief, redemption and a victory.”

In Europe and beyond, farmers are leading the charge against authoritarianism and are proving not to be messed around with.

## No Clear Evidence That Depression is Caused by a Chemical Imbalance According to University College London Research Team

Researchers from University College London (UCL) have published eye-opening findings that may have a seismic shift in how we view and treat depression.

Joanna Moncrieff, lead author of the study and professor of psychiatry at University College London said: “It is always difficult to prove a negative, but I

think we can safely say that after a vast amount of research conducted over several decades, there is no convincing evidence that depression is caused by serotonin abnormalities, particularly by lower levels or reduced activity of serotonin.”

“The popularity of the ‘chemical imbalance’ theory of depression has coincided with a huge increase in the use of antidepressants...”

“Thousands of people suffer from side-effects of antidepressants, including the severe withdrawal effects that can occur when people try to stop them, yet prescription rates continue to rise.”

Co-author of the research Dr. Mark Horowitz reacted to their findings by saying: “I had been taught that depression was caused by low serotonin in my psychiatry training and had even taught this to students in my own lectures. Being involved in this research was eye-opening and feels like everything I thought I knew has been flipped upside down. It is high time to inform the public that this belief is not grounded in science.”

The UCL team also highlighted that many studies found that precipitating external factors such as stressful life events can increase likelihood of depressive features. More pluralistic treatment options such as psychotherapy alongside practices such as exercise, self-care, and mindfulness, or addressing underlying perpetuating factors such as poverty, stress and loneliness can greatly help with low mood, was recommended by the researchers.



Dr. Horowitz said: “One interesting aspect in the studies we examined was how strong an effect life events played in depression, suggesting low mood is a response to people’s lives and cannot be boiled down to a simple chemical equation. We believe the situation has been driven

partly by the false belief that depression is due to a chemical imbalance.”

The ground-breaking umbrella peer-review meticulously examined all relevant studies and research published on depression and serotonin. The detailed review can be found in the scientific journal Molecular Psychiatry under the title: The serotonin theory of depression: a systematic umbrella review of evidence.

The professor and consultant psychiatrist, Moncrieff, also questioned the efficacy of antidepressants by stating: “Our view is that patients should not be told that depression is caused by low serotonin or by a chemical imbalance, and they should not be led to believe that antidepressants work by targeting these unproven abnormalities. We do not understand what antidepressants are doing to the brain exactly and giving people this sort of misinformation prevents them from making an informed decision about whether to take antidepressants or not.”

A diagnosis of depression and the instant subsequent prescription of antidepressants is hugely profitable for pharmaceutical industries. The money-making pharmaceutical industry has freely worked hand in hand with psychiatry for decades with only minimal inquiry into its over-simplification methods and faulty consensus.

Antidepressant drugs rank third in pharmaceutical sales worldwide. According to a report from Fortune Business Insights, the global antidepressant market size is projected to reach USD 18.29 billion by 2027.

It is high time that enlightened health professionals and service-users question the psychiatric and big pharma industry over its inaccuracies, pseudo-science, and reliance on popping pills.

## Norwegian Woman Faces Jail Time for Stating Biological Facts

A Norwegian self-described feminist is facing up to three years in prison due to a number of no-nonsense common sensical tweets asserting that men cannot be lesbians. .

Between February 2021 and January 2022, Christina Ellingsen, a member of the global feminist organization Women’s Declaration International (WDI), tweeted, “Why (does) FRI teach young people that males can be lesbians? Isn’t that conversion therapy?”

Her not so controversial tweets were directed at Christine Marie Jentoft, a representative of a Norwegian self-described feminist is facing up to three years in prison due to a Norwegian trans-female activist group Foreningen FRI. Jentoft was born a biological male but now identifies as a lesbian woman.

Another tweet that has reportedly being deemed as hate speech read: “Jentoft, who is male and an advisor in FRI, presents himself as a lesbian-that’s how bonkers the organization which supposedly works to protect young lesbians’ interests is. How does it help young lesbians when males claim to be lesbian, too?”

In response to the investigation Ellingsen spoke with Reduxx, a pro-woman, pro-child safeguarding news online platform. She said: “I am under police investigation for campaigning for women’s rights, because to certain groups, the fact that women and girls are female and that men cannot be women, girls, mothers or lesbians, is considered hateful.”

“Women are not protected against hate speech in Norway, but men who claim to be lesbian and a woman, are protected both on the grounds of gender identity and on the grounds of sexual orientation.”

“The fact that police are legally able to investigate and prosecute women who engage in women’s rights is concerning. This is new territory in Norway, so the outcome of the investigation is important, both if the case is dismissed and if it leads to a trial.”

Once again George Orwell was prophetic when he said, “The further a society drifts from the truth, the more it will hate those that speak it.” Speaking common sense and stating the obvious will soon be seen as a revolutionary act.

## Some Of The Most Absurd Things That Have Happened In Recent Weeks

- **Quadruple vaccinated Dr. Fauci** —head of the NIAID — **tests positive for COVID-19 for the 2nd time** after experiencing symptoms that were “much worse than the first time round.” He is referring to this second infection as a “rebound” case of COVID.
- The **University of Western Ontario reinstates its mask policy and mandates Covid-19 boosters** for all students, staff and faculty on campus this fall — a first in Canada. The university implemented these mandates despite Ontario Public Health’s data ([url for wayback machine: https://covid-19.ontario.ca/data#casesByVaccinationStatus](https://covid-19.ontario.ca/data#casesByVaccinationStatus)) showing an alarming trend of the triple-vaccinated getting COVID-19 at rates of more than double that of the unvaccinated group.
- **The British Columbia Center for Disease Control buries the evidence.** The BCCDC chose to “retire” the Outcomes by Vax data and Vax Donut Charts with no explanation. The charts, archived on [drtrozzi.org](https://drtrozzi.org) —see Aug 8 article — shows that those who are triple vaccinated are at a dramatically increased risk of dying from COVID-19.
- UK Government office of National Statistics releases a health data report titled “Deaths by Vaccination Status, England, 1 January 2021 to 31 May 2022” which finds that **unvaccinated individuals are showing the lowest mortality rates per 100,000 people in every age group in England** as compared with individuals who have had the COVID jabs.
- New research out of *The New England Journal of Medicine* (Boucau et al.) finds that both the **COVID vaccinated and the boosted were contagious for a longer period of time compared to the unvaccinated.**

- Researcher Brian Shilhavy queried the CDC’s Vaccine Adverse Event Reporting System (VAERS) and discovered a **shocking 10,661.4% increase in cancer reports as a result of COVID-19 gene-based vaccines** as compared with all other FDA-approved vaccines combined, over the last 30 years.
- As an “update” to Greece’s “**COVID Free GR Wallet**,” the **government of Greece introduced “Digital ID cards”** where digital copies of people’s IDs —and soon, other documents — may be viewed and verified using a QR code. As the country’s digital governance minister Pierrakakis put it, “(this) is a very good example of how one service creates the conditions for

- the next.”
- **OnlyFans squashed competitors** in the online porn industry through a bizarre scheme that bribed Meta employees to **place thousands of porn stars onto a terrorist watchlist**, resulting in their content being “shadowbanned” across various social media sites, according to a group of explosive lawsuits.
  - **The Japanese government launches a nationwide**



- competition to encourage young people to drink more** in an effort to raise tax revenue. The nationwide competition to boost alcohol consumption calls for citizens to create new product designs and ways to promote more home drinking. There will be an awards ceremony in November recognizing the best campaigns and innovative ideas.
- Recently released **Transport Canada documents reveal that the intention behind travel restrictions for unvaccinated Canadians was purely one of pressure to increase vaccine uptake**, and not for any valid medical reason. In a document titled “*Risk of COVID-19 Transmission Aboard Aircraft*,” the department confirmed that “the risk of spread of COVID-19 amongst passengers while travelling aboard aircraft appears to be low” citing a report showing a 1 in 27 million rate of flight-related transmission. A memorandum signed by Transportation Minister Alghabra stated the desired ‘indirect benefit’ of the mandates as one that “should act as a catalyst to increase Canada’s overall vaccination rate.”
  - **Unvaccinated mothers are now facing up to \$50,000 in maternity leave repayment to the BC Government.** New or expectant mothers working in the BC Public Service who are not completely vaccinated against COVID-19 are being asked to pay back their whole maternity leave top-up benefit and are at risk of losing their jobs.
  - A forensic report by Manitoba resident Ken Drysdale titled “*Investigation into Criminal Allegations Concerning COVID-19 Pandemic Response*” shows, among many other shocking statistics, in 2020, **women of childbearing age were nearly twice as likely to die of murder than COVID.** According to Statistics Canada, 20 women aged 20-40 contracted

and died of (or, more accurately, *with*) COVID. To put this into perspective, there were 341 suicides and 39 murders of women in that same age group.

- **Former CDC Medical Officer, Dr. Jeffrey Klausner, calls out inaccurate COVID death count.** In an August 24th tweet, Dr. Klausner said, “*Given every hospitalized and dying patient is tested for COVID, we can expect ‘Covid deaths’ forever. Test every patient for staph, count those as staph deaths, we will always have staph deaths. The COVID death counting system does not work.*” Back in late June of 2020, Toronto Public Health tweeted that “*Individuals who have died with COVID-19, but not as a result of COVID-19 are included in the case counts for COVID-19 deaths in Toronto.*” During Ontario’s June 23, 2020 news conference at Queen’s Park, Health Minister Christine Elliott also confirmed that everyone who dies with COVID is counted as a COVID death in Ontario.

- Canadian Taxpayers Federation document reveals there was a whopping **66% increase in federal employees making over \$100K** last year. In 2021, there was a total of over 114,000 federal workers who made more than 100k.
- Five months after the CEO of OneAmerica Insurance announced that deaths among people aged 18-64 were up 40%, newly released records show that the US’s 5th largest life insurance company, Lincoln National, paid out **163% more for deaths of working people ages 18-64 in 2021** compared to the last 2 years.

The company cited “non-pandemic related morbidity” and “unusual claims adjustments” when explaining their losses.

- Germany’s largest health insurer, Techniker Krankenkasse, reveals **1 in 25 clients underwent medical treatment in 2021 for COVID vaccine side effects**, an increase of 3000% from the previous two years.
- In a time of record-setting inflation seen in the US (a 40-year high) Biden signs “**The Inflation Reduction Act**” into law. The problem is this act “**will have no measurable impact on inflation**” according to Oxford Economics economists, a sentiment echoed by the University of Pennsylvania’s Penn Wharton Budget Model. Strangely, most of the spending on this bill will be going towards “clean energy” as well as tax credits for people who buy electric vehicles.
- A new study titled *Cardiovascular Effects of the BNT162b2 mRNA COVID-19 Vaccine in Adolescents* (Mansanguan et al.) found that **cardiovascular effects in recently vaccinated adolescents were found in 29.24% of participants**, 2.33% of participants exhibited at least one elevated cardiac biomarker, **.66% developed pericarditis**, and **.33% developed Myocarditis**. These numbers are much higher than Public Health Ontario’s records (.00014% of boys aged 12-17). This study illustrates the fact that active systems like this study, where all teenagers were screened, will always find more cases than passive systems, like the reporting system here in Canada where doctors fill out an application after a child has been properly diagnosed. There is potentially a huge number of cases of children with chest pain or fatigue that are never brought to a doctor or are misdiagnosed and are thus never captured in the statistics.
