## 15 Minute/Smart Cities Utopian Dream or Dystopian Nightmare?

**A Smart City is an urban environment with omnipresent surveillance and data harvesting technologies that will monitor and record even the most intimate, personal details of everyone.**

The goal is to know everything about everybody: what you eat and drink, where you go, what you buy, who you meet, what you think, how you feel, your opinions, your habits, your health and vaccination status, and so on. Every. Little. Detail. The justification for this all-encompassing surveillance is that it is supposedly essential to "save the planet" from climate change. They also guarantee it will make your life more connected, safer and healthier.

Every aspect of life in a Smart City will be monitored by a wide variety of data harvesting technologies: SMART Lights, SMART Poles, SMART Cars, SMART Neighborhoods, SMART Homes, SMART Appliances, SMART Energy, SMART Transportation and many other SMART technologies. Together they will form an omnipresent surveillance grid, continually collecting all information about every little detail of the life of the people.

### Smart Cities create the Internet of Bodies (IoB)

These external SMART devices are being synchronized with devices that are directly connected to the human body, like SMART watches on our wrists or SMART phones in our hands. These devices are able to gather information about what is happening inside our body and even have the ability to alter functions of the human body. In the near future, they will be implanted inside the human body to collect even more data and have a lot more influence on what happens inside of us.

The personal information gathered by these billions of devices worldwide form a network called the Internet of Bodies, or in short, IoB. Again, a "wonderful idea to save the planet": lock the world population up inside Smart Cities, where they "enjoy life" in a virtual realm.

There is zero privacy in a Smart City

The World Economic Forum wrote an article on Forbes.com that describes the experience of a citizen inside a Smart City, who praises it as heaven on earth: "How come we never thought of this before?" One of the characteristics will be that no one will own anything. Everything will be shared: homes, cars, tools, even clothes. At the end of the post, the citizen expresses one concern about life in a Smart City:

*"Once in a while I get annoyed about the fact that I have no real privacy. Nowhere I can go and not be registered. I know that somewhere, everything I do, think and dream of is recorded. I just hope that nobody will use it against me. All in all, it is a good life."*

The central nervous system of Smart Cities will be 5G. According to former Chilean president Sebastián Piñera, 5G is not only able to read our thoughts, but can also insert thoughts and emotions into everyone. He stated that it will become the central nervous system of society, and he guaranteed that they will make sure it reaches every home in the country. Interestingly, all streetlights in Smart Cities are also concealed 5G antennas.

### Smart Cities harvest everyone's data

Why do they want everyone to live in Smart Cities, and what is their motivation behind recording every little detail about all of us? The answer is given by Israeli professor Yuval Noah Harari, who is an advisor to the

World Economic Forum. He explains:

*"The new masters of the world will be those that own the data."*

The wealth of today is no longer gold or oil. It is data. The more data a corporation, government, or banking imperium has about the population, the more power it affords them. Smart Cities will be an unprecedented way to use humanity as one massive herd of data cows.

**Personal data will be milked from us all day long, and even while we sleep.**

Apart from gathering tremendous amounts of data, these technologies also allow for levels of control that are unheard of in previous civilizations. A former Silicon Valley engineer, Aman Jabbi, is sounding the alarm that Smart Cities will essentially be open concentration camps:

*"By giving them your data, you give them the ability to monitor and assess your behavior, which can now be converted into a social credit score. That score is then used to determine what privileges you qualify for and which ones you don't in the new slave society."*

This social credit score is already being deployed in China, and during the 2020 pandemic, many nations implemented the

first steps toward this system of control. Digital IDs and digital currencies will be at the center of this grid. When people disobey, or criticize the system, their spending will be curtailed, and access to basic aspects of society will be blocked. Again, this is happening already in China, which is the testing ground for the rest of the world.

### Will Smart Cities edit the human genome?

A concerning fact about Smart Cities is that all the streetlights include new LED technology, which may have the ability to manipulate the circadian rhythm, human behaviour, and gene expression.

Klaus Schwab, founder of the World Economic Forum, promotes the agenda of human gene editing. He openly says it will change what it means to be human. WEF advisor Yuval Harari even goes as far as to state that financial elites will split from humanity, as they will be genetically edited to become far superior to normal people. Economic inequality will become biological inequality. Harari says elites will become "Homo Deus": divine beings, or gods.

If all these ideas weren't being promoted worldwide by people and groups such as Bill Gates, Barak Obama, CNN, Facebook, the United Nations, the World Economic Forum, and countless other outlets of the elites — we would surely think it's the script of a science fiction movie! # Parents, It’s Time to Take a Stand

# United Nations Seeks Totalitarian Power During ‘Global Shock’ Response

The United Nations (UN) produced a series of 11 ‘Policy Briefs’<sup>[1]</sup> in the spring of 2023 under the theme “Our Common Agenda.” These provide specific ideas about how the UN wants to achieve its Sustainable Development Goals, while the policy briefs still leave a lot unsaid. One of the briefs proposes that the UN assume international management of certain ‘global shocks.’ I have taken some of the language straight from this UN policy brief<sup>[2]</sup> on page 12: *When the world faces a complex global shock, we must ensure that all parts of the multilateral system are accountable for contributing to a collective response. No single agency exists to gather stakeholders in the event of complex global shocks. The United Nations is the only organization that can fulfil this role.* I propose that the General Assembly provide the Secretary-General and the United Nations system with a standing authority to convene and operationalize automatically an Emergency Platform in the event of a future complex global shock of sufficient scale, severity and reach.

The UN claims that the ‘only’ way we can adequately respond to global emergencies (which the UN terms complex global shocks) is through the UN, by galvanizing global action. However, this is obviously not the only way to approach emergencies affecting multiple countries, since we have managed so far without the UN’s emergency platform. Another concern is using the terms “standing authority” and “operationalize automatically” the emergency platform. ‘Standing authority’ means that the UN Secretary-General has already been given the authority by the UN members and can then use it at will. ‘Operationalize automatically’ suggests no further authority would be needed for the UN to use its new emergency powers. This opens the door to the UN Secretary-General declaring an emergency or shock using his standing authority and then the UN would automatically take charge, directing countries what they must and must not do. The problem is that disaster management is always local. Local resources deal with the problem immediately when it occurs. State, national or United Nations troops, supplies, and logistics take days or weeks to organize and arrive. Central authorities generally swoop in after the emergency has already been managed. We certainly don’t need central governing authorities telling the local authorities what they can and cannot do, when in fact they are the only ones there at the scene of the emergency. What emergencies does the UN think we might need them to manage? The policy brief<sup>[3]</sup> offers



this list of global shocks on page 6. An emergency could be declared over climate! Or a disruption to the internet or grid. An event in outer space (which may not even be noticed on earth) might lead to the UN asserting itself to manage things. The UN appears to be jockeying with the WHO to manage pandemics and bioterrorism, even though the

WHO is rushing through a pandemic treaty and new International Health Regulation amendments that do the very same thing, right now. Worst of all, the UN has said that ‘black swan events’ might trigger the UN to take over. Black swan events<sup>[4]</sup> are incidents that are unusual and unexpected. In other words, the UN could declare any kind of crisis it likes, a ‘black swan event,’ leading the UN to jump in and manage whatever it is. But the problem is that the UN has no expertise or staff with experience managing all possible crises. Furthermore, UN staff are not elected by the world’s population and are not accountable to them. Turning over the authority for managing ‘global shocks’ to a political agency that can choose the shocks it wants to manage, and how it wants to manage them, seems foolhardy at best.

# WILDFIRES: Living in Hell

## Shuswap B.C. Residents Angry at Government Incompetence

People are as mad as hell in temperatures that feel like hell!

Wildfire temperatures range between 800-1200°C, and, in those ungodly temperatures, locals in the Shuswap region of British Columbia are fighting for their homes, businesses and lives. Meanwhile, the government is more concerned about looters. There are more military and police to be seen than fire-fighters. Some have said, “There are no forestry people to be seen. There is no one here from BC Wildfire Services.” While this is not 100% true, indeed, the leadership from any one of the many government agencies supposedly on the scene is non-existent. It seems a free-for-all mayhem, more reminiscent of Mardi Gras than a first-world fire scene.

In one of the most deadly fires to hit BC in decades, temperatures are rising in other ways. People are angry; they feel betrayed and abandoned and they are not going to take this lying down. Told to stay in their homes and behave, they feel like bad dogs kenneled and punished for wanting to help. However, this is a community that doesn’t blindly follow rules, especially when the rules are nonsensical and downright stupid. These rules are creating further destruction, under the guise of keeping everyone safe. Safe? How can what the government is doing be called safe, as fire rips through communities at break-neck speeds, in one day traveling 20 km in 12 hours, leaving no time for residents to prepare for evacuation? With much of Canada literally on fire, the government lacks both the equipment and the manpower to fight the fires alone. While public safety is their go-to reason for denying help from public resources, their reason serves to support their ultimate goal — more Canadians homeless and dependent on government resources.

Canadians are going to fight, especially in areas like the Shuswap, where families have been connected to the land for generations. While many locals have experience that far surpasses that of the help brought in from Mexico, more than anything, they have the spirit, the heart and the drive to save their homes and communities. Why is their help not being embraced? Angela Lagore, a long-time resident in the Shuswap and part-owner of The Hub (a restaurant in Scotch Creek) had plans in place to use the restaurant to provide frontline workers with meals. Their plans were thwarted, however, when efforts to retrieve supplies being delivered by boat were blocked by the RCMP because they didn’t have a permit. At the infamous one-lane bridge outside of Scotch Creek, locals with food trucks and critical supplies such as gas, propane and pumps are being blocked by military and police, with threats of arrest if they attempt to cross the bridge.

Meanwhile, back in the blazing mountains and hills of the Shuswap, thousands are working tirelessly, many for days, with little to no sleep, insufficient food and limited supplies. On August 18, Premier David Eby enacted the Emergency Act (EA), designed to give the province, the ability to better serve and protect the residents of the Shuswap. Their efforts have failed miserably! It feels more like oppression than protection. Eby enforced the strictest laws in the province, giving the government full rights in the Shuswap, while the residents of all but one community lost theirs. Strangely, Anglemont, at the northern end of the lake, has escaped the tyranny. In talking to the locals there,, it’s hard to believe they are experiencing the same fire on the same lake as the rest of the communities. They can move around freely, purchase gas for their generator and launch their boat in the lake at a public marina — activities that the rest of the residents on the lake are forbidden to do.

While every community from Scotch Creek to Celista and beyond is under the merciless rules of the dictatorial Emergency Act, Anglemont eats, drinks and is merry. Families there praise the firefighters and are eager to help out at the Lakeview Community Centre. It is impossible to fathom that the same fire that rages directly behind Anglemont Mountain is the one

that has destroyed countless homes, ravaged stunning forests and left an unrecognizable charred mess that screams incompetence. Why is Anglemont exempt from the hardships that the EA has imposed on the other communities? Why do they have privileges that neighbouring communities do not and why aren’t they even on alert? Are they being lulled into a false sense of security only to become the next community burned to the ground? So, while thousands are fighting for their homes and lives, unable to obtain the necessities required to survive, Anglemont residents are feeding the firefighters and those in need with the compassion and community that marks this precious region.



At some imaginary line that divides Anglemont and Celista (a community decimated by the famous backburn), the latter residents are being treated like second-class citizens with spike belts on the streets and in lockdowns far too reminiscent of the Hitler-like days of Covid. Desperate for necessities such as food, water and fuel, they are extinguishing hotspots, mostly with back-breaking work and simple shovels. While they clamour for equipment and help, I am told that firefighters sit in their camps, drinking coffee under orders to stand down. A friend of mine who is a professional logger and heavy machinery operator, has been formally trained to fight fires as is the requirement for all loggers in the province. He is experienced and knowledgeable, yet he sits outside the ring, watching inexperienced young Mexicans who have never fought wildfires on terrain like this.

Residents, working like slaves in the heat, desperate for much-needed water, see fire trucks drive by, loaded with water. The firefighters wave and keep going, “Just following orders”, they say. Meanwhile, heavy machinery that could be building fireguards remains unused, newbies are fighting the fires, and experienced firefighters are barred from helping. My logger friend also told me that after fighting one fire successfully, the company was told they were too efficient and too opinionated and weren’t invited back. In other words, they knew what the hell they were doing! BC is also home to Coulson Aviation, a global leader in aerial firefighting, emergency personnel transport and other industrial heavy lift operations. Where are they when we need them? They usually spend the summers fighting fires in the US and countries as far away as Australia and Chile. Since 2015, they have only been called in to fight one fire in BC and that was in 2021.

We are experiencing our worst wildfire season ever in the province. We have the best aerial firefighters in the world at our doorstep and, while the rest of the world appreciates their expertise, the BC government stupidly thumbs their nose at them. Choosing cheap, unqualified, Mexican labourers over qualified Canadians just doesn’t make sense. The inexperience and lack of first-class firefighters have cost us billions. It is hard to fathom the frustration of the locals. They have at their feet the largest lake in the province and one of the top 10 water reservoirs in the world, yet without the proper equipment, they cannot access the water to fight the fires. Though helicopters carrying buckets of water are a normal part of firefighting in this province, that familiar sight and sound has been rare this summer. The government says it is because the boats in the lake made it difficult to access. Locals disagree.

One resident in the Meadow Creek area ravaged by

the backburn cries in anger and frustration. The government defends their backburn, a controlled burn of 14 km on one of the windiest nights of the summer. At approximately 4:00 p.m., with no notice to the residents in the area, the backburn was lit despite warnings of 40-50 km winds. As the wind changed direction, the “controlled” fire decimated three communities: Scotch Creek, Lee Creek and Celista. Defended by firefighters and government agencies, it was deemed a success. It saved hundreds of homes, they say. Success? Wiping out three communities is a success? Only a government wanting more citizens to be homeless and desperate for their 15-minute City agenda to thrive would call that a success.

The one star of the government show is Jay Simpson, the director of the CSRD (Columbia Shuswap Regional District). Everyone I talked to spoke highly of his diligent efforts, his communication skills and his constant presence. As a long-term resident of Lee Creek, Jay understands the mentality of his people. Many of them have been on the land for generations, on property bought by their parents’ parents. They have birthed babies and dreams on this land. They have nurtured generational relationships with both the community and their homesteads. They were born here and they intend to die here, but not in a fire, not if they can help it! They will not stand down. They will not sit down and obey orders.

They will fight for their homes and their lives.

It is hard not to be proud of the fighting spirit beaming in the Shuswap this summer. It has been challenging not to cry at the devastation of the beautifully scenic lake and tiny communities home to an eclectic mix of artists, boaters, families and farms. It is also hard to not be livid at the arrogance, stupidity and Nazi-like mentality of our government. It feels like us against them. With BC residents now paying the fourth-highest personal income tax rate in Canada and the US combined, we would like to believe that our taxes cover first-class services such as fire protection and a much-coveted lifestyle. However, it is time to wake up to the reality that we are more likely paying for stupidity, arrogance and incompetence. I would like to hear what the people of the Shuswap, who have now seen firsthand the inept use of our hard-earned dollars, have to say.

The land will heal; that is what it does. The trees will grow back; that is the marvel of Mother Nature. But, the fury of the residents of the Shuswap at what they see as an incompetent and ruthless government may take a whole lot longer.

# 14 U.S. Cities Planning to Ban Meat, Dairy, Private Cars by 2030

14 American cities have set a “target” to comply with the World Economic Forum’s (WEF) green agenda goals by banning meat, dairy, and private car ownership by 2030.

The U.S. cities have formed a coalition called the “C40 Cities Climate Leadership Group” (C40). The C40 has established an “ambitious target” to meet the WEF’s goals by the year 2030. To fulfill the “target,” the C40 Cities have pledged that their residents will comply with the following list of mandatory rules:

- “0 kg [of] meat consumption”
- “0 kg [of] dairy consumption”
- “3 new clothing items per person per year”
- “0 private vehicles” owned
- “1 short-haul return flight (less than 1500 km) every 3 years per person”

The C40 Cities’ dystopian goals can be found in its “The Future of Urban Consumption in a 1.5°C World” report.

The report was published in 2019 and reemphasized in 2023. The organization is headed and largely funded by Democrat billionaire Michael Bloomberg. Nearly 100 cities across the world make up the organization.

The American city members of C40 include:

Austin	Boston

Media coverage of C40 Cities’ goals has been relatively sparse. However, the few media personalities and news outlets who have discussed it have reportedly been heavily attacked by the corporate “fact-checkers.” In a “fact check” aimed at conservative commentator Glenn Beck, AFP Fact Check claimed that the banning of meat and dairy and limits on air travel and clothing consumption were actually “not policy recommendations.”

AFP quotes a paragraph from the original “The Future of Urban Consumption in a 1.5°C World” report, which reads:

“This report does not advocate for the wholesale adoption of these more ambitious targets in C40 cities; rather, they are included to provide a set of reference points that cities, and other actors, can reflect on when considering different emission-reduction alternatives and long-term urban visions.”

But this paragraph, likely included in the report as a liability in the case of pushback, seems to directly contradict the meaning of “target,” which in this context can be defined as a “desired goal.”

The target of eliminating meat, dairy, and private vehicles by 2030 is “based on a future vision of resource-efficient production and extensive changes in consumer choices,” the report notes — something its authors clearly hope to bring about.

If these were not their goals, they would not have labeled them “ambitious targets.”

The “fact-checker’s” insistence that C40 Cities’ explicitly stated climate goals are somehow insincere is even more unconvincing, given that we are watching them start to unfold right now.

This year, in lockstep with C40 Cities’ 2030 aims, New York City Mayor Eric Adams announced that the city will place caps on the amount of meat and dairy served by city institutions, such as schools and prisons.

Meanwhile, the U.K. has banned the sale of new gas-powered vehicles after 2030, and France has banned short-haul flights “to cut carbon emissions.”

In 2020, the World Economic Forum (which promotes C40 Cities on its website) introduced “The Great Reset,” which seeks to use the Covid pandemic as a point from which to launch a global reset of society to supposedly combat climate change.

This reset, however, has far more to do with social control than it does with the climate.

If globalist leaders truly cared about the environment, they wouldn’t be chartering private jets or owning massive, energy-consuming mansions on the coast in

California, which, by climate fanatics’ own calculation, will soon be underwater.

As the WEF plainly stated in a 2016 promotional video, by 2030 “You’ll own nothing, and you’ll be happy.” Right now, hedge funds and private billionaires are buying up residential homes and farmland all over the world.

At the same time, unrealistic zero-emissions policies are impoverishing Westerners and annihilating the middle class, which is fueling reliance on centralized government. Such intentional steps backward also, ironically,

harm the earth because wealthier nations are proven to have cleaner environments and put less strain on natural resources.

Climate activists are also advocating for “climate lockdowns,” in the same way there were Covid lockdowns. Ideas floated for a climate lockdown have ranged from shuttering people in their homes and restricting air travel

to providing a Universal Basic Income and introducing a maximum income level.

Climate dystopianism doesn’t end there. WEF-linked “bioethicist” Dr. Matthew Liao has proposed the idea of scientists genetically modifying humans to be allergic to meat, as Slay News reported.

Liao has also discussed shrinking the physical size of humans via eugenics or hormone injections so they consume fewer resources.

All of these policy proposals appear even more unreasonable and illogical when we actually evaluate the data.

According to the International Disaster Database, deaths related to extreme heat, floods, storms, and droughts have plummeted as C02 emissions have risen.

The fossil fuel economy has provided billions of people with heating, air conditioning, weather warning systems, mass irrigation, and durable buildings.

This isn’t to say that we shouldn’t try to limit carbon emissions.

Environmentally friendly nuclear energy, which is safe and more reliable than wind and solar energy, is a great way to wean our society off of our reliance on fossil fuels.

The globalist climate activists, however, oppose nuclear energy, further undermining their supposedly good intentions.

Ultimately, the climate coalition’s goals are inherently anti-human. People generally need meat and the protein it provides to flourish.

Banning meat and dairy, restricting calories, genetically altering the human body, and impoverishing the masses will hurt the planet and people.

More likely than not, it will do more than hurt people — it will kill many of them.

## Vancouver hospital suggests MAID to woman struggling with suicidal ideation

A 37-year-old woman who visited a Vancouver hospital for psychiatric help was instead offered assisted suicide, according to a report from a UK faith-based think tank.

According to the Christian Institute, Kathrin Mentler went to Vancouver General Hospital seeking psychiatric help in the midst of a mental health crisis.

Mentler says that she lives with chronic suicidal thoughts and sought out the hospital’s help to put herself in a position where it would be a lot harder for her to attempt an drug overdose or other self-harming behaviours.

“I didn’t want to get into a situation where I would think about taking a overdose of medication,” said Mentler.

“That day my goal was to keep myself safe. I was thinking of maybe trying to get myself admitted to hospital because I was in crisis.”

Mentler says that she arrived at Vancouver General’s Access and Assessment Centre and was told there weren’t any beds available for her, and that she should expect a long wait before she could see a psychiatrist.

At this point, Mentler says that she was asked if she had ever considered MAID (Medical Assistance in Dying), with the clinician telling Mentler about the “relief” she felt after patients with mental illness had committed suicide through MAID.

Mentler says that the clinician suggesting MAID to her made her feel like her life was “worthless,” and that she



was a problem that could be solved with MAID.

The Christian Institute reached out to Vancouver Coastal Health (VCH) who operate the hospital at which Mentler was offered MAID. VCH had apologized for any distress the incident caused, but claimed that suggesting MAID to patients was a matter of procedure to assess the patient’s risk of self-harm.

Currently, it is illegal to deliver MAID to Canadians who are not suffering from a grievous and irremediable medical condition and whose only medical condition is mental illness.

However, cases like Mentler’s have become more of a common occurrence, with several stories of medical staff offering MAID to otherwise healthy Canadians.

Last year, *Global News* published a report of a Canadian Armed Forces veteran who was inappropriately offered MAID by a Veteran Affairs Canada employee while seeking treatment for a traumatic brain injury and post-traumatic stress disorder.

Despite outrage from Canadians concerned with the ethics of allowing the mentally ill to kill themselves, the Trudeau government has pushed forward with making MAID easier to access for those suffering with mental illness, as on March 17, 2024, those seeking MAID can be accepted if their only condition is mental illness.

In 2021, a total of 10,064 Canadians died through MAID, representing 3.3% of all Canadian deaths that year.

# What the Mainstream Media Won't Tell you About the Maui Fires

The historic town of Lahaina on the island of Maui, a popular tourist spot, was destroyed by a fire that seemingly came out of nowhere. As of Monday morning August 14, the death toll sits at 96. An estimated 2,200 acres have been burned, over 2,000 buildings have been reduced to ash, and of those buildings, 86 percent of them were residential homes. The investigation is ongoing, loved ones are still missing, but alongside the rubble and ruin, questions remain.

Not so long ago, the band of islands we call Hawaii was a sovereign state known as the Kingdom of Hawaii. Because of its key location in the Pacific Ocean and its fertile ground, Hawaii was historically a prized place for trade. However, the kingdom fell when the United States gobbled it up under the whole notion of manifest destiny. With a little help from the U.S government, a group of American and European businessmen overthrew the Hawaiian monarchy.

You see, the Hawaiian Islands offered a key position for a U.S military base and would aid in the development of the U.S as a global superpower, and thus the final Queen of the Kingdom of Hawaii was deposed in 1893. From then on, Hawaii played a key role in the world stage. Just think about it, the Japanese attack on Pearl Harbor, which occurred on December 7, 1941, had a significant effect on the United States and was crucial in influencing the government's decision to enter World War II. It was also key in rallying the emotional support for war from U.S troops and civilians alike. Nearly a century later, there is open discourse on the idea that President Roosevelt either let it happen, as in, he had prior knowledge of Pearl Harbor and did nothing, or he caused it to happen — you know, the same conversation we have about George W. Bush. Alas, Americans would not and could not give their consent to war without a reason, they just needed to be given one: **problem, reaction, solution.**

At 11 a.m. on August 4, 2023, it was reported by satellites that a handful of small fires had started on Maui around the same time. No cause has officially been given, and this is a key detail that I just want to emphasize: it wasn't just one fire that was started, but several at once.

On Tuesday morning, August 8, Lahaina, once the Kingdom of Hawaii's Capital City, began to witness wildfires. Lahaina is a small town located in Maui, and in the Hawaiian language, Lahaina means cruel or merciless Sun. Survivors of the fire reported that there were no sirens or warnings when the fire started, only strong winds that brought distant fire into the residential areas within minutes.

According to emergency officials, Maui's warning sirens didn't sound as devastating wildfires approached as they should have. On the island of Maui, there are 80 outdoor sirens to alert residents of tsunamis and other natural disasters, but those sirens were totally silent as people burned to death. According to investigators, *"nobody at the state and nobody at the county attempted to activate those sirens based on our records"*.

Emergency alert texts were reportedly sent out, but due to the rate at which these fires spread, the towers were down, the power lines were down, and people weren't receiving those alerts on their phones or TVs —



all of which contributed to the chaos. The fires were so intense and spread so rapidly that the U.S Coast Guard saved over 50 individuals after some people fled the fire by jumping into the Pacific Ocean. The fires were still active the following day, and locals reported being barred from bringing supplies to the affected areas just to even search for their loved ones and render aid.

And this is another weird, strange detail: The Incident Commander of the 2017 Las Vegas country music mass shooting, one of the biggest cover-ups in U.S history, just happens to be Maui's police chief, John Pelletier, who said the following about the fires: *"To find these, you know, our family and our friends, the remains we're finding is through a fire that melted metal. We know we've got to go quick, but we got to do it right, so when we pick up the remains and they fall apart, and so when you have 200 people running through the scene yesterday and some of you, that's what you're stepping on. I don't know how much more you want me to describe it."*

Hawaii governor Josh Green said the town looked like a bomb had been dropped and he wasted no time blaming the fires on climate change. Of course, mainstream media ran with this narrative and has blamed humans for living and vacationing in Maui for the wildfires, which brings us into a whole other conversation entirely: who is actually responsible for the wildfires in Maui?

According to some locals, bad government and poor land management is to blame, as dry, non-native invasive grasses weren't properly cleared in previous years, which served as perfect tinder under the right conditions: strong winds and drought. And I want you to remember what we talked about earlier: satellites picked up all these fires across the island igniting around the same time, same day, the morning of August 4. It wasn't just one fire, it was multiple fires across Maui. And I'm not trying to interject my opinion when I say this, I'm just giving you the facts, but that in particular sticks out to me and I find it weird.

So of course, there's already a wrongful death lawsuit brewing, and *"legal teams from Watts, Guerra, Singleton, Schreiber, and Franz Law Group firms have all independently reached the conclusion that Hawaiian Electric's compromised infrastructure served as the ignition source for the inferno"*.

And I just want to point out that according to the World Economic Forum, in an article that they published in 2018, Hawaii plans to be the first U.S state to run entirely on clean energy, with clean energy being defined as solar, wind, biomass, and geothermal green power. And after someone sent me that article, I was

reading up on how our current power grid will stand up to the clean energy goals of the future, and basically, the corporations are lobbying for our entire power grid to be replaced. So if you fault Hawaiian Electric, sue them for all their worth, put them out of business — who replaces them? Will it be whoever is going to bring forth the goals of Agenda 2030 and the World Economic Forum?

So attorneys are blaming the electric company, probably because the electric company has the deepest pocket, the governor is blaming climate change, and other people are blaming land mismanagement. The average residential home in Maui is just at the median price of 1.2 million dollars. Can insurance companies afford to rebuild thousands of homes in this area? Can families who didn't have homeowners insurance afford to rebuild their homes and businesses with the rapid inflation we've experienced over the past couple years? The cost of building has increased substantially — what will insurance cover? Because I'm imagining a scenario where residents are left with land and no means to rebuild, nowhere to live in the interim, and yeah, that would make it hard to say no to offers on your property.

So my final question that the media would never ask is, are we witnessing a land grab at fire sale prices in the future?

# The Global Uprising Against CBDCs Has Begun

Stop the presses! Here’s my hot take for the day: **CBDC’s are a bad thing.**

OK, maybe that take is not so hot. After all, I don’t even need to spell out “Central Bank Digital Currencies” for my well-informed, switched-on readers to know what I’m talking about when I refer to CBDC’s. And the idea that a digital form of programmable money with a central banker’s on/off switch is a bad thing? Come on! Even the normiest of the normies can sense that.

But here’s the hot part of my hot take: CBDC’s are deeply unpopular with the general public and we have a chance of stopping them in their tracks.

At first glance, you might not think this is such a controversial statement, but really think about it for a minute.

If you listen to the stenographers and prestitutes of the establishment dinosaur media, you’ll believe that CBDC’s not only represent an exciting opportunity to bring our outdated paper money system into the digital age, but that they’ll be bestowed on us by the benevolent central banker technocrats in the next year or two (if we’re lucky!).

If you listen to the pundits in the alternative media, however, you’ll believe that CBDC’s not only represent the greatest threat to human freedom in our lifetime, but that they’ll be forced upon us by the evil central banker overlords in the next year or two (no matter what we do to fend them off).

Do you see the similarities in these two “competing” narratives? In both cases, you and your opinion about CBDC’s are utterly irrelevant. It’s a *fait accompli*. You can love ‘em or hate ‘em, embrace them or recoil from them, but whatever your position, you will be forced to use them.

But this just isn’t true. In fact, we’re already seeing a massive global pushback against the CBDC agenda. And this pushback is already causing the banksters to panic and to pull back on their grand plan for world domination.

Of course you’re not hearing about this CBDC pushback in the establishment media. Why would they tout their masters’ failures, after all?

But, weirdly enough, you’re not hearing much about this pushback in the alt media either.

Let’s correct that today, shall we?

## Global Pushback

As we all know, when globalists are looking for a population to test out their latest technology of enslavement, they turn to Africa. From genetic manipulation to vaccine experiments to agricultural “revolution,” there is no shortage of examples of pathocrats disguising their experiments in technocratic tyranny as philanthropic concern for the poor, beleaguered people of that continent. It’s hardly surprising, then, that Africa is once again serving as a laboratory for the latest globalist technocrat pet project: digital money.

Accordingly, Nigeria became one of the first nation’s in the world to adopt an official, national central bank digital currency when the Central Bank of Nigeria (CBN) launched the eNaira amid much fanfare in October 2021. Promoted with the slogan “Same Naira, more possibilities!” the bankster class collectively held its breath as it watched this trial run of digital money unfold before their eyes.

The early results of this experiment, however, were not promising for the money manipulators. Despite a massive push of the eNaira by the government and breathless coverage of its rollout in the establishment media, it was revealed one year after the digital currency’s launch that a mere 0.5% of the population — one in every 200 people — had actually used it.

Not to be dissuaded, the CBN imposed new banking regulations last December, limiting cash withdrawals from ATMs to just ₦20,000 (\$45) per day in a bid to increase adoption of the nation’s CBDC.

The result? Again, utter failure. In fact, worse than

utter failure. An actual uprising!

Nigerians took to the streets in February of this year to protest the cash restrictions and even attempted to storm the central bank.

CBN officials are now rearranging the deck chairs on the Titanic, upgrading the eNaira app to allow contactless payments, as if that was what was keeping people from using the banksters’ new digital enslavement tokens. But, try as they might to cover it up, the results of this experiment in monetary manipulation are now clearly visible for all to see. The eNaira is a failure of such gargantuan proportions that it now



serves as a cautionary tale to central bankers around the world about how pear-shaped things can get when a digital currency is shoved down an unwilling public’s throat.

But it isn’t just Nigeria where people are saying “no, thanks” to the banksters’ digital money agenda.

In the European Union, protesters are already marching against the European Central Bank’s (ECB) proposed “digital euro.” In Croatia, for example, activists are warning that their government’s adoption of the euro “will be followed by the introduction of a digital euro, and then you will have to kiss all the freedoms you know goodbye.” In the Netherlands, meanwhile, demonstrators have staged rallies warning about the coming European CBDC and the ECB’s plan “to control the spending habits of the population.”

In Russia, too — where Putin has just signed the Central Bank of Russia’s “digital Ruble” into law as an official national currency — people are already threatening to go Nigerian on their government. Recent polls show that a mere 6% of Russians are actually excited about their opportunity to use the new CBDC. This widespread distrust of the digital Ruble is reflected in the coverage of the currency in the nation’s alternative news websites, which are filled with articles decrying the technocratic tyranny. One such article sums up the situation by noting that “we can only say that if citizens actively use non-cash transactions, then they themselves will enter the electronic banking concentration camp, seemingly completely voluntarily.”

And how about in the bastion of liberty, the beacon on the hill, the good ol’ US of A? Well, the grandstanding politicians — always eager to get in front of a parade and pretend they’re leading it — are already introducing (and even passing) legislation to ensure CBDC’s never see the light of day in America.

Of course, readers of this column will know that these political promises aren’t worth the paper they’re written on. Nevertheless, the proposed legislation is important because it reflects two underlying realities. Firstly, it demonstrates that the American public is not on board with the CBDC agenda. And secondly, it signals to the Fed and other central banksters that they risk upsetting their whole rigged monetary system if they push this agenda too far and too fast.

## Banksters Running Scared

Yes, it’s safe to say that, on the CBDC issue at least, the momentum is not in the banksters’ favour. In fact, things are so bad that the establishment is now begin-

ning to contemplate whether the mad dash toward CBDC’s might just wake up the public to the whole monetary scam.

In a revealing op-ed in *The Financial Times* last month, Brookings Senior Fellow Eswar Prasad warned, “Central banks must not be blind to the threats posed by CBDC’s.” After dutifully detailing all of the nifty features of programmable money that would-be world controllers can take advantage of (“imposing negative nominal interest rates to disincentivise saving,” for example), he then cautions the central banksters that their pretense of “political neutrality” might be exposed for the self-evident sham that it is if central banks start meddling in people’s everyday transactions.

Central banks could be viewed as political agents if their visibility into payment transactions is used for law enforcement or surveillance purposes. [...] Central banks already face threats to their independence, credibility and legitimacy. The more extensive the functionality of the money they issue, the greater the political pressures they will be exposed to. At a minimum, such innovations pose risks to the integrity of central bank money.

Oh, won’t somebody think of the central banksters’ credibility!?

And — wouldn’t ya know it?! — just as Prasad and others are beginning to warn that the banksters might be pushing too far and too fast with

this whole “programmable money” idea, it looks like the monetary mafia are now stepping back from the CBDC brink ... at least publicly.

Just this past week, the Central Bank of Colombia issued a white paper on the “Expected Macroeconomic Effects of Issuing a Retail CBDC,” which admits that if central banks push the cashless agenda too far and the situation “reaches a point where the use of cash is about to disappear, central bank money could lose its role as a monetary anchor for deposits and other forms of private money.” Also this past week, the Bank of Canada issued a report on “Unmet Payment Needs and a Central Bank Digital Currency,” which acknowledges that “consumers face few payment gaps or frictions and therefore might have relatively weak incentives to adopt and — especially — to use

# The Vaccine Hoax is Over

A Freedom of Information Act (FOIA) request filed by a doctor in the UK has revealed 30 years of secret official documents showing that government experts have:

1. Known the vaccines don’t work
2. Known they cause the diseases they are supposed to prevent
3. Known they are a hazard to children
4. Colluded to lie to the public
5. Worked to prevent safety studies

Those are the same vaccines that are mandated to children in the US.

Educated parents can either get their children out of harm’s way or continue living inside one of the largest most evil lies in history, that vaccines — full of heavy metals, viral diseases, mycoplasma, fecal material, DNA fragments from other species, formaldehyde, polysorbate 80 (a sterilizing agent) — are a miracle of modern medicine.

A FOIA request filed in the US with the CDC, by a doctor with an autistic son, seeking information on what the CDC knows about the dangers of vaccines, had, by law, to be responded to in 20 days. Nearly 7 years later, the doctor went to court and the CDC argued it does not have to turn over documents. A judge ordered the CDC to turn over the documents on September 30, 2011.

On October 26, 2011, a *Denver Post* editorial expressed shock that the Obama administration, after promising to be especially transparent, was proposing changes to the Freedom of Information Act that would allow it to go beyond declaring some documents secret and to actually allow government agencies (such as the CDC) to declare some documents “non-existent.”

Simultaneous to this on-going massive CDC cover up involving its primary “health” MANDATE (not recommendation) for American children, the CDC is in deep trouble over its decades of covering up the damaging effects of fluoride affecting the lives of all Americans, especially children and the immune compromised. Lawsuits are being prepared. Children are ingesting 3-4 times more fluoride by body weight as adults and “the sheer number of potentially harmed citizens — persons with dental fluorosis, kidney patients tipped into needing dialysis, diabetics, thyroid patients, etc — numbers in the millions.”

### Dangers of the CDC

The CDC is obviously acting against the health of the American people. But the threat to the lives of the American people posed by the CDC’s behavior does not stop there. It participated in designing pandemic laws that are on the books in every state in the US, which arrange for the government to use the military to force unknown, untested, vaccines, drugs, chemicals, and “medical” treatments on the entire country if it declares a pandemic emergency.

The CDC’s credibility in declaring such a pandemic emergency is non-existent, again based on the Freedom of Information Act. In 2009, after the CDC had declared the H1N1 “pandemic,” the CDC refused to respond to a Freedom of Information Act request filed by *CBS News* and the CDC also attempted to block their investigation. What the CDC was hiding was its part in one of the largest medical scandals in

history, putting out wildly exaggerated data on what it claimed were H1N1 cases, and by doing so, created the false impression of a “pandemic” in the US.

The CDC was also covering up a financial scandal to rival the bailout since the vaccines for the false pandemic cost the US billions. And worse, the CDC put pregnant women first in line for an untested vaccine with a sterilizing agent, polysorbate 80, in it. Thanks to the CDC, “the number of vaccine-related “fetal demise” reports increased by 2,440% in 2009 compared to previous years, which is even more shocking than the miscarriage statistic [700% increase].

### Historical Hoax

The exposure of the vaccine hoax is running neck



and neck with the much older hoax of a deadly 1918-19 flu. It was aspirin that killed people in 1918-19, not a pandemic flu. It was the greatest industrial catastrophe in human history with 20-50 million people dying, but it was blamed on a flu. The beginning of the drug industry began with that success, and Monsanto was part of it. The flu myth was used by George Bush to threaten the world with “another pandemic flu that could kill millions” — a terror tactic used to get pandemic laws on the books in every state and worldwide. Then the CDC used the pandemic hoax to create terror over H1N1 and to push deadly vaccines on the public, killing thousands of unborn children and others. The CDC will not release the data and continues to push the same vaccine.

The hoax of the vaccine schedule is over, exposed by FOIAs in the UK.

The hoax of the CDC’s interest in children’s lives has been exposed by its refusal to respond to a doctor’s

FOIA’s around its knowledge of vaccine dangers.

The 1918-19 pandemic hoax has been exposed by Dr. Karen Starko’s work on aspirin’s role in killing people.

And despite refusing to respond to FOIA’s, the CDC’s scandalous hoax of a 2009 flu pandemic and its part in creating it, was exposed by *CBS NEWS*.

And, the Obama administration, in attempting to salvage the last vestige of secrecy around what is really happening with vaccines by declaring agency documents non-existent, has made its claim of transparency, non-existent.

But, pandemic laws arranging for unknown vaccines to be forced on the entire country are still in place with HHS creating a vaccine mixture that should never be used on anyone and with all liability for vaccine injuries having been removed. Meanwhile, a Canadian study has just proven that the flu vaccine containing the H1N1 vaccine which kills babies in utero, actually increases the risk of serious pandemic flu.

# The Coming Collapse of the Global Ponzi Scheme

**It won't be long before governments around the world, including the one in Washington, self-destruct. Strong words, but anything less would be naïve.**

As economist Herbert Stein once said, “If something cannot go on forever, it has a tendency to stop.” Case in point: fiat money political regimes. Interventionist economies of the West are in a fatal downward spiral, comparable to that of the Roman Empire in the second century, burdened with unsustainable debt and the anti prosperity policies of governments, especially the Green New Deal.

In the global Ponzi scheme, thin air and deceit substitute for sound money. As hedge-fund manager Mitch Feierstein wrote in Planet Ponzi, “You don’t solve a Ponzi scheme; you end it.” Charles Ponzi and Bernie Madoff made some of their investors a whole lot poorer, but the world didn’t come crashing down as a result. For that — for a Ponzi scheme that would threaten to bankrupt capitalism across the entire Western world — you need people much smarter than Ponzi or Madoff. You need time, you need energy, you need motivation. In a word, you need Wall Street.

But Wall Street alone doesn’t have the strength to deliver a truly cataclysmic outcome. If your ambition is to create havoc on the largest possible scale, you need access to a balance sheet running into the tens of trillions. You need power. You need prestige. You need a remarkable willingness to deceive. In a word, you need Washington.

As Gary North wrote in a brief review of Feierstein’s book, “The central banks have colluded with the national governments in order to fund huge increases of national debt, beyond what can ever be paid off. In other words, [Feierstein] has described government promises as part of a gigantic international Ponzi scheme.”

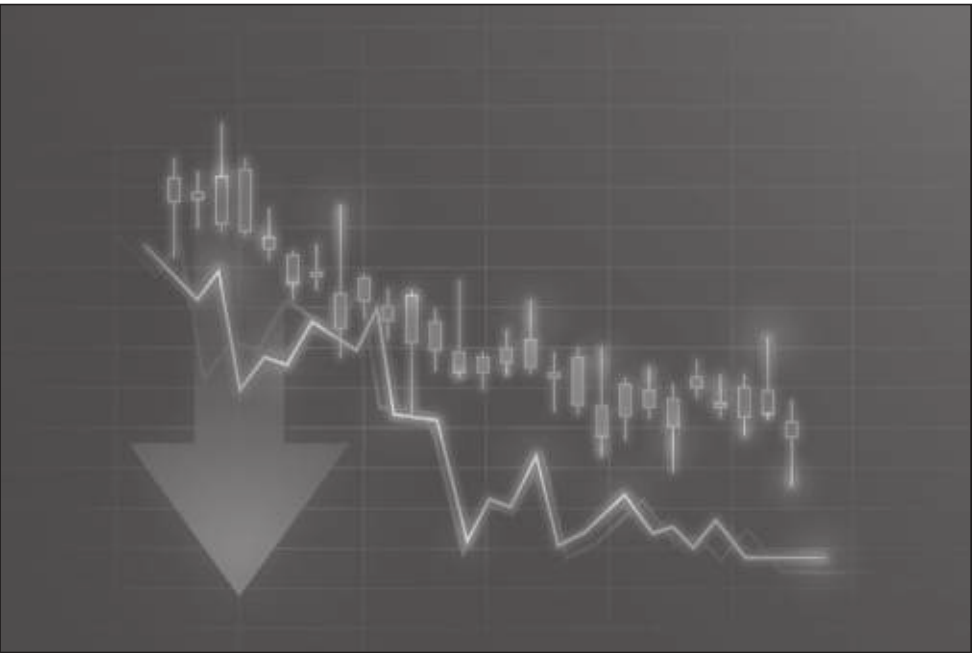
In a recent interview, Peter Schiff, who was laughed at when he predicted the economic meltdown of 2007–9, said interest on the federal debt alone “will be about a trillion by the end of this year. By the end of next year [it will reach] two trillion dollars — and that’s if interest rates don’t go up. . . . This is a huge debt bomb that’s going to explode.”

Ultra-high corporate and credit card debt, along with bank insolvency sustains his argument for a coming collapse, the polar opposite of Biden’s economic dream. Along with this, Reuters notes that the spread between two- and ten-year Treasurys is at the deepest inversion

since 1981. Rarely has an inverted yield curve not signaled a recession.

Can Jerome Powell and his advisors steer the economy into a soft landing? Not this time. “The only landing possible is a crash, where everyone on board dies,” Schiff recently tweeted.

Ponzi and Madoff went to jail for their schemes, but how do you prosecute governments for theirs? Prosecution implies being a part of the government. And with rare exceptions such as Ron Paul, those who go into government believe gold is a barbarous relic and the Fed is a good thing that just needs a little government tinkering. So, the guilty will go unpunished, unless public outrage misguidedly turns to nonjudicial violence. The rest will be too busy trying to survive and protect those they



care about.

### The War on Being Human

A study of history, including US monetary history, makes clear that the state is not in the business of securing our liberty. As the previous nine hundred plus days have made clear, any defense of “liberty” would likely be regarded as hate speech. Instead, we are inundated with the feel-good words of diversity, equity, and inclusion along with the fear-driven campaigns of climate change and killer covid. Challenge any of it and you’re demonized — or worse.

But the state can’t do anything significant without monopolizing money, and the Orwellian central bank digital currencies (CBDCs) will be the latest installment to control the monetary system. The new FedNow payment system with its emphasis on user convenience is providing the framework and psychological grooming

for CBDCs.

### The Shadow Superpower

We can stop this from happening. Two states, Florida and Indiana, have effectively banned CBDCs as money in those states. Other states will likely follow. The government will outlaw cash at some point, but those who use it now are casting a vote against CBDCs.

Many people will turn to barter, some using barter metals, and to the shadow economy. If this sounds desperate, consider how the global black market in 2011 was the world’s fastest-growing economy. Sometimes referred to as System D, it features both the usual, small transactions of flea market trades or workers looking for employment in the parking lots of home improvement stores and also larger, international trades. David Obi, a Nigerian, relying on his cell phone and his own initiative, contacted a Chinese firm to have small diesel-powered generators shipped to his home country, where electric power is often scarce: “Like almost all the transactions between Nigerian traders and Chinese manufacturers, it was also sub rosa: under the radar, outside of the view or control of government, part of the unheralded alternative economic universe of System D.”

Friedrich Schneider, research fellow at Johannes Kepler University Linz, Austria, whose expertise is in off-government economies and who co authored The Shadow Economy, found that System D is growing faster in many countries than the officially recognized gross domestic product. If System D were an independent nation, it would be the second-largest economy in the world.

### Conclusion

The future is undecided, but we can help determine the outcome if we take responsibility for it. Wikipedia defines System D as “a manner of responding to challenges that require one to have the ability to think quickly, to adapt, and to improvise when getting a job done.” In this sense success has always depended on System D, with or without government.

The American term for it is life hack, “any trick, shortcut, skill, or novelty method that increases productivity and efficiency, in all walks of life.” Whatever you call it, it describes a spirit all of humanity needs to adopt if we are to survive the coming collapse of government Ponzi schemes.

# The Common Ground of Covid: My Journey with the NCI

“Would you consider being the spokesperson for the NCI?”

When **National Citizens Inquiry** lead council, Shawn Buckley, asked me the question in our first phone conversation together, I was gobsmacked. Would I consider volunteering as the voice of a national organization dedicated to finding, recording, and presenting truthful evidence about Covid mandates and their impact on Canadians?

There was no other answer for me but yes.

In a matter of days, I'd arranged my life to travel across the country for 2 months. It was, as it turns out, just the beginning of a growing and historical movement to out the truth and unite the country. And it took more than any of us had bargained for.

### Physically, it was punishing.

We sat in windowless hotel rooms, hearing horrifying and heartbreaking testimony for 9-12 hours a day, listening to over 300 people during 24 hearing days in 8 different cities from coast to coast. On the “breaks” I interviewed witnesses and at the end of the hearing days I recorded “sit-down” summary videos of the day’s testimony that couldn’t possibly do justice to each and every witness. I’d then rush out for a late dinner and head back to the hotel to review stories from the day before, answer any urgent texts, calls, and emails, and get into bed by midnight, only to be up at 7am to start all over again.

On non-hearing days, I wrote stories, gave interviews, and travelled to the next city. There was no time for reflection or introspection, no walking or exercise, no daylight, no downtime.

### Mentally, it was taxing.

I understand why people would rather watch TV. It takes nothing. In fact, it dulls our senses and lulls us into a kind of self-numbing trance that allows us, for a short while, to forget the real tragedy and horror happening in the real world.

Comprehending complex scientific evidence necessitates full attention and alertness. Listening to legal issues and economic assessments can be challenging. And there is only so much information one can absorb hour after hour, day after day. But the commitment to honour each witness’s contribution overrode any desire to step out or miss just one witness.

### Emotionally, it was draining.

When I took on this role, what encouraged me most was not the lineup of superstar scientists, valiant doctors, and other expert witnesses. What gave me hope about the Inquiry was the prospect of ordinary Canadians hearing the stories, the real lived experiences, of fellow Canadians. It would be difficult, but this, I believed, would connect us once again with the kindness and compassion we are known for. Because we had lost our way during Covid.

What I witnessed was a degradation of natural human response to the suffering of others that could only have been usurped by the implementation of the greatest psychological assault we’ve ever experienced.

In the darkest days of Covid, we not only allowed but encouraged the medical segregation and shaming of our own families, as well as the loss of livelihood of friends and colleagues, and, most shockingly, the harm to our children through the traumatic sacrifice of their freedoms for the supposed protection of the health of their elders. An obscene reversal of roles from which they will spend a lifetime recovering. Some never will. Some never did, as self harm and suicide went way up.

We have yet to feel the societal impact of thousands

of kids who permanently dropped out of school. We have no idea what a generation of children subjected to psychological warfare will have on the future of this country or any country. We cannot begin to know the physical impact of an experimental medical intervention that is already causing sudden death in the young.

And then there are the injection injuries. Those who experienced the most physical harm were the people who were coerced, pressured, or just trusted the government’s assurance of a “safe” and “effective” “vaccine.” And as Dr. Mark Trozzi testified, all three words turned out to be a lie.

It was the testimony of the “vaccine” injured that was among the hardest to hear. Those of us listening to a daily litany of tragic outcomes of political decisions that ruined lives took solace in each other. We hugged and cried. With the witnesses and with each other.

### Psychologically, it was traumatizing.

Hearing this direct experience of physical, emotional, mental, and financial hardship took something more than just listening. It required a willingness to experience a full range of human emotions. But this was the real gift of the NCI.

In the clouds of despair, there lay a silver lining — the mechanism by which we could reestablish our reputation for kindness and compassion. Bearing witness. As we heard these unimaginable stories, the false division of vaxxed versus unvaxxed began healing. The testimony of those who took the shot served to disintegrate the “us versus them” narrative that the government tried so hard to push.

We have all been misled. We have all been victimized by a government-sanctioned, government-promoted, culture of fear and blame. But no more. We have each other and we have each other’s stories. And it is these stories which must continue to be heard.

Watching and sharing the testimony of the witnesses of the National Citizens Inquiry is a means to awaken those who suspect that something is rotten in the state of Denmark, but don’t yet know what is happening or how to stop it. This is why we were inspired to start the #ThisIsCanada campaign, encouraging people to put flyers into mailboxes asking others to watch and share. Because we know, I know from personal experience,

that you cannot watch a day of NCI testimony without being changed.

### Spiritually, it was the most challenging and rewarding thing I’ve ever done.

The National Citizens Inquiry was, and is, a part of history that has the potential to make us who we were born to be. To encourage, embolden, and empower us to be our greatest selves, and to take responsibility for what we allowed to happen here. It was, and is, an olive branch between cleaved communities and colleagues, fractured friends and families. It was, and is, an opportunity to begin a new conversation with a clean slate.

We can honour the courageous men and women who testified by ensuring their stories are seen, and never forgetting that this was allowed to happen in Canada. As word spread of this unprecedented event, a Canadian family was created. A vast network of volunteers, most of whom don’t even know each other but share a commitment to truth, justice, personal responsibility, and accountability.

While the NCI’s stated purpose was, “to listen, to learn, and to recommend,” it has become about so much more. It is the mechanism by which we can awaken the power of each of us to create the country, the society, the world in which we want to live. It has become a new muscle to exercise our democracy.

The Commissioners report will be released this fall, making many recommendations based on the evidence heard. But it is up to each of us, the citizens of Canada, to ensure that something is done with it. We must be willing to face the truth and to be the change. To rekindle our kindness and compassion, to admit our mistakes, and then to stand together to hold those responsible to account. Because that is who we are.

And this is why I feel proud and privileged to be a part of the National Citizens Inquiry.

In the words of Shawn Buckley during his closing statements in Ottawa, “Canadians don’t cower.” It’s time for all of us to stand on common ground. Because history is calling and THIS is Canada.

CBDC at scale.”

In other words, central bankers are quietly admitting there are no real advantages to retail CBDC’s and there are even potential downsides to their introduction.

Of course, as my astute readers will already know, this does not mean that the issue is settled, that the bankers have given up, and that the CBDC dream is officially done. No, it just means that they have to change tack and try to find other ways to cajole the public into the digital gulag. Perhaps this is why the central banking minions are now openly strategizing about how best to sell their digital money agenda to an unwilling public.

Take the Bank of Israel, for example. It just released a new white paper purporting to identify “Principles for creating ‘Acceptance’ and ‘Network Effect’ for the Digital Shekel,” or, in plain English: “Ways to convince the rubes to use our virtual slave coins.” The document considers ideas for leveraging the “Network Effect” to artificially stimulate adoption of the digital shekel. Naturally, the plan does not focus on ways to incentivize the use of CBDC’s but rather on ways to enforce their acceptance, including obligating banks, payment providers and merchants to participate in the scheme or forcing the government to officially declare the digital shekel to be legal tender.

On its face, the fact that the banksters are now openly plotting how best to stuff digital money down the public’s throat may be a worrying development.

But, upon further reflection, the fact that the banksters are now turning from the carrots of incentives and bonuses and discounts to the stick of government regulation and enforced adoption does not mean that the anti-CBDC movement is doomed to failure.

On the contrary. That the banksters are now actively engaged in a struggle against the general public is a sign that we are winning and that CBDC’s are not inevitable.

### Resistance is Fertile

I’ve made the point before, but it bears repeating: the constant stream of propaganda, conditioning and censorship that we are subjected to from governments, establishment institutions and their lapdog media is not a sign of their strength. It is a sign of their weakness.

The fact that they have to spend billions of dollars a year pumping lies and misinformation into the heads of the citizenry in order to keep people from seeing the truth is a tacit admission that our thoughts and opinions actually do matter. After all, why would they bother propagandizing to us at all if they didn’t require our approval (or at least our docile apathy) to continue pursuing their agenda?

Similarly, the fact that the banksters are ramping up the next stage of their CBDC indoctrination operation — attempting to convince an increasingly skeptical public that a complete overhaul of the fabric of our monetary reality is somehow beneficial to Joe Sixpack and Jane Soccermom — is a tacit admission that we are the ones who decide whether CBDC’s are implemented or not. They can tout the benefits of their digital slave tokens all they want, but if we refuse to use them, then the CBDC world order will not come to fruition.

The banksters, for one, are well aware of this fact. But are we aware of it?

I understand why this message — that pushback and protest do matter and that the globalist agenda is not inevitable — is such an unpopular one in the “alternative” media. If the message is simply: “Relax,

everyone! The battle is over and CBDC’s have been defeated! Now go back to sleep!” then it is indeed no different from enemy propaganda.

But that is not the message here. Instead, the message is that the public is — for the time being and until the propaganda machine kicks into high gear — overwhelmingly on our side. People DO NOT WANT programmable money and the vast majority see it for what it is: another trick on the part of the establishment to take more power and control away from every day people and put it in the hands of the banksters and their cronies.

That’s why this is the time to seize the momentum of public opinion and steer it into actual productive activity. We can encourage Cash Friday awareness. We can build up local trading communities based on alternative and complementary currencies. We can introduce those around us to Agorist.Market (<https://agorist.market/>). We can promote community currencies and precious metals and decentralized cryptos and barter circles and the million other forms of survival currency that clued-in Corbetteers have been researching for years.

The time has come to harvest those seeds you’ve been planting! The public is on our side!

Yes, your resistance and pushback do matter. It does make a difference. We do have a part to play in this. Now, let’s go out there and put the final nail in the CBDC coffin.

# Globally, There Have Been Fewer Fires This Year

Yes, you read that right! Many countries around the world, including the US, are experiencing one of the least destructive years caused by forest fires in the last decade. Despite this fact, the corporate media continues to blame climate change for nearly every fire (without explaining how climate change only affects Canada and Hawaii, but not other places). Official data from the European Commission indicates that, despite Canada having an anomalous year, many countries are quite in line with previous years — or even having fewer fires and fewer amounts of area burned than normal. Environmental researchers have been speaking out about this, including Bjørn Lomborg, Danish academic and environmental economist, who recently published

on twitter “Contrary to what you constantly hear in the media, global fire in 2023 has so far burned less than normal. Have you seen that reported anywhere? Yes, the [North] Americas [particularly Canada] burned much more, but surely the media should also tell you that Africa and Europe burned much less?”

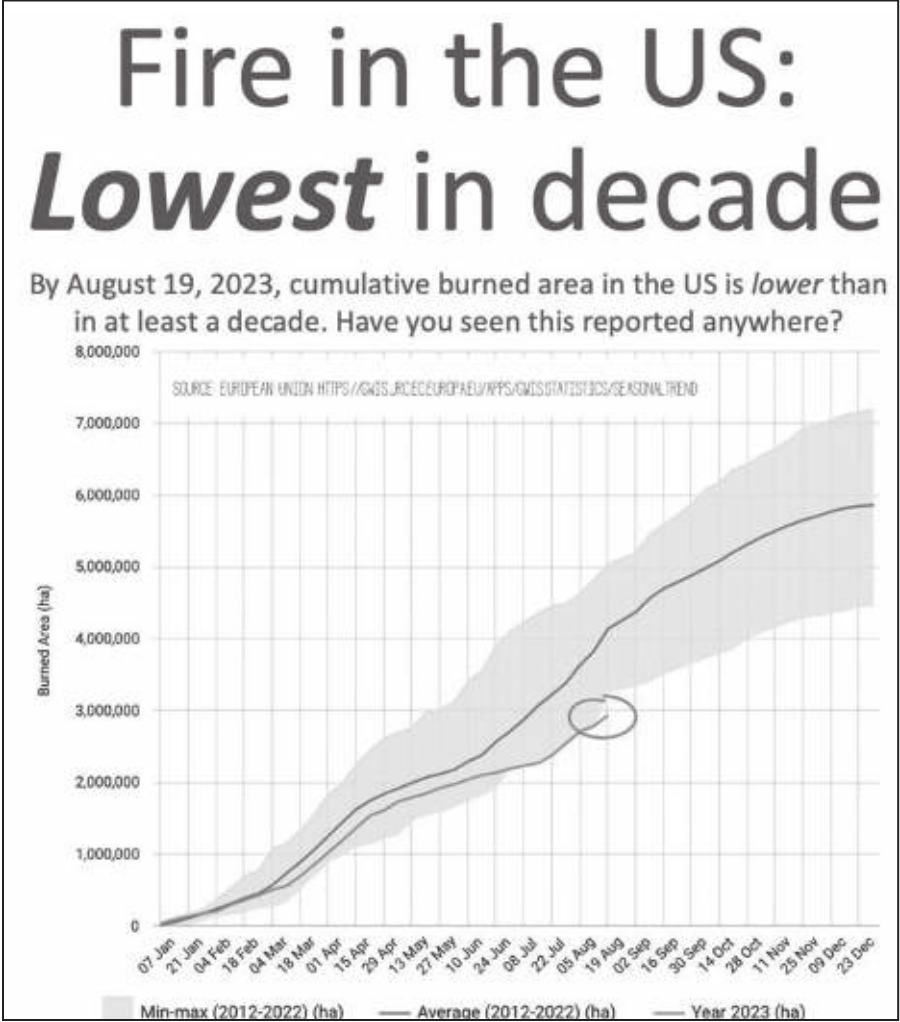
According to official data by the European Commission’s Global Wildfire Information System, the US, Europe, Asia, Africa, and South America are experiencing lows in the number of forest fires and the amount of area burned, when compared to the past ten years. As Lomborg put it, “Climate alarmists highlight all the places that burn and ignore the ever more places that don’t.”

What Lomborg said rings true here in Canada, where politicians are regularly pointing to the devastating number of forest fires in Canada this year and claiming that they are the result of climate change — despite the fact that the annual number of wildfires in Canada over the past 40+ years appears to be relatively stable, if not slightly decreasing. In fact, 2020 had the fewest amount of forest fires in Canada’s 41-year history of tracking them — and this includes the fewest amount of hectares burned.

Of course, there were no climate change activists celebrating the lack of wildfires in 2020. That record was ignored by the corporate media. However, this year, with the surge in wildfires aligning with the climate change narrative, both the media and politicians are giving it extensive coverage. In August, Alberta Premier Danielle Smith was practically begged to blame climate change on the record-breaking number of forest fires in Alberta — but she refused, noting that most of them were caused by humans. A few individuals in Alberta have been charged by the RCMP in connection to forest fires, though the vast majority of the human-started forest fires appear to be accidental. In June, BC’s

Coastal Fire Centre indicated that every forest fire on Vancouver Island this year — all 46 of them — were started by humans.

It is true that 2023 set a new Canadian record (so far) for forest fires in terms of land area affected since records began in 1980. According to the Canadian Interagency Forest Fire Centre, a staggering 13.2 million hectares have already been consumed by flames this year. Yet, when we take a step back and look at the global data spanning the last few decades, there’s no proof linking fires to climate change. While this year’s surge in Canadian forest fires is undeniably alarming, attributing it solely to climate change gives undue credence to the climate change agenda, thereby indirectly supporting politicians who advocate for authoritative measures.

## Some Of The Most Absurd Things That Have Happened In Recent Weeks

- Sheila Lewis, a terminally-ill woman in Alberta who had been denied a place on an organ transplant list because she was not vaccinated against COVID-19, has passed away. This marks the second publicly reported death of a patient who had been denied an organ transplant due to their COVID-19 vaccination status.
- Two months after the federal government revealed plans to make questioning the narrative of unmarked mass graves near residential schools illegal by categorizing these thoughts as “hate speech,” a four-week excavation at a former Manitoba residential school “mass grave” finds only underground rocks. To this day, no human remains have been found at any of the “mass graves” near former residential schools in Canada.
- “Contrary to what you constantly hear in the media, global(ly,) fire in 2023 has so far burned less than normal.” Danish academic and environmental economist Bjørn Lomborg published online with supported data. While the Canadian Government has claimed climate change is the reason for Canada’s forest fires, Europe, Asia, Africa, South America, and the US have had the lowest forest fire burn per acre in over 10 years (data can be viewed at [tinyurl.com/5n88t6cs](https://tinyurl.com/5n88t6cs)).
- Blackstone acquires *Ancestry.com* for \$4.7 billion, giving the world’s largest private equity firm total ownership of all DNA from every person who’s ever used the service.
- Study finds that paper straws, which are being pushed as an eco-friendly alternative to plastic versions, contain “forever chemicals” that are both harmful to humans and possibly even more harmful to the environment than their much-vilified plastic counterparts. The study, published in the journal *Food Additives & Contaminants*, noted that the poly and perfluoroalkyl substances (PFAS) found in paper straws can remain in the environment for thousands of years. The chemicals dissolve in water, meaning they could leach into beverages, and have been associated with health issues including liver damage, birth defects, and cancer.
- FatCon, the first conference to celebrate overweight people, is set to be hosted in Philadelphia this October and will be featuring Sonalee Rashatwar, a “non-binary therapist” who claims that “Fatphobia” has “white supremacist origins.”
- A Brazilian mother has been fined and threatened with losing custody of her son for homeschooling him. Regiane Cichelero decided to educate her 12-year-old son at home to teach him better values, despite homeschooling being illegal.
- Kimberly Neudorf, a stay-at-home mom, has been fined \$37K for organizing two anti-restrictions protests in Aylmer, Ontario back in 2020. One rally drew in over a hundred, and the other, over a thousand, at a time when only groups of 25 were allowed to be outside. Around the time of Kimberly’s rallies, there was a Black Lives Matter march in the area where no one got ticketed.

- Aylmer Ontario’s Church of God Pastor, Henry Hildebrandt, pleaded guilty to violating COVID-19 rules and was fined \$65,000. During police surveillance, it was claimed that in June 2021, almost 200 individuals congregated at the church during an outside service, with no adherence to social distancing or mask-wearing.
- In a fresh blow to free speech, American satirist and playwright C.J. Hopkins has been handed a punishment order: jail for 60 days or a €3600 fine. His crime? Using an almost invisible image of a swastika on a mask on the front cover of his book, “The Rise to the

- New Normal Reich,” which is a critique of Germany’s authoritarian, Nazi-like response to COVID.
- Pharmaceutical company Novo Nordisk faces allegations of both causing and concealing a surge in suicidal incidents among users of their new, popular weight loss drug Ozempic. While there’s a well-documented link between monoamine neurotransmitters (the class of drugs to which Ozempic belongs) and suicidal tendencies, Novo Nordisk’s studies failed to track suicidal thoughts. Furthermore, they excluded participants with a history of mental disorders and those showing behaviour associated with suicidal ideations. As of now, Ozempic packaging lacks a warning about potential suicidal thoughts.
  - Biden pledged \$700 per household for victims of the Maui fires, and, in the next breath, he asked Congress for an additional \$20B for Ukraine. Prior to Biden’s additional \$20B request, The Heritage Foundation found that the United States’ \$113B in aid to Ukraine has cost Americans \$900 per household.
  - The alarming trend of debanking customers who think differently continues: Dr. Joseph Mercola, prominent vaccine freedom advocate and founder of natural health website [Mercola.com](http://Mercola.com), announced that, after

- 18 years with Chase Bank, they suddenly and unexpectedly shut down his business account, as well as the accounts of his employees. Also in America, Indigenous Advance Ministries, a Memphis-based Christian charity, claims it has been unjustly debanked by banking giant *Bank of America* due to its religious ideologies, which includes advocating for pro-life and traditional marriage.
- Taco Bell, Pizza Hut, and KFC announce their plans to go completely cashless. The fast-food chain’s parent company, *Yum Brands* plan is for transactions to be 100% digital in the future to aid in order automation and AI integration (with the unmentioned added benefit of increased consumer tracking).
  - The death toll in 2023 is nearing pandemic levels, with UK government data suggesting that the number of extra fatalities this year is on path to surpass that of 2020 (source: <https://tinyurl.com/2vucnjee>). According to experts, “of particular concern is the 15 to 44 age group, where cumulative deaths are tracking above all recent years, including 2020.” Additionally, disability is also rising in the working age. The UK’s Office of National Statistics disability data shows that, over the last three years, the percent of the UK population who were approved for PIP disability payments rose from 0.74% to 1.27%.
  - The EU’s Digital Services Act is now in effect, which means online platforms in the EU are now legally required to implement mechanisms for preempting and eliminating posts containing “hate speech” and “disinformation.”
  - Dr. Paul Offit, leading vaccine advocate, vaccine developer, and member of the FDA’s Vaccine Advisory Committee has finally admitted that “there certainly is a causal link between [COVID-19] vaccine and myocarditis. No doubt about it.” Offit noted that antibodies in the bloodstream seem to be attacking the heart and, as noted in various studies, “fully vaccinated individuals demonstrated an average of 50-fold higher antibody levels than naturally infected unvaccinated individuals” in the blood (Meyers et al.). Naturally acquired immunity, on the other hand, results in more mucosal antibodies, which is also why natural immunity results in less transmission compared to vaccine “immunity.” According to the Cleveland Clinic website, “almost 20% of sudden deaths in young people have a connection to myocarditis” and the 5-year survival rate is only 50%.
  - The American Board of Internal Medicine’s Credentials and Certification Committee has put forth that Dr. Paul Marik, one of the most published doctors in the field of critical care medicine (who also wrote the Critical Care Medicine textbook used in medical school) and his colleague, Dr. Pierre Kory, be stripped of their credentials for allegedly disseminating, what the committee deems to be, flawed or inaccurate medical information online. Dr. Marik and Dr. Kory, who both worked in critical care units during the pandemic, have been raising awareness about using ivermectin as a treatment for COVID-19 since 2020.
  - A judge has rejected Robert F. Kennedy Jr.’s request for a temporary restraining order against YouTube for censoring his presidential campaign due to his “anti-vaccine” beliefs.
